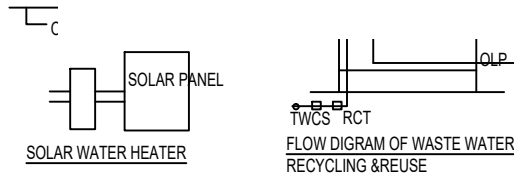


SITE PLAN

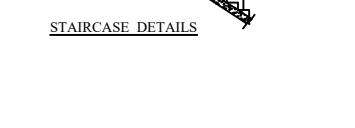

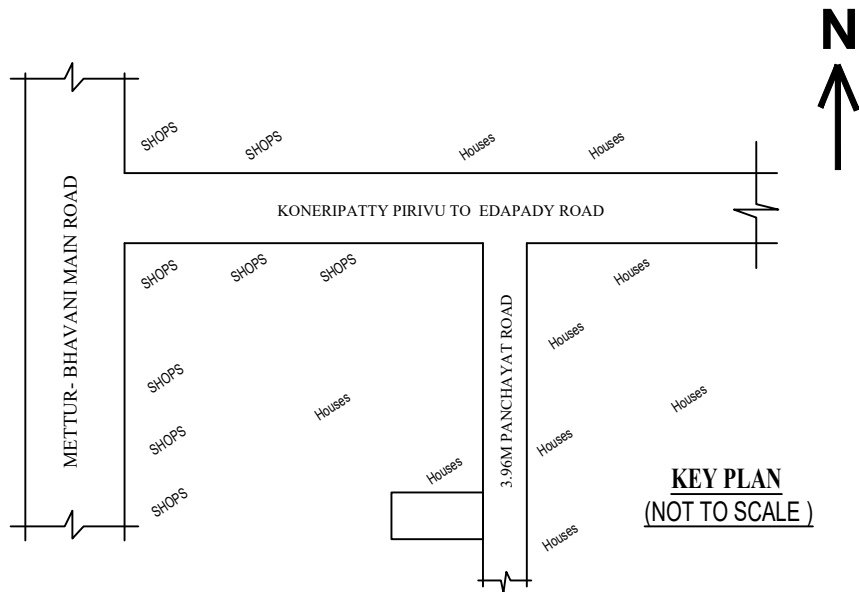
TERRACE FLOOR PLAN

SEPTIC TANK & SOAK PIT DETAILS



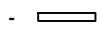
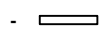
KEY PLAN
