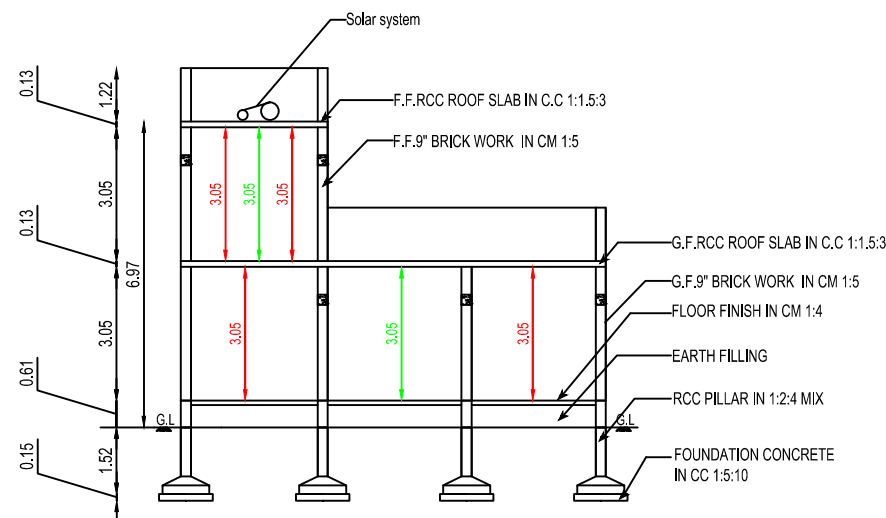

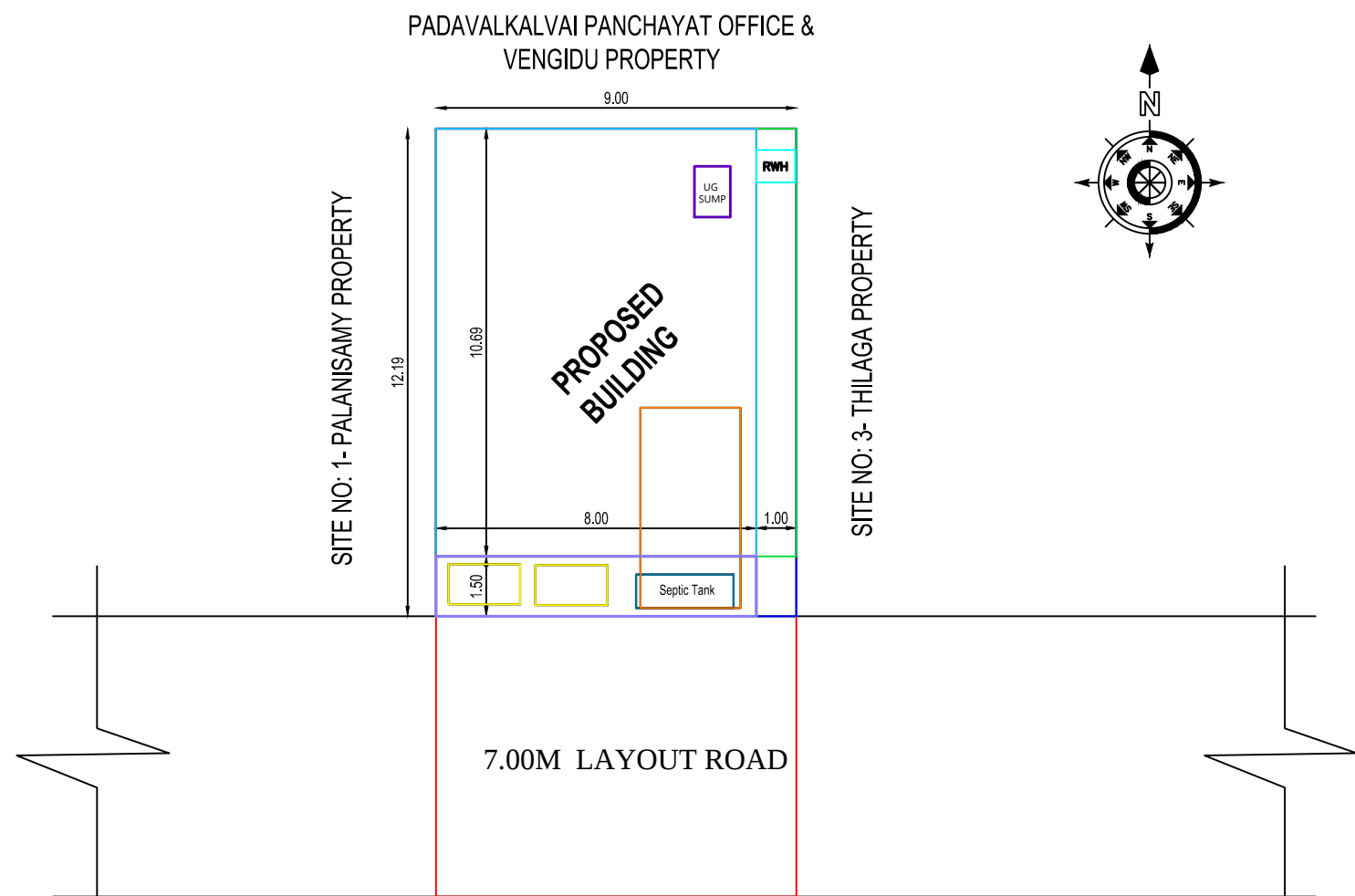

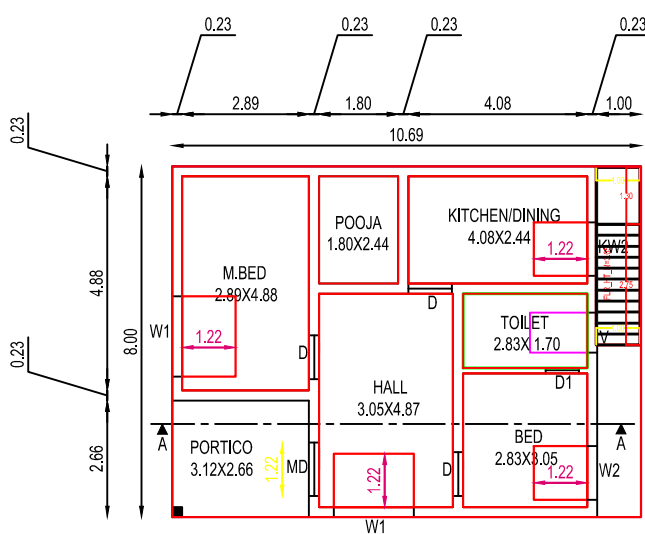

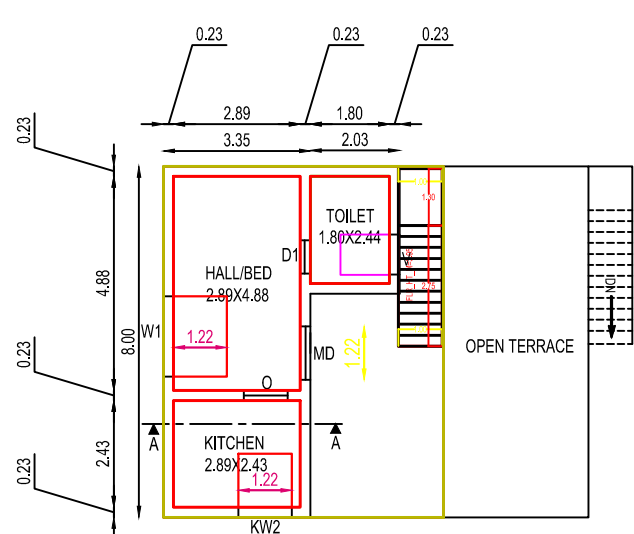


SITE PLAN
(Scale : 1:100)

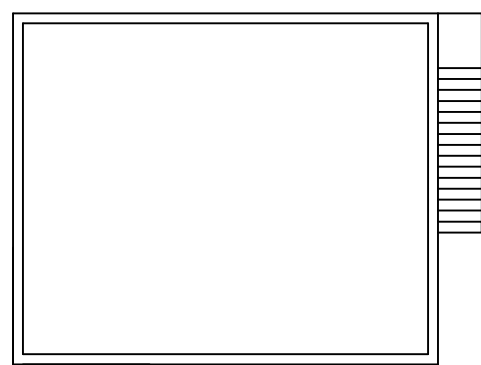

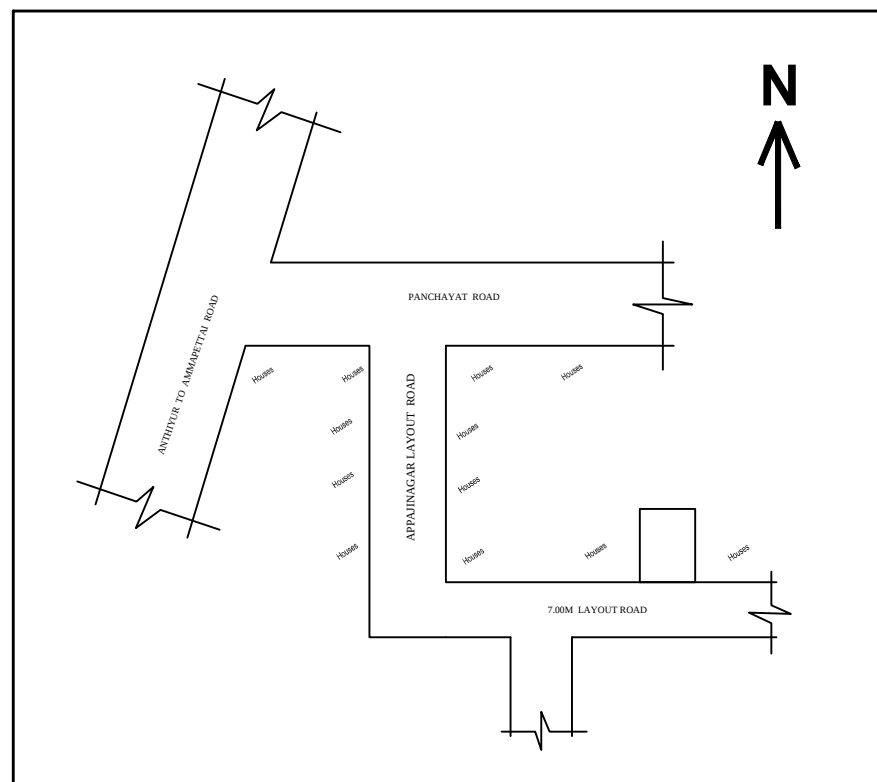
GROUND FLOOR PLAN
