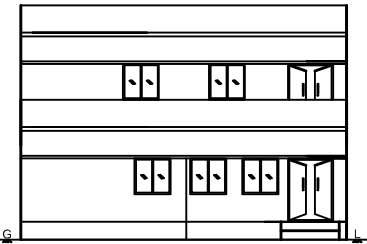

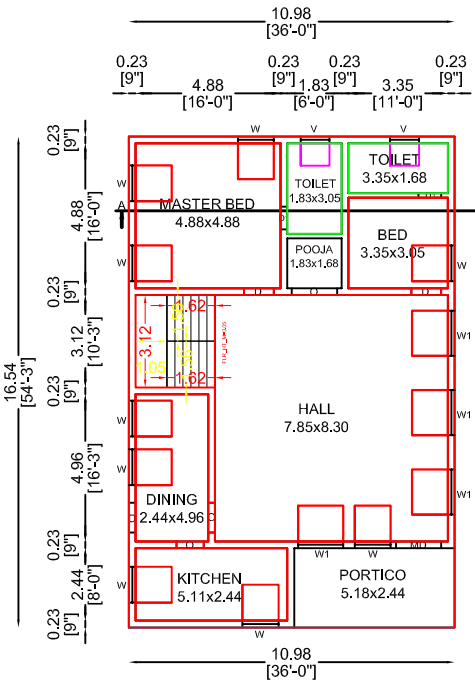
PLAN SHOWING THE PROPOSED CONSTRUCTION OF R.C.C ROOF GROUND FLOOR AND FIRST FLOOR

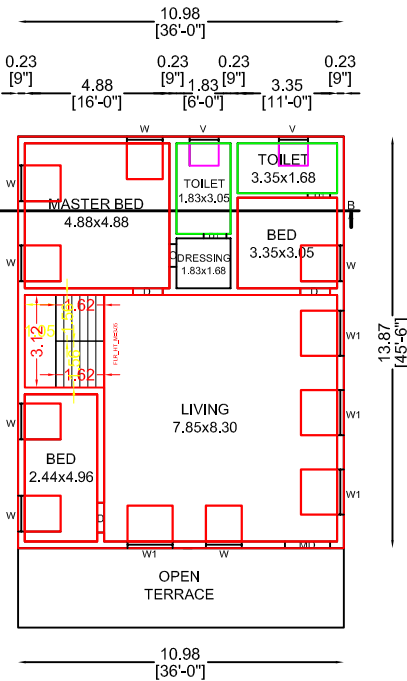

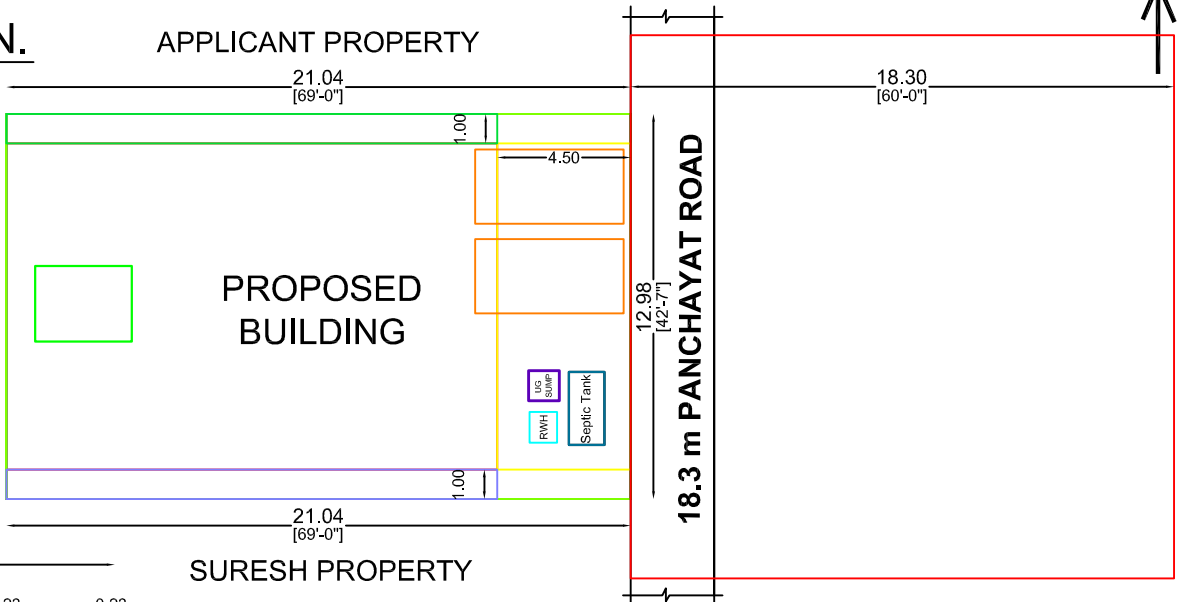


GROUND FLOOR PLAN



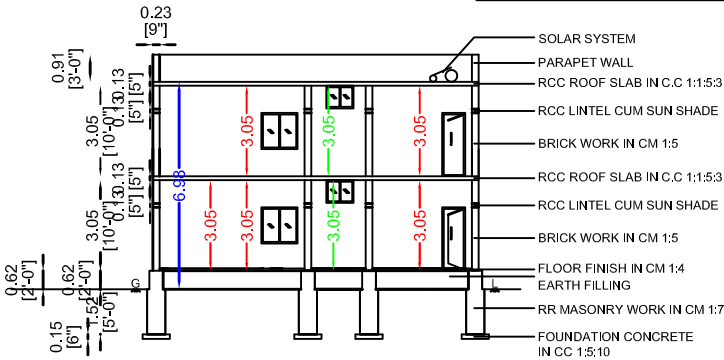
FIRST FLOOR PLAN

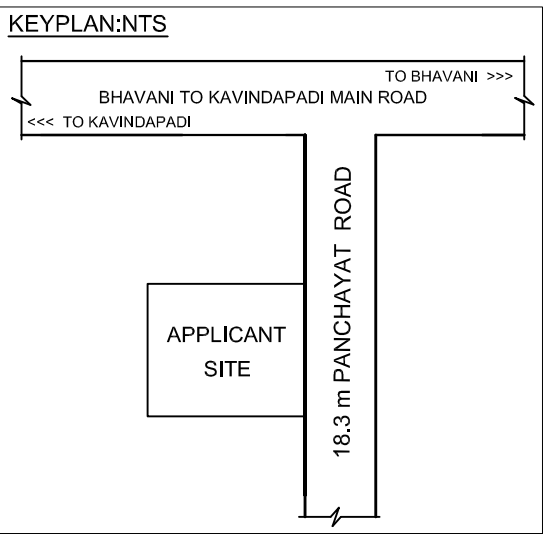

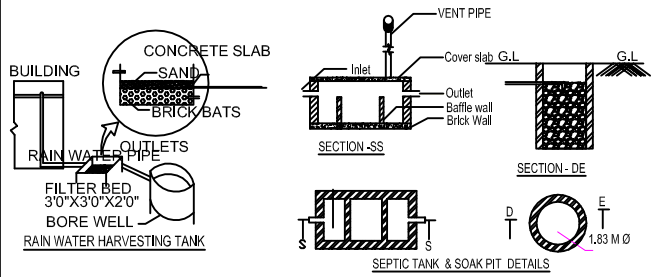
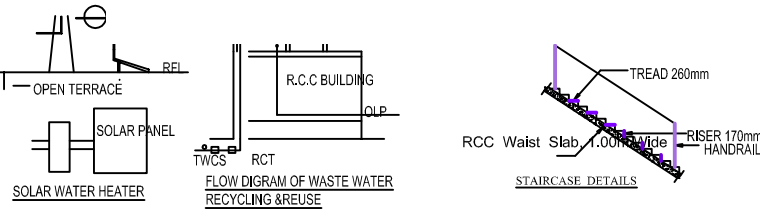
SITE PLAN (Scale : 1:100)
