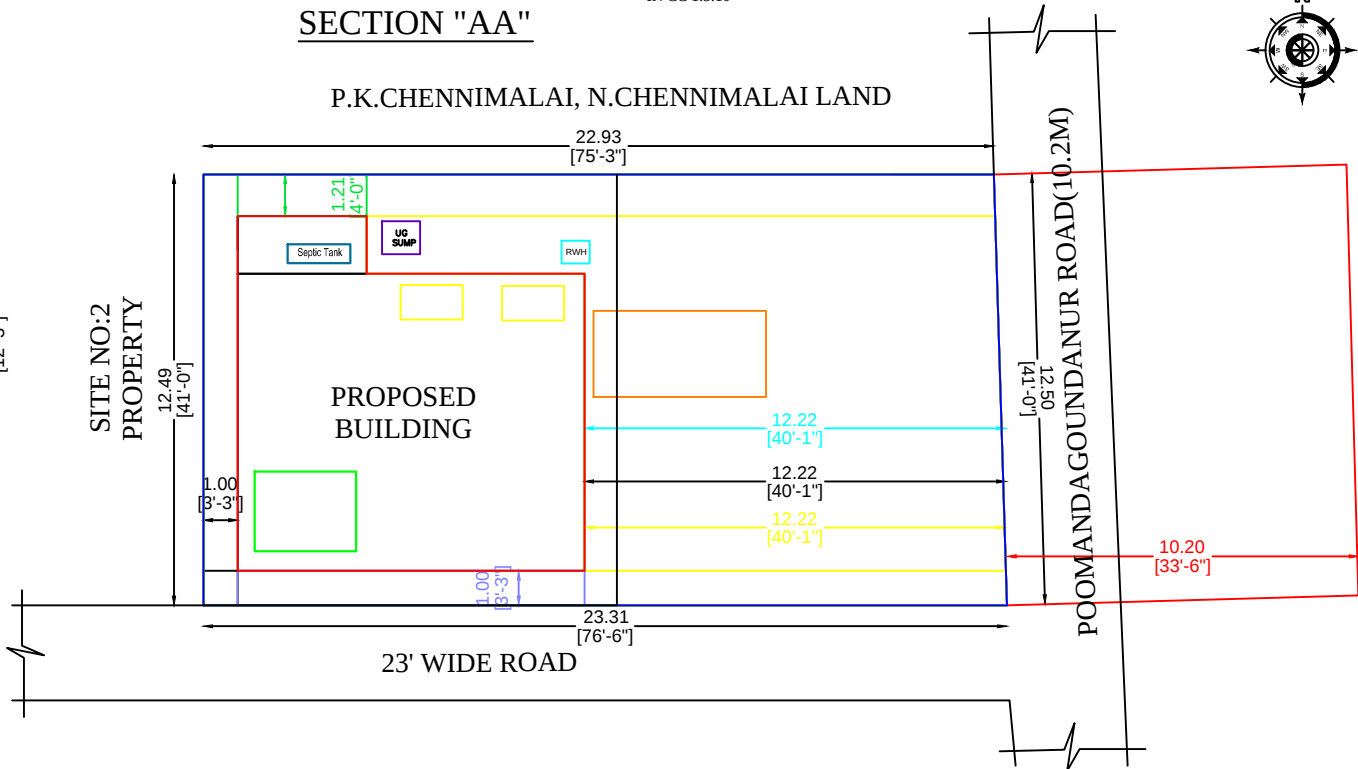

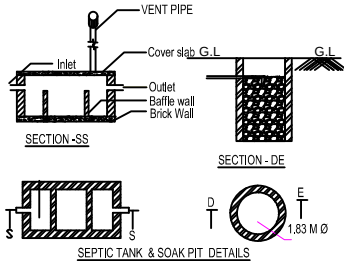
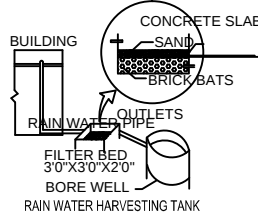
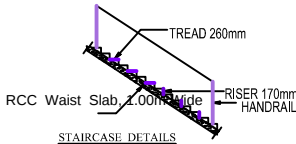
SITE PLAN ( Scale : 1:200)
