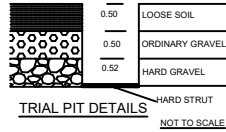
FLOOR PLAN



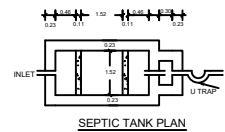
RAINWATER HARVESTING PLAN



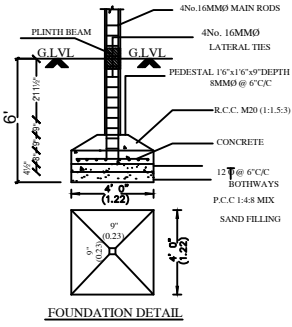
