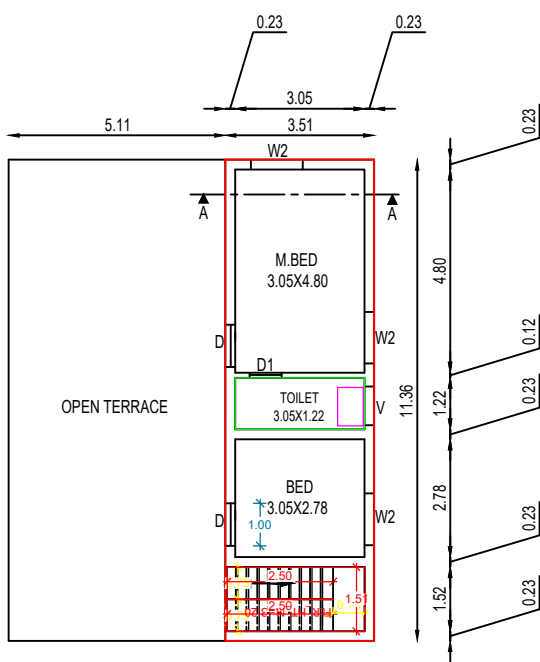

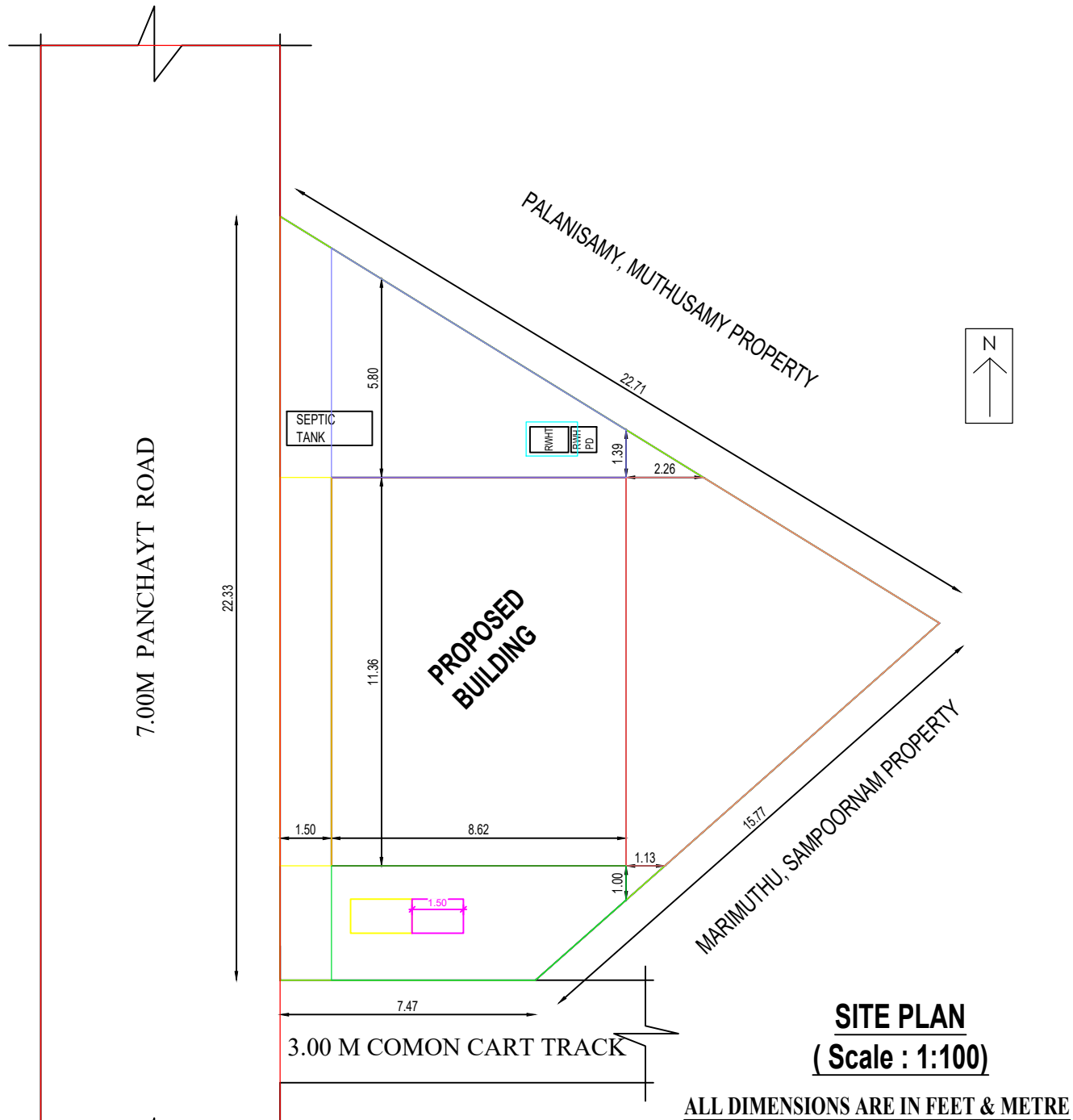

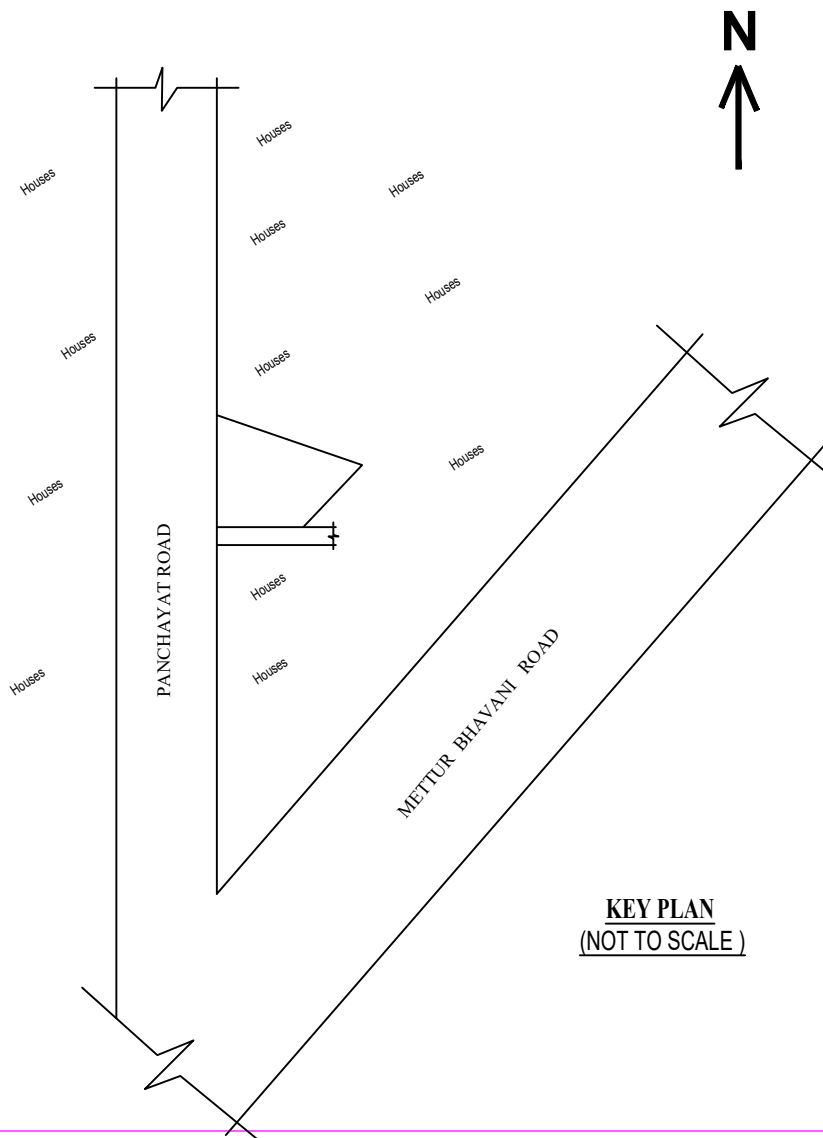
FIRST FLOOR PLAN

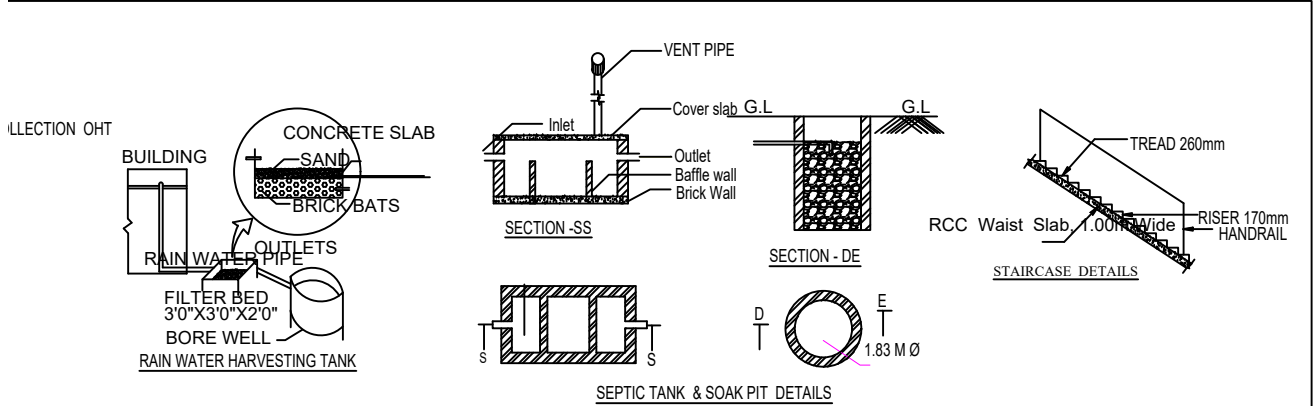
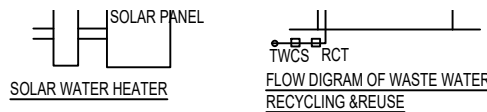
