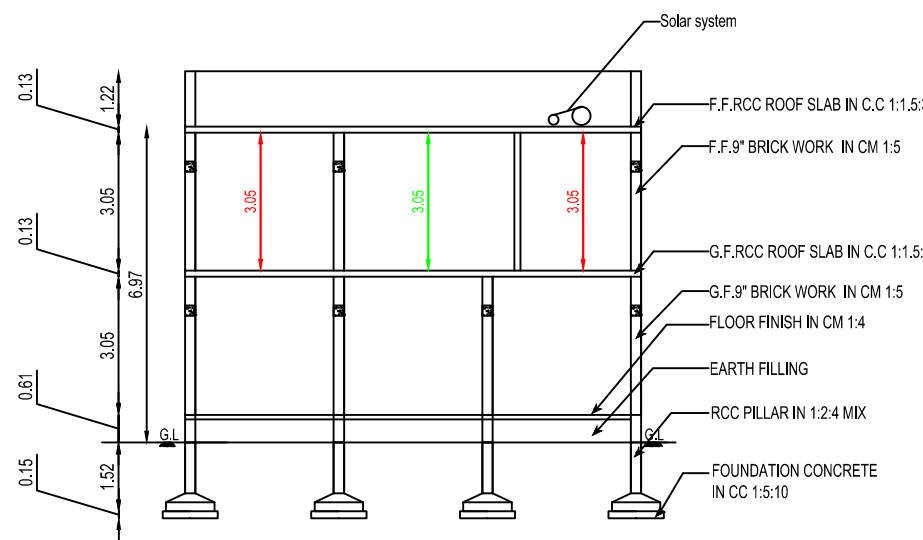

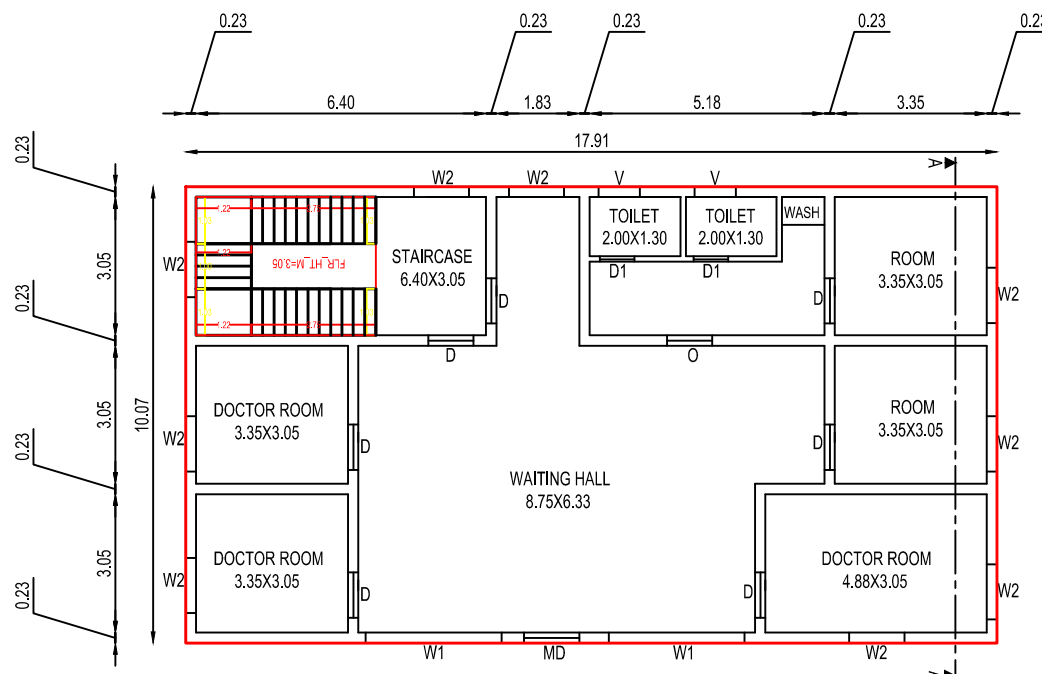

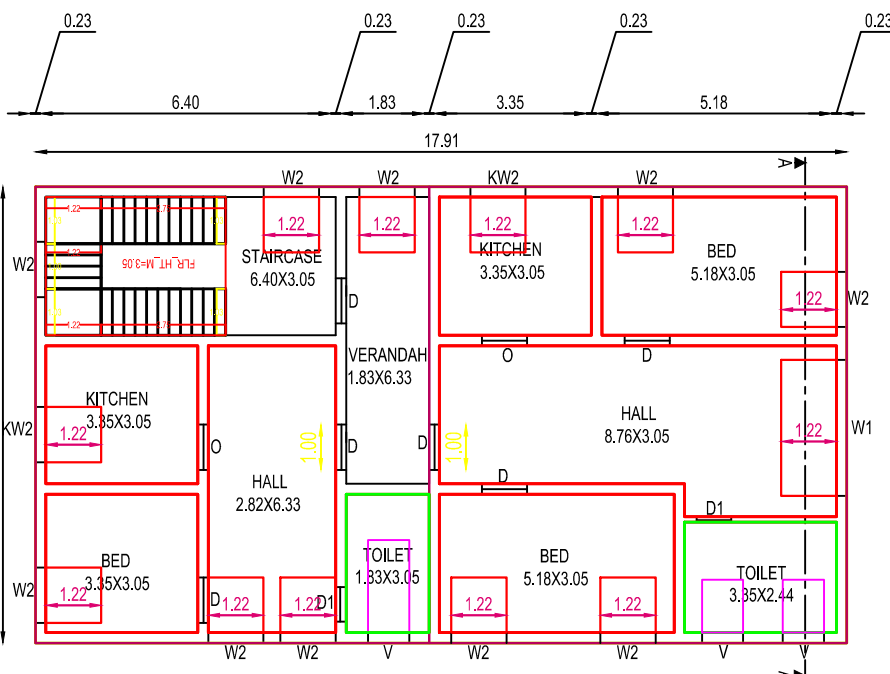

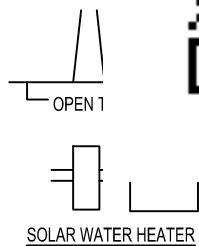

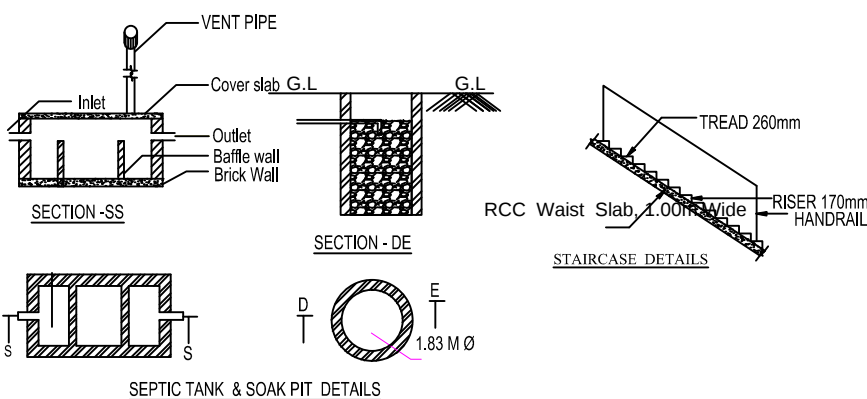
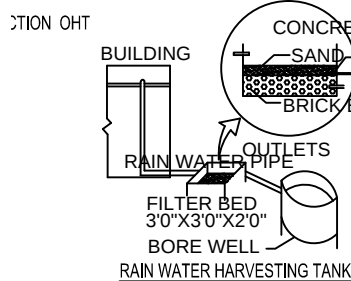
FLOOR PLAN

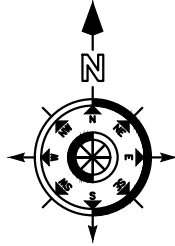

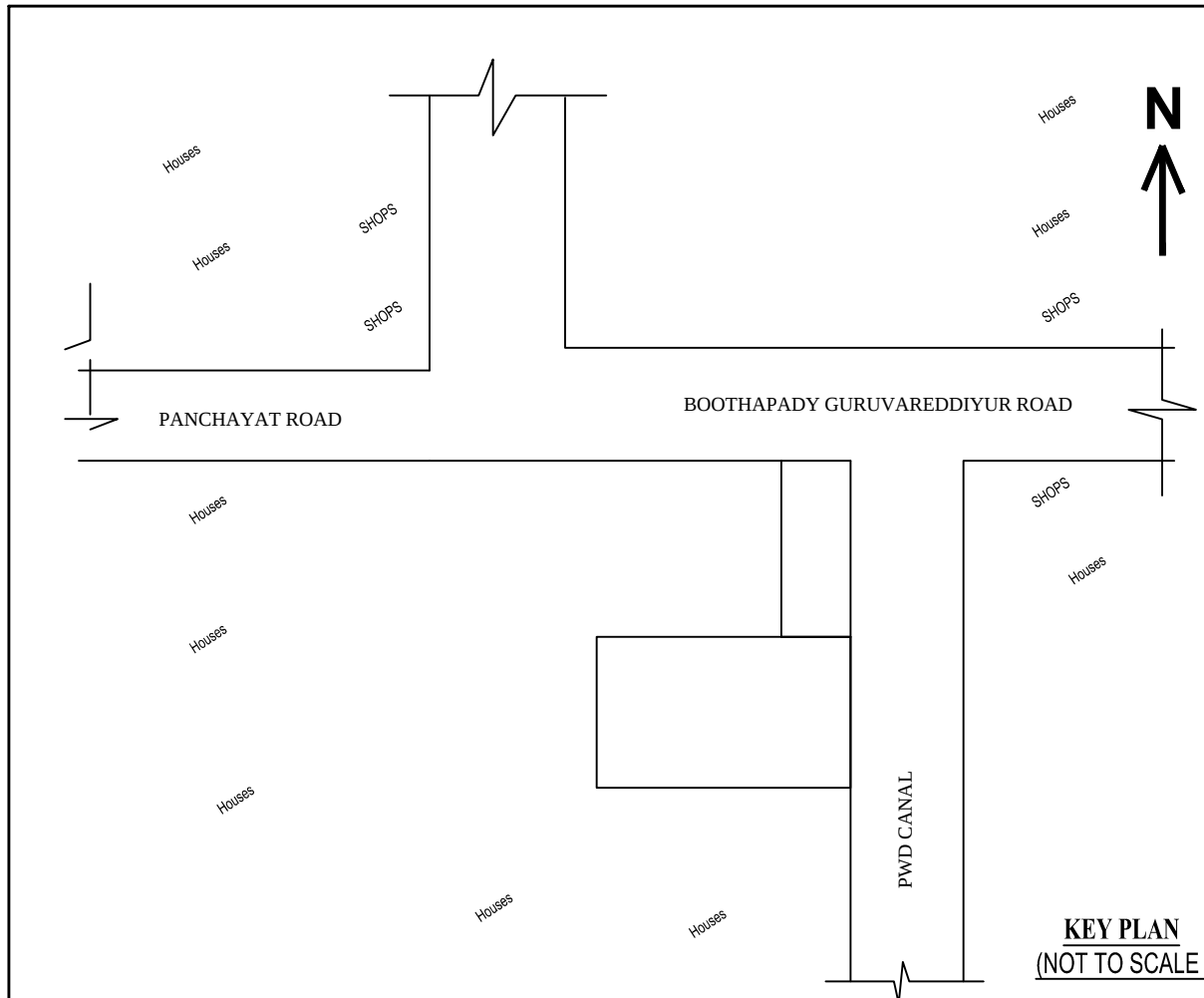
