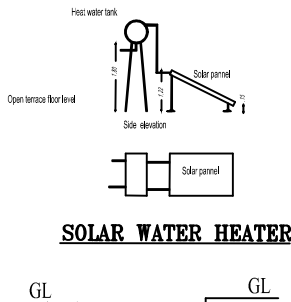

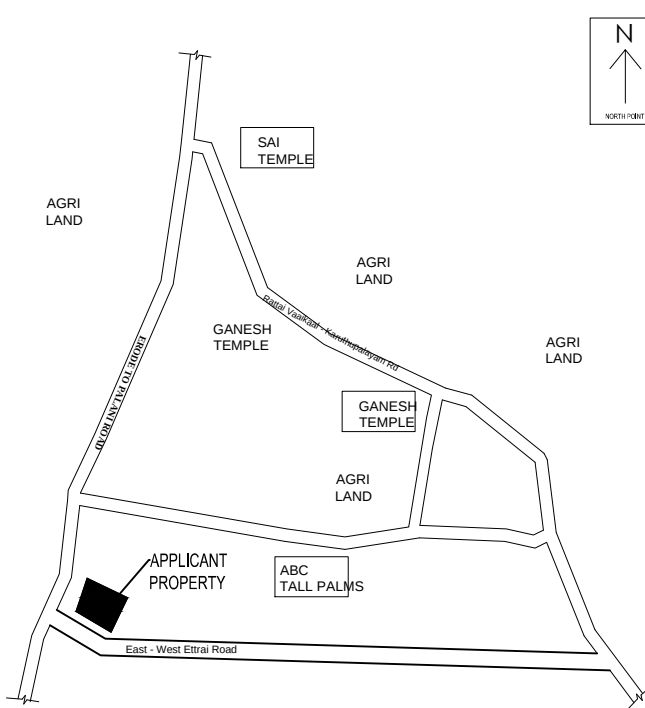

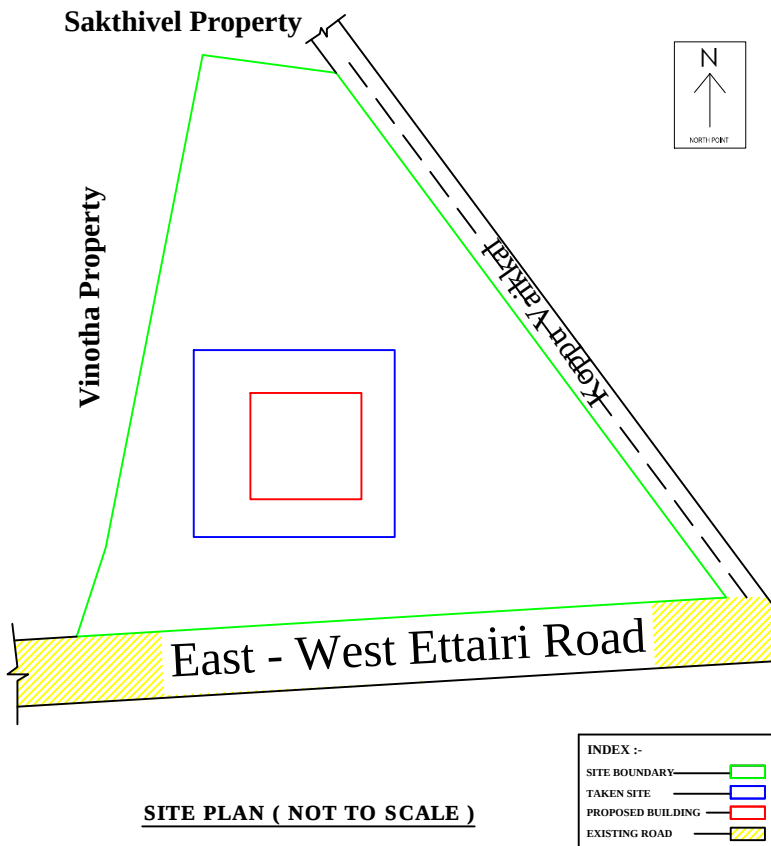
SITE PLAN (TAKEN AREA)

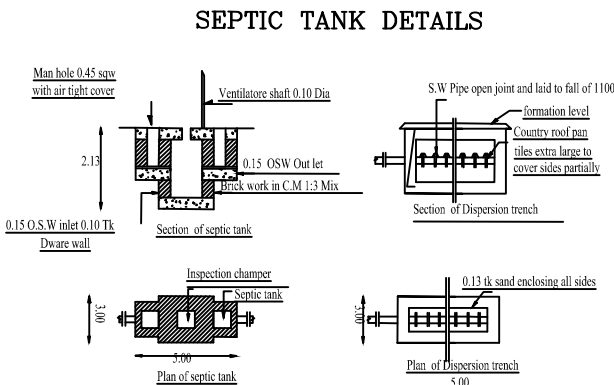
