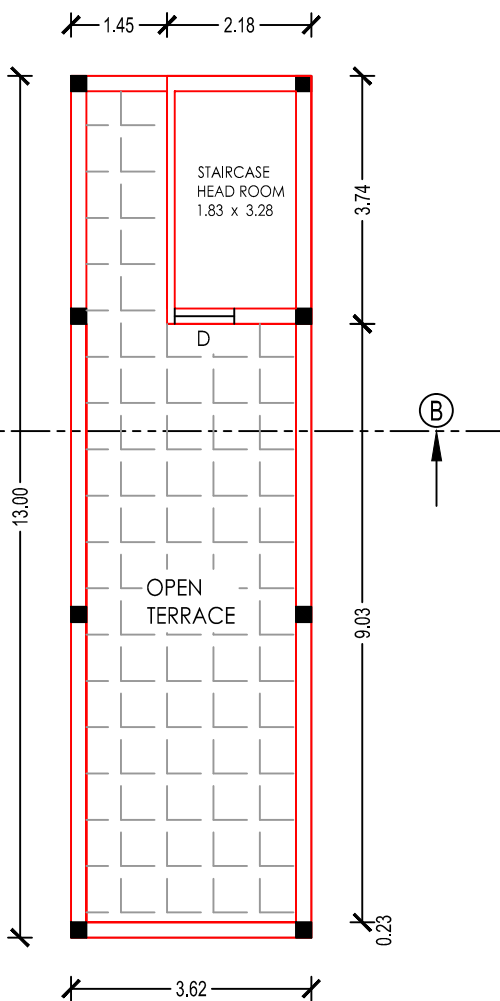
ELEVATION (WEST FACING)

GROUND FLOOR PLAN

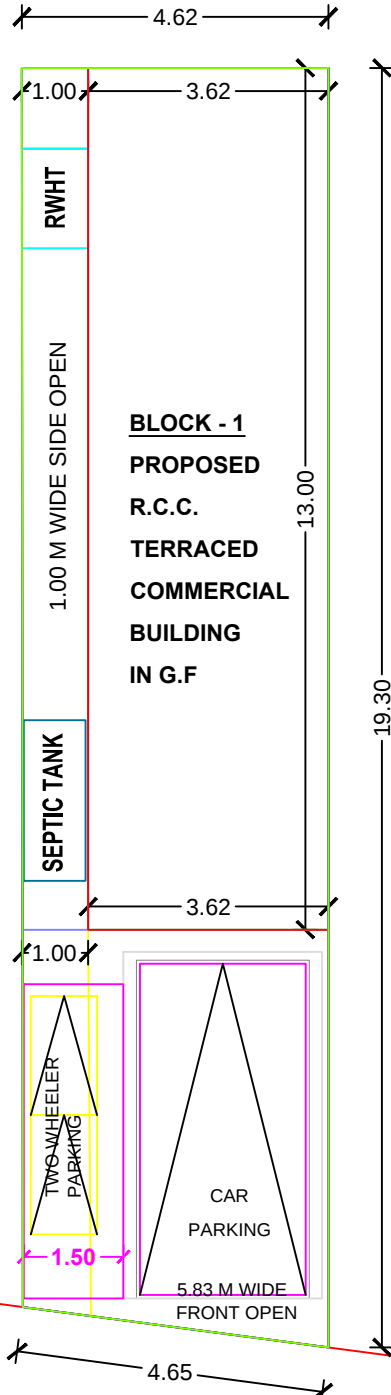

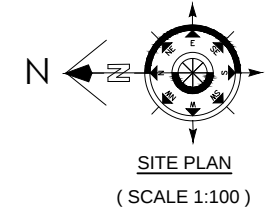
