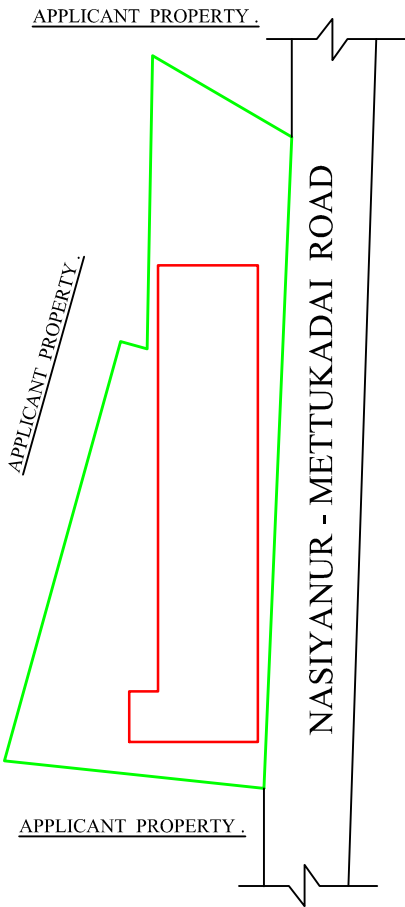
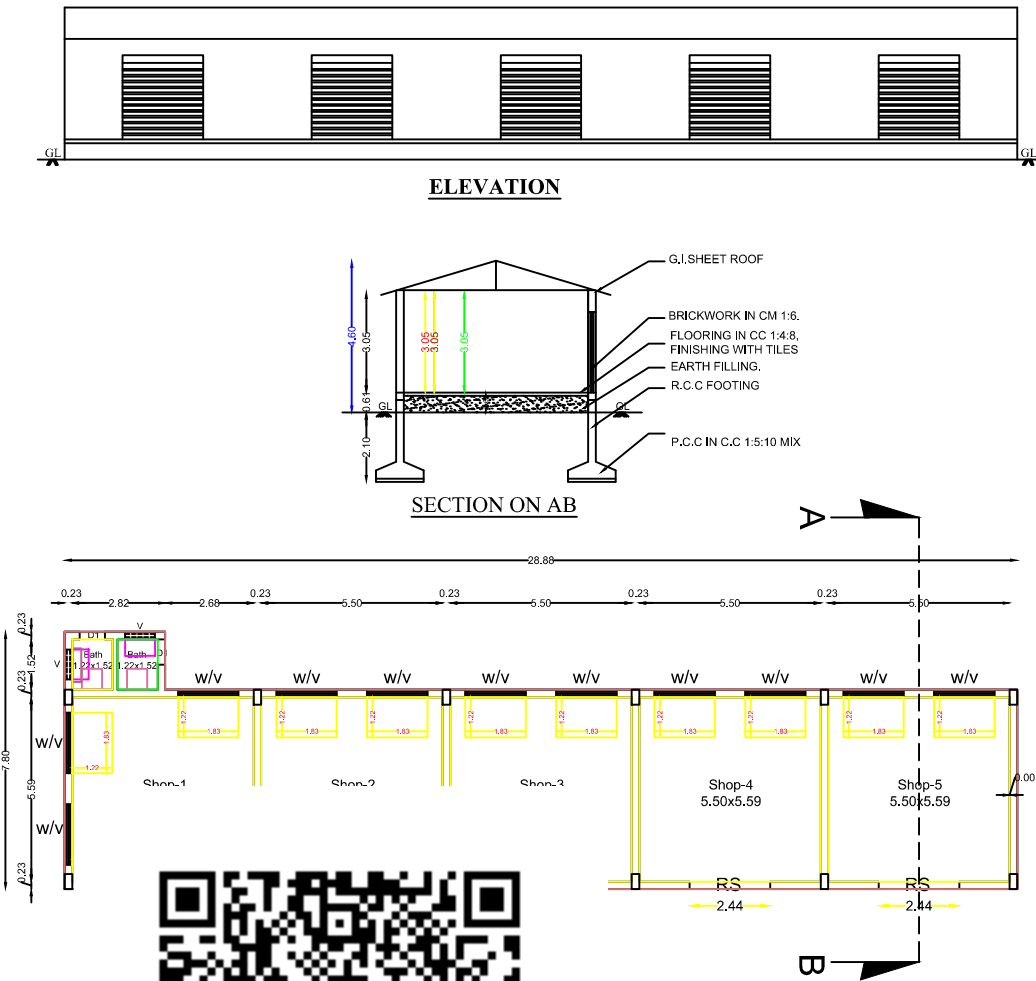

KATHIRAMPATTI PANCHAYAT , ERODE TALUK & ERODE DISTRICT .

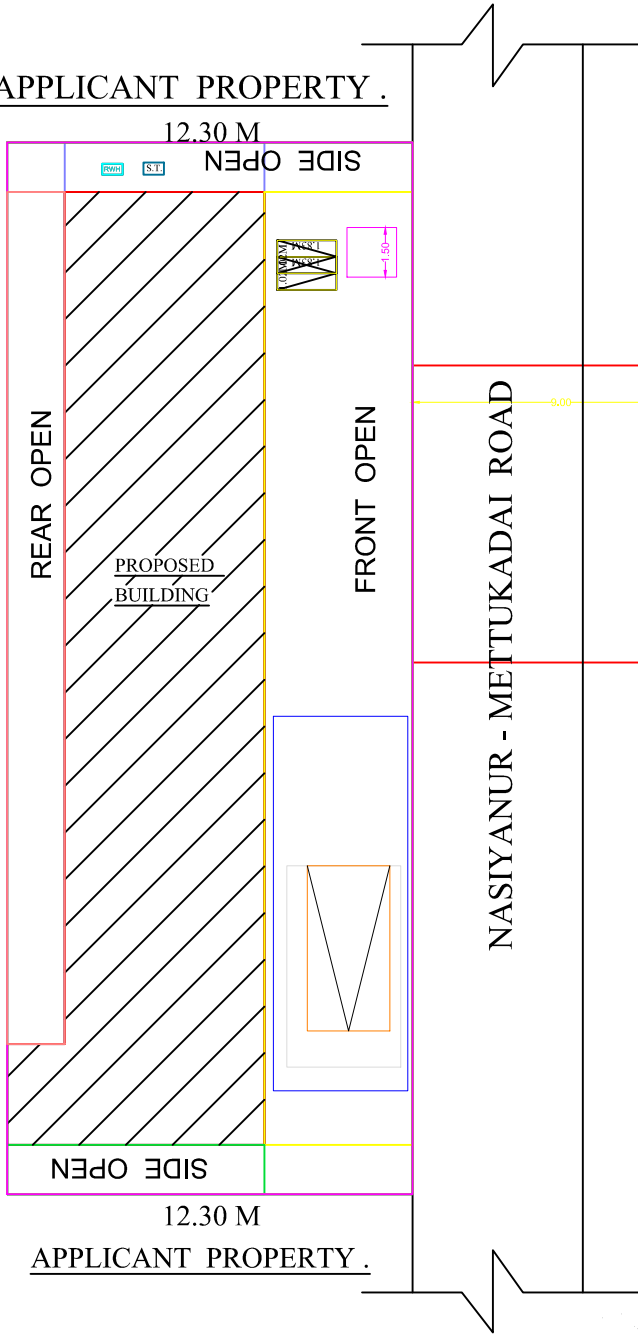

NOT TO SCALE

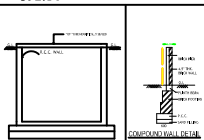
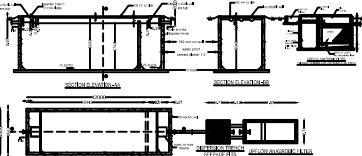
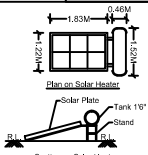
