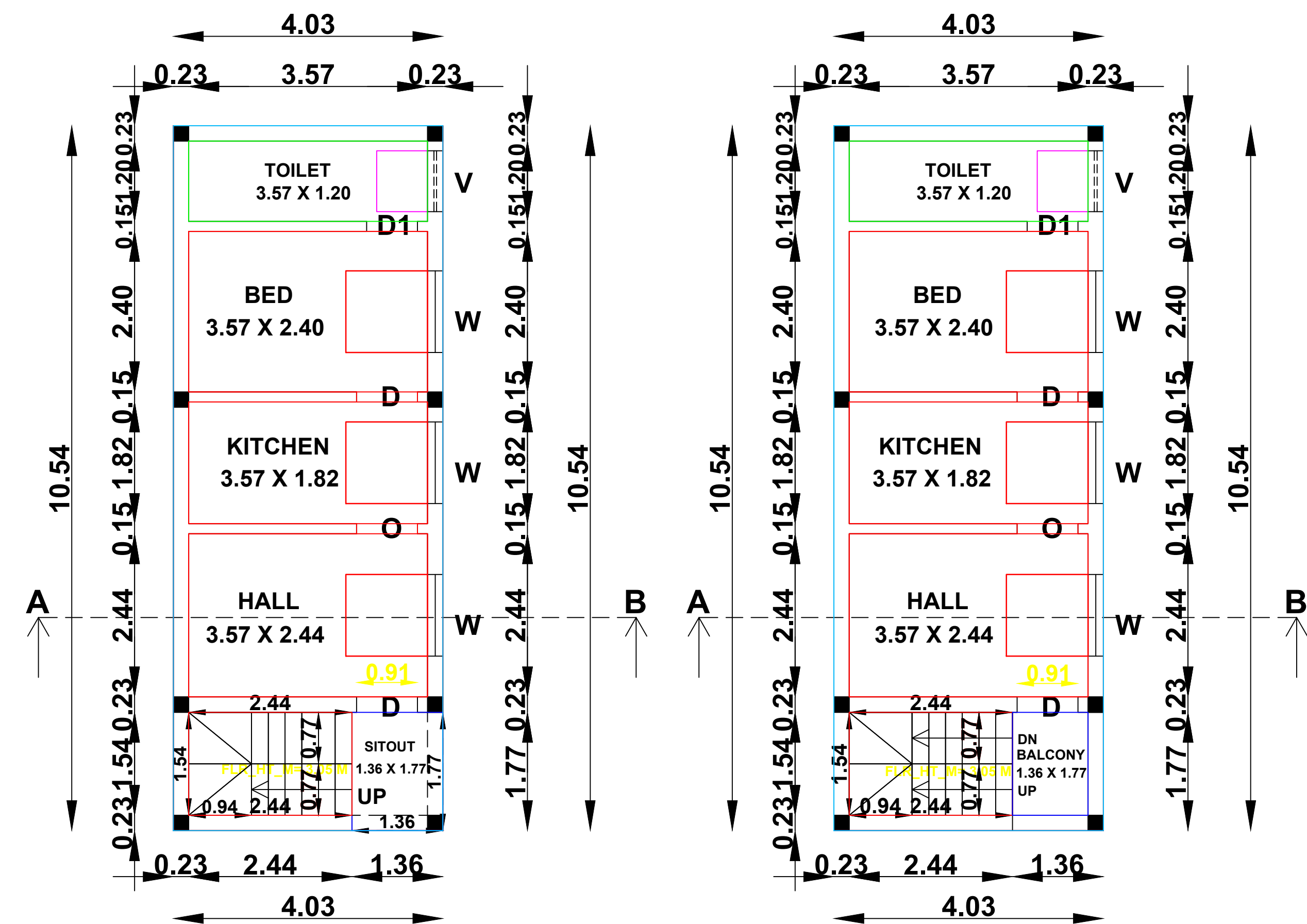
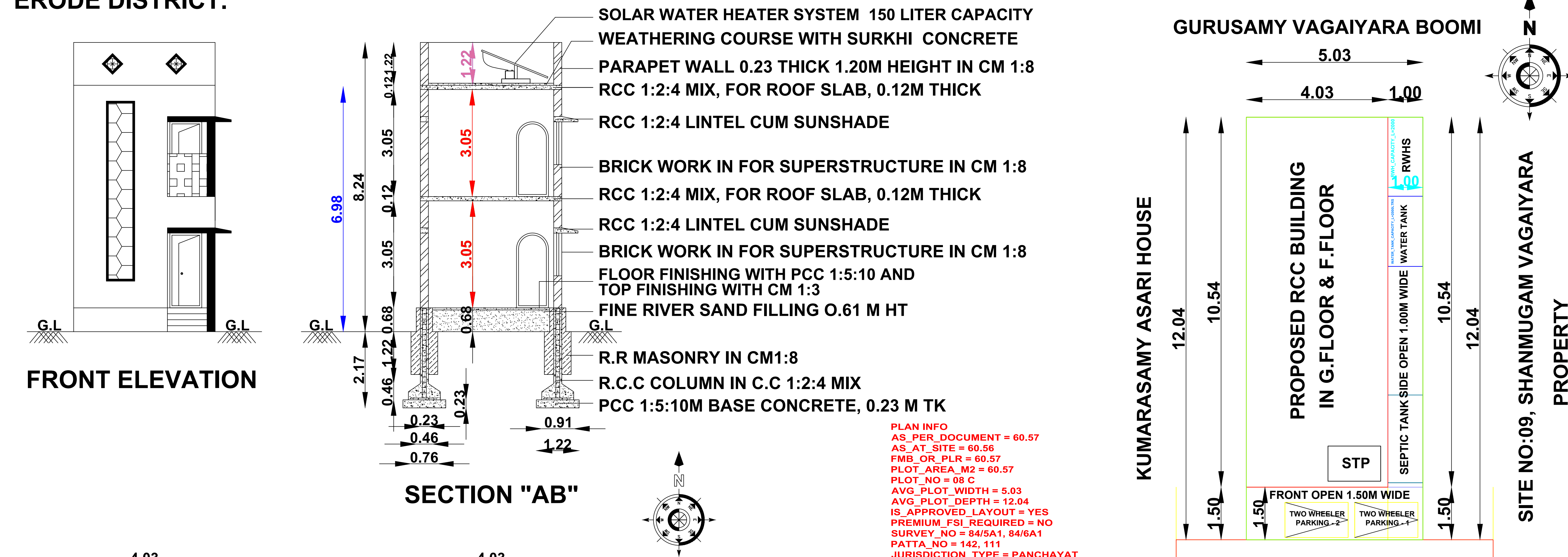

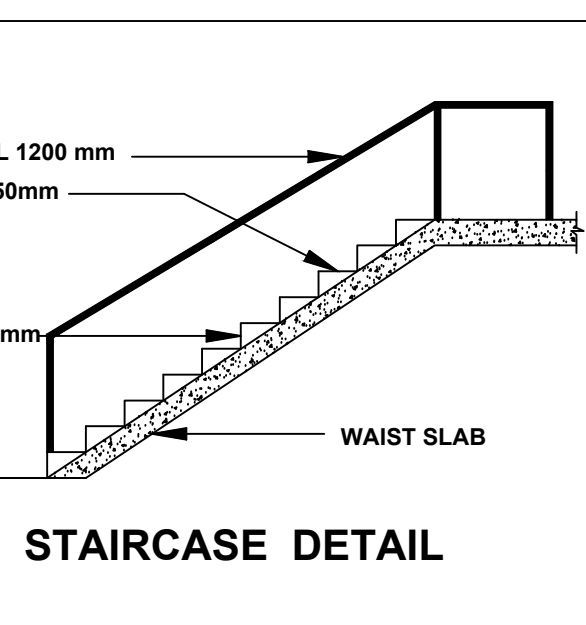
GROUND FLOOR PLAN

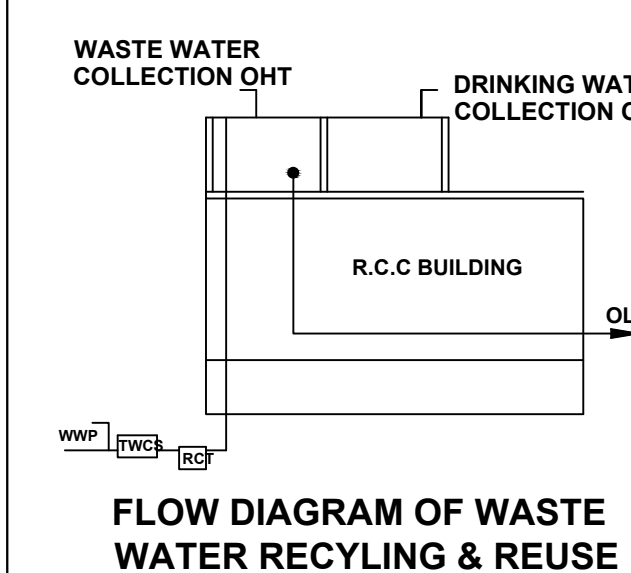

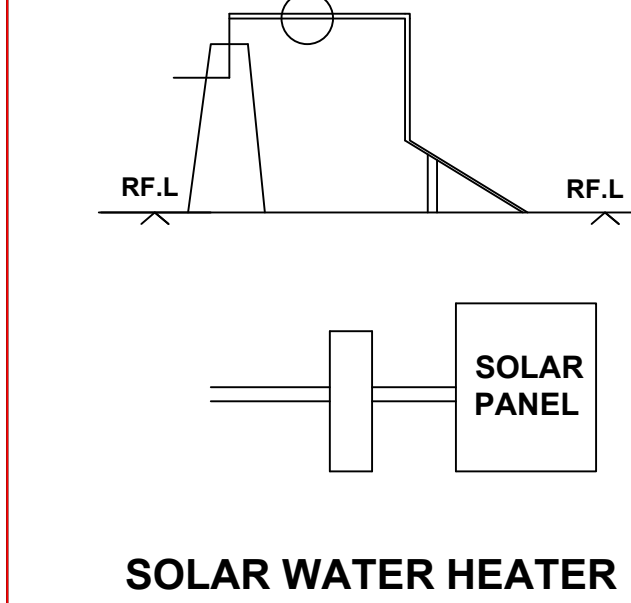

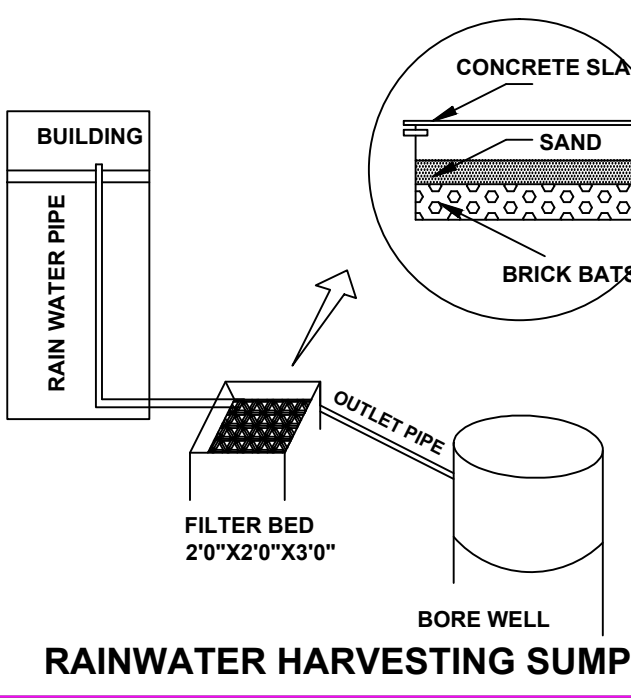
FLOW DIAGRAM OF WASTE WATER RECYLING & REUSE



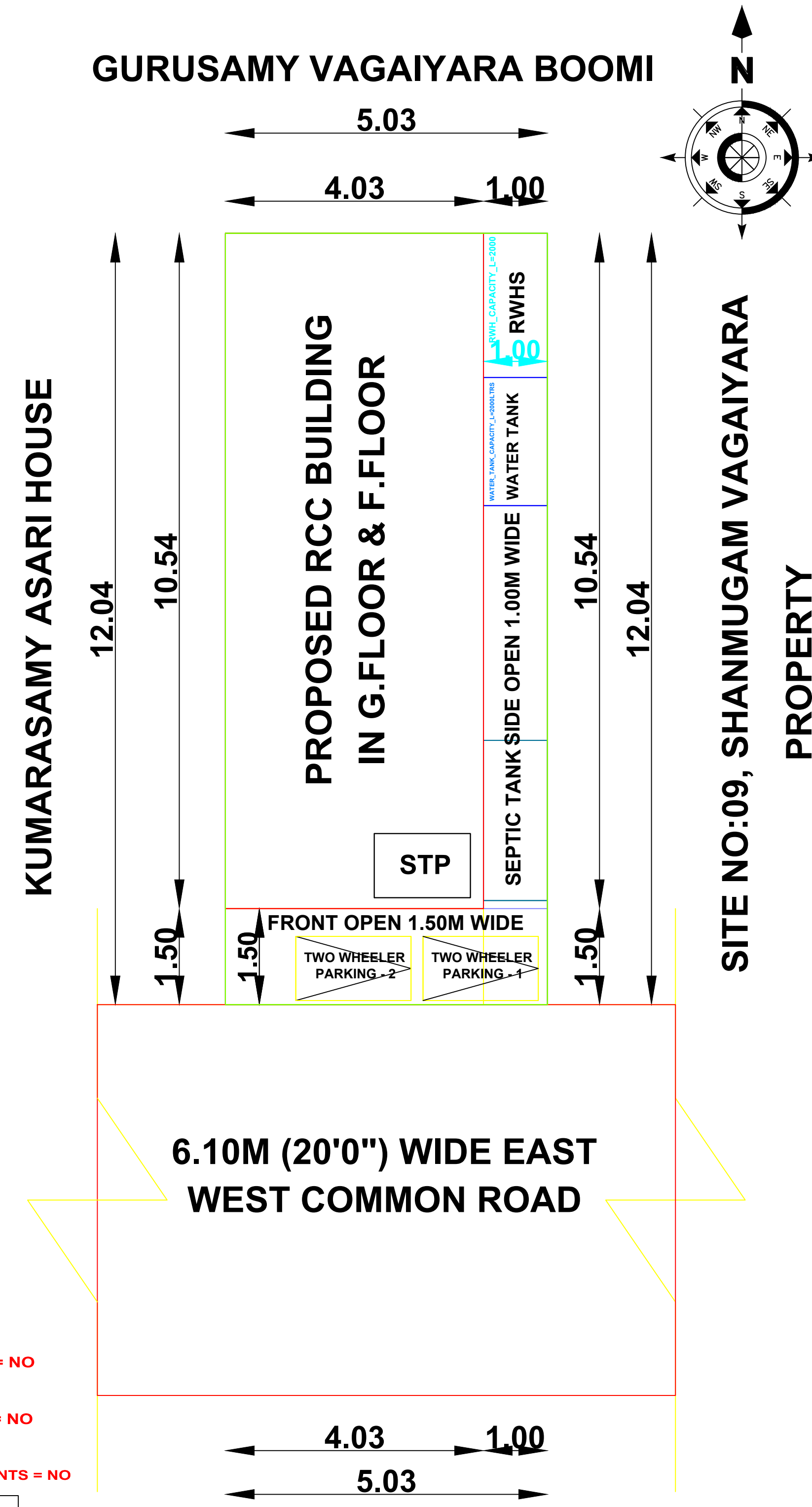
PLAN SOLAR SYSTEM (NOT TO SCALE)



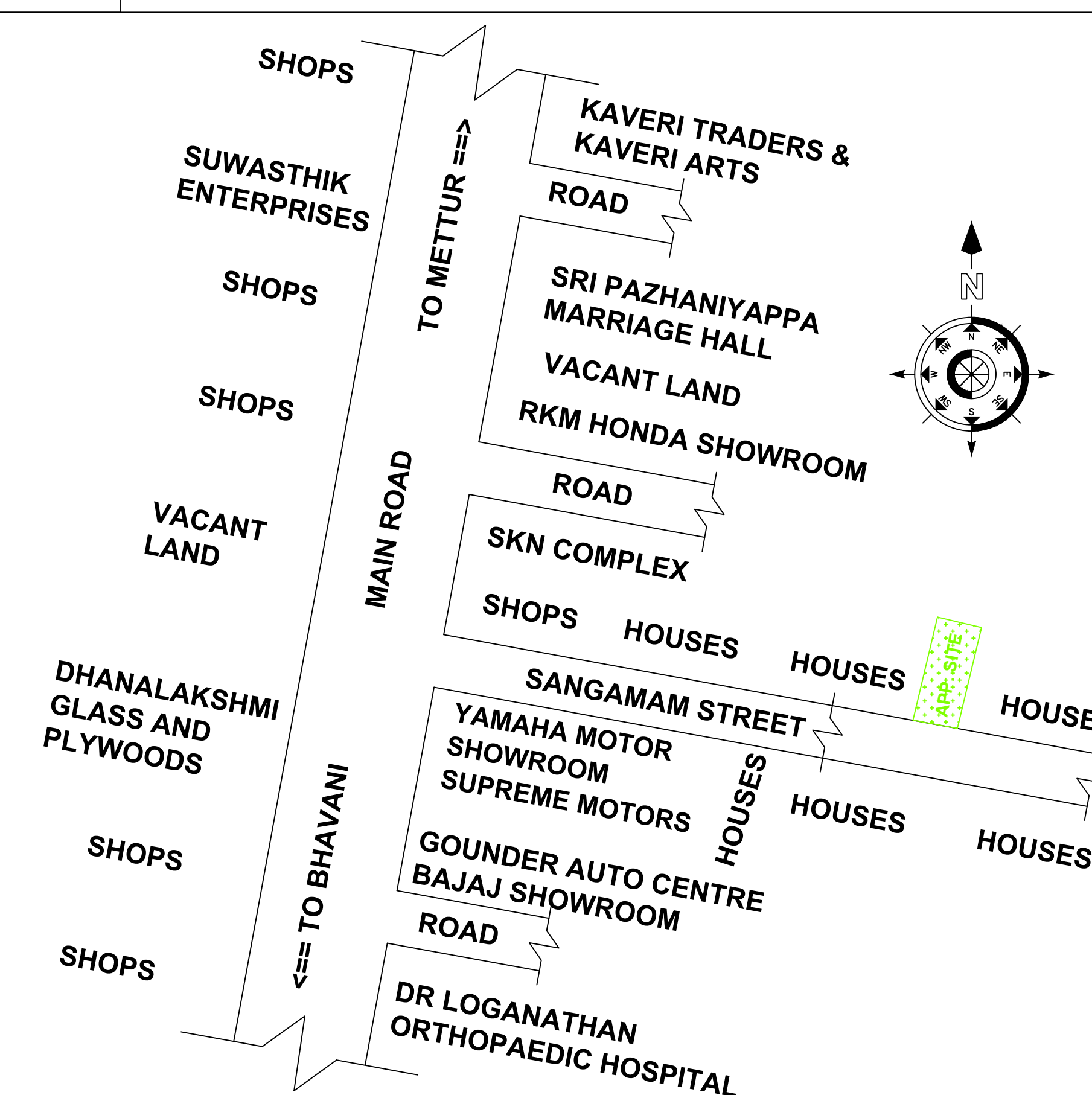
SOLAR WATER HEATER
