FRONT ELEVATION

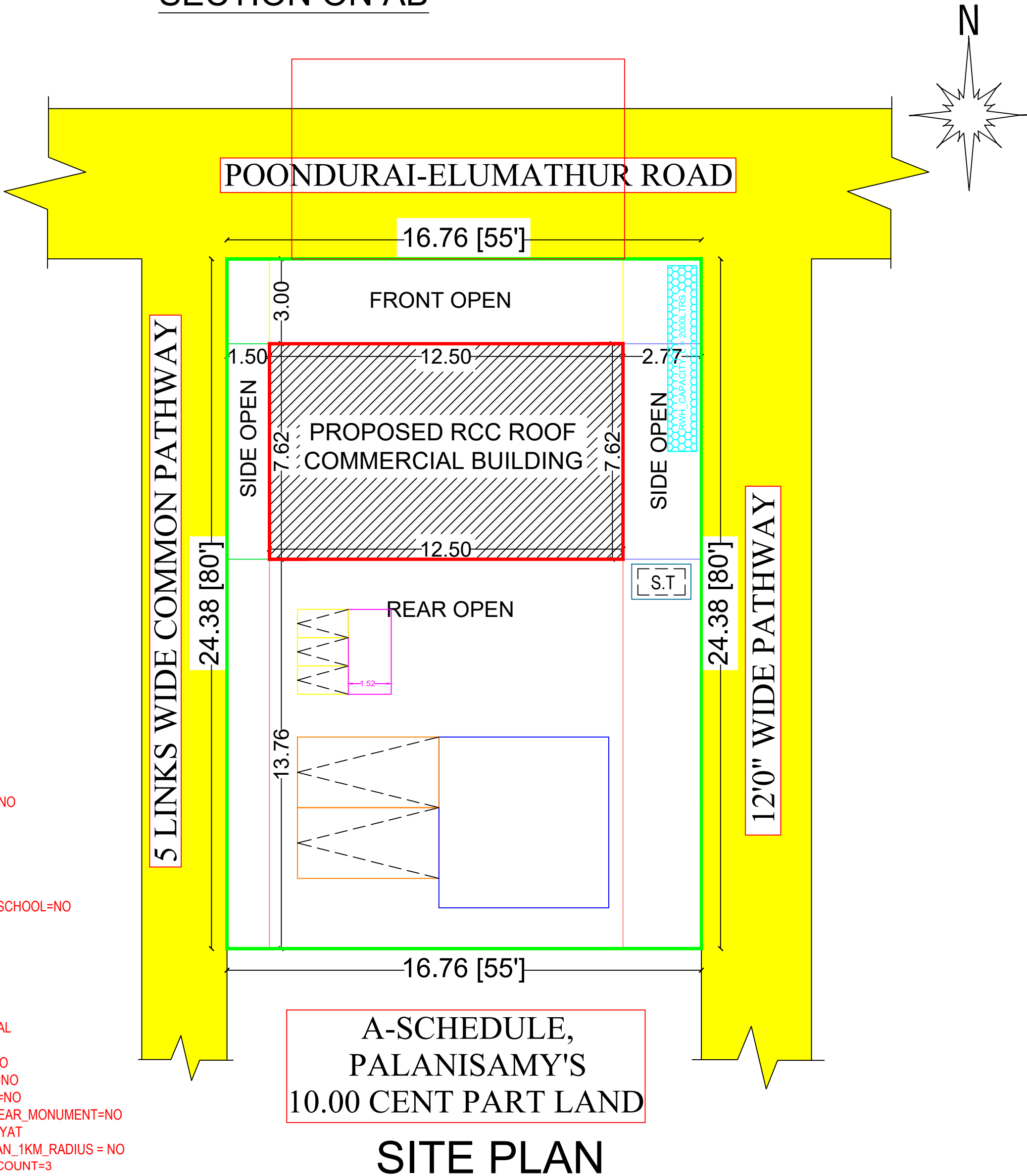

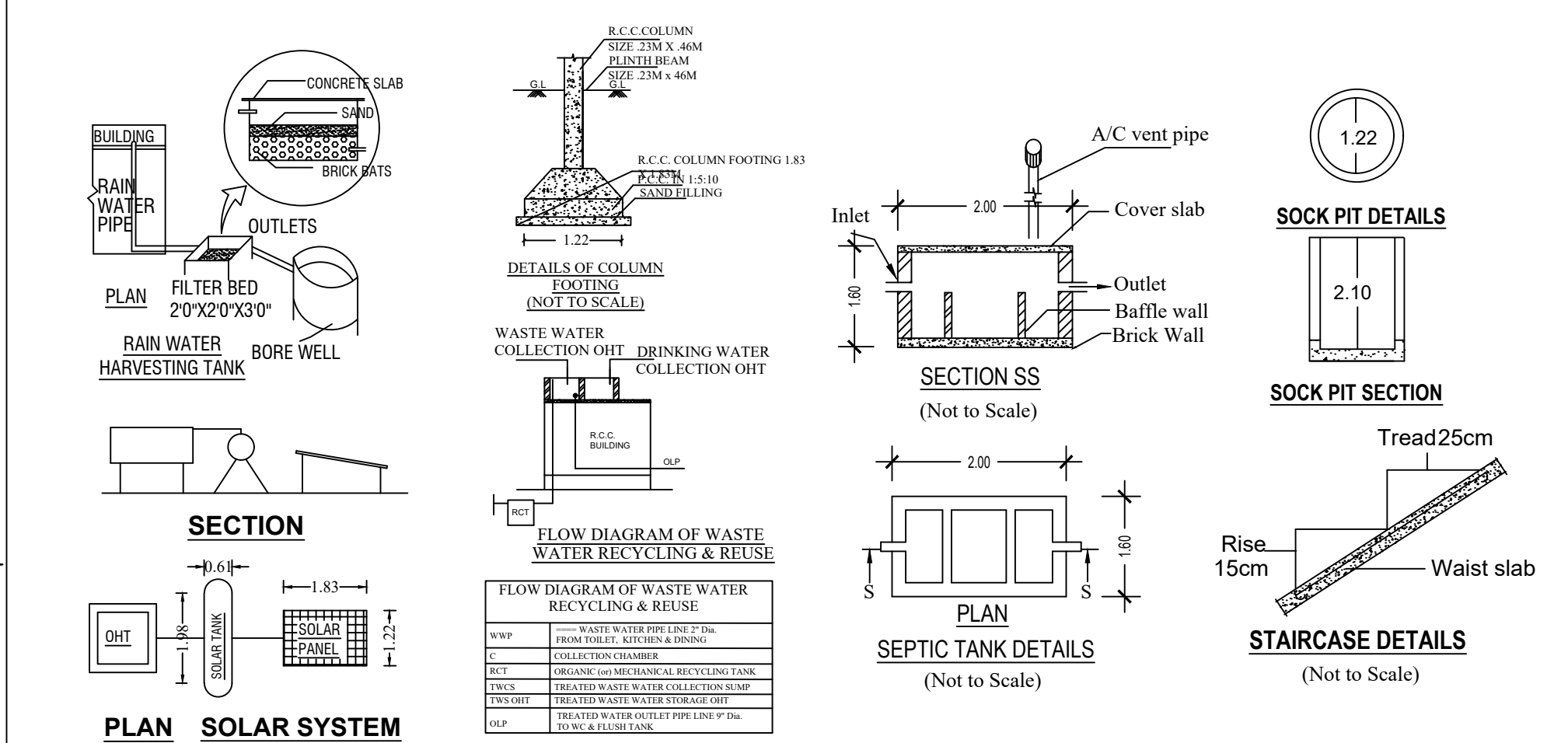


SITE PLAN
