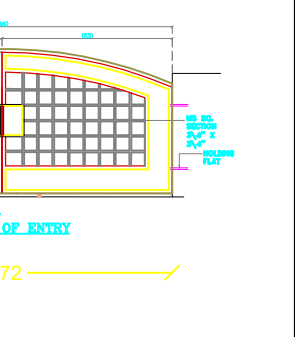
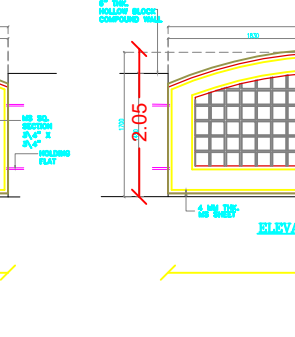
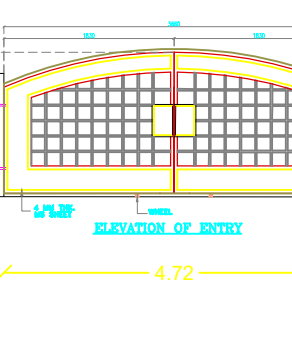
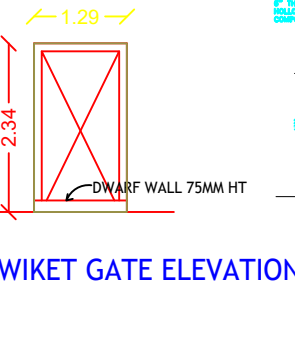
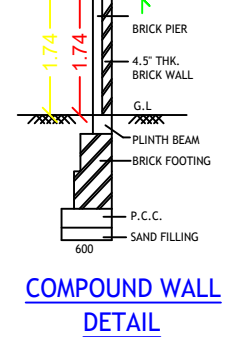
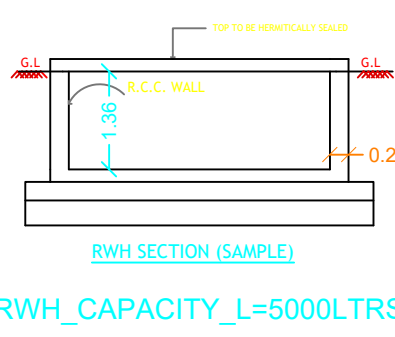
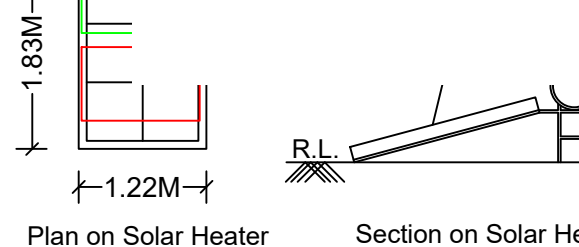
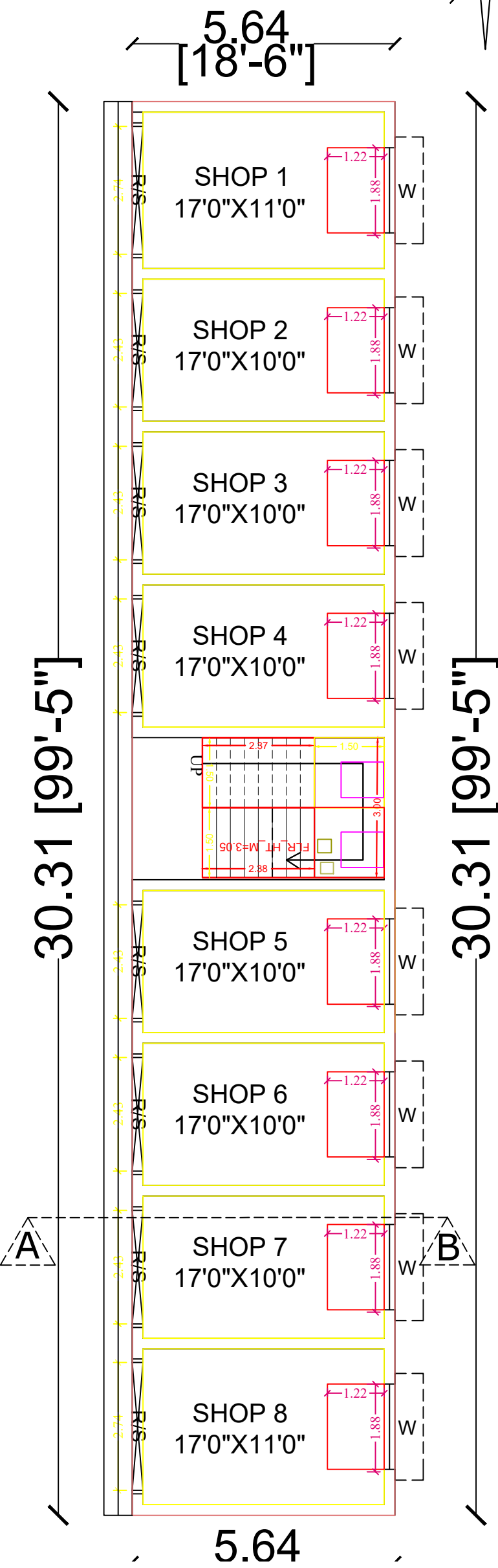


GROUND FLOOR  
PLAN BLOCK-2

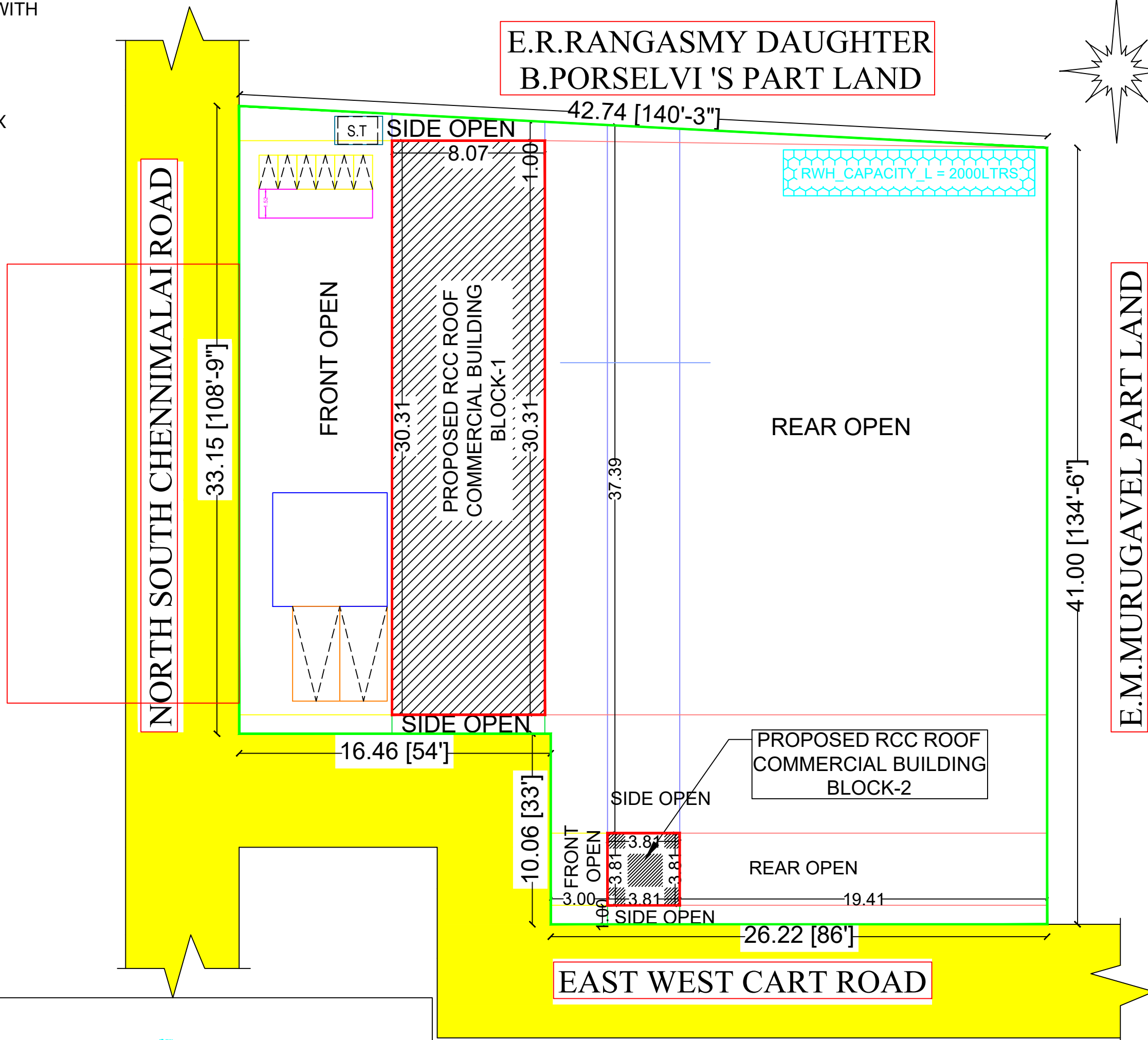

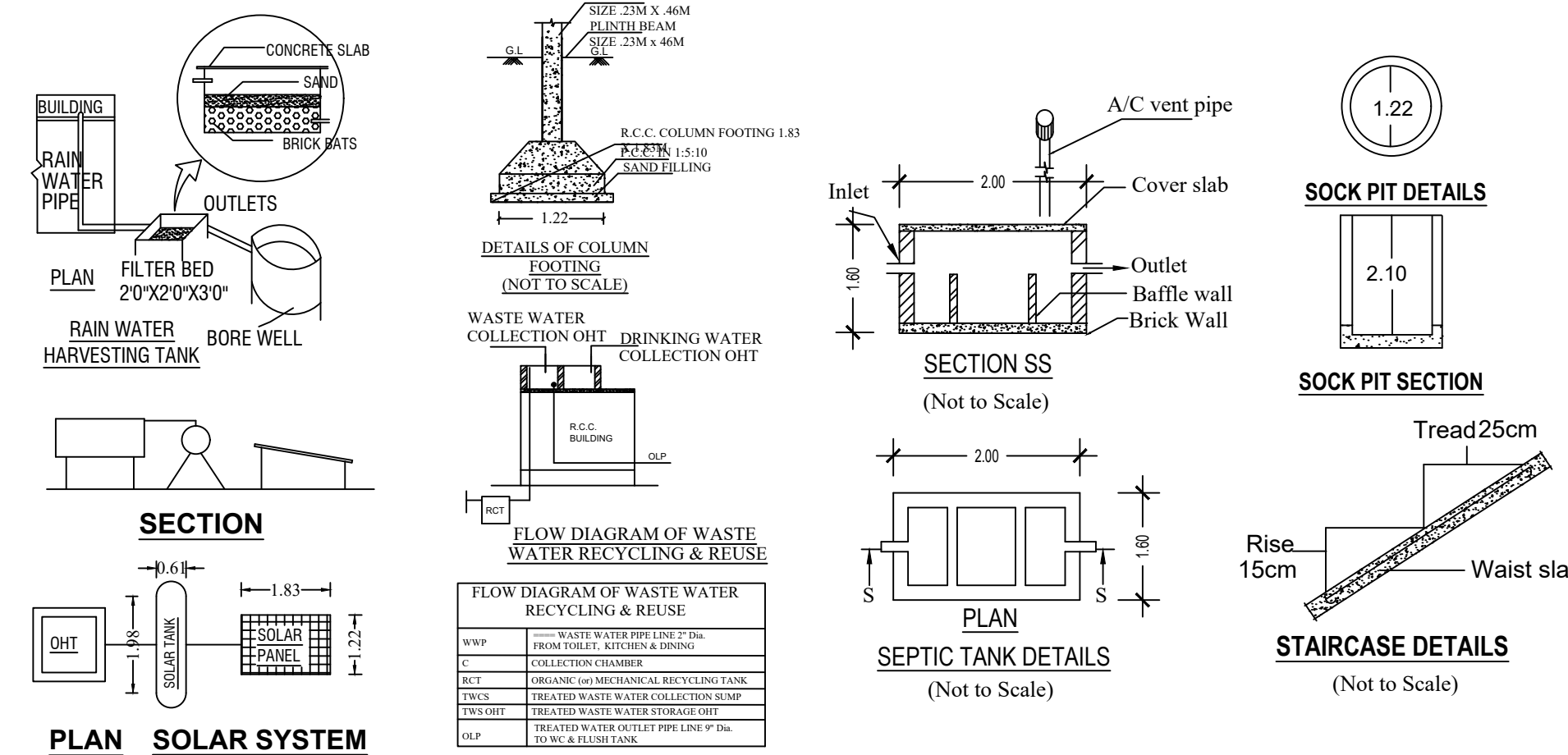
