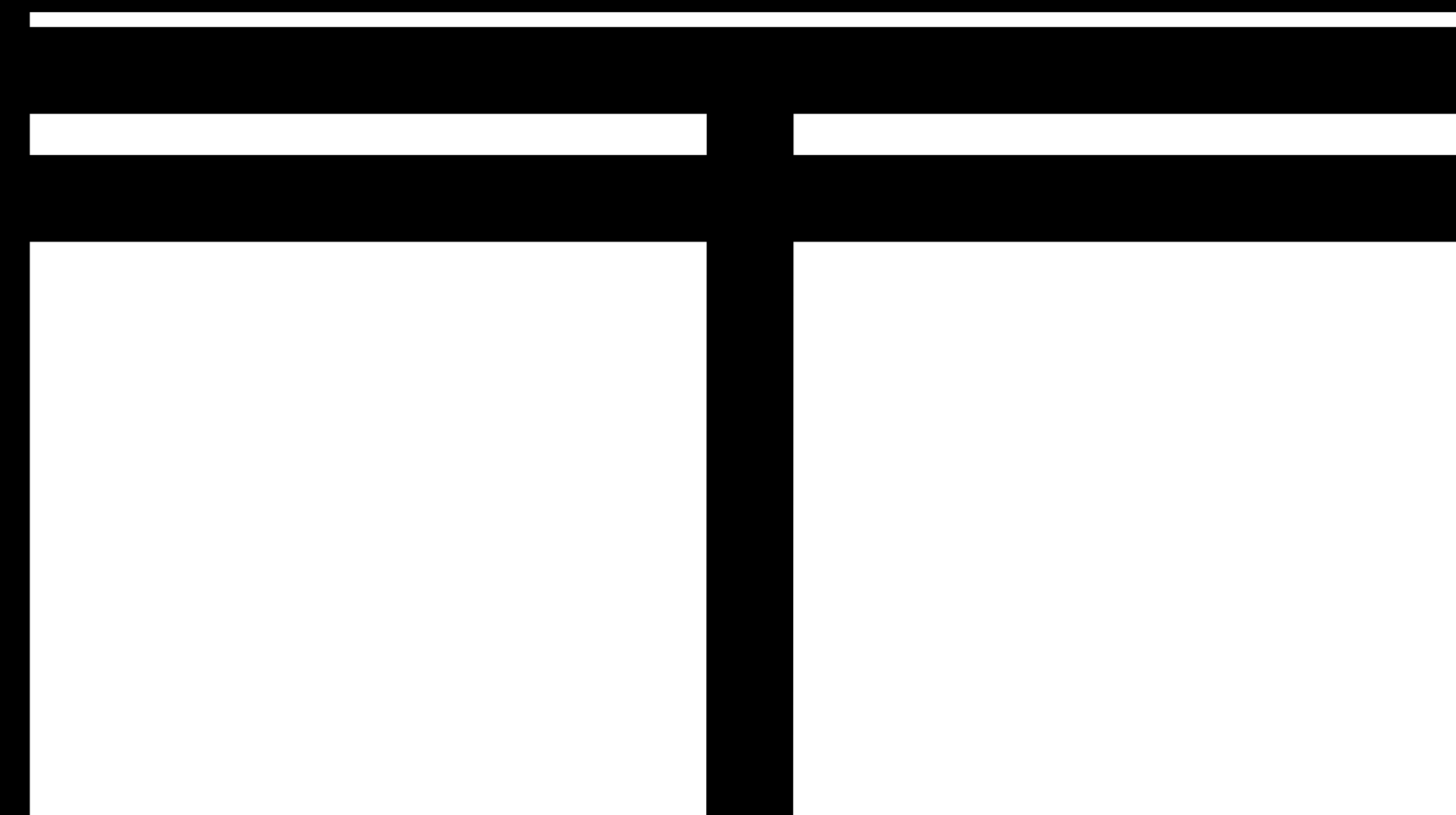
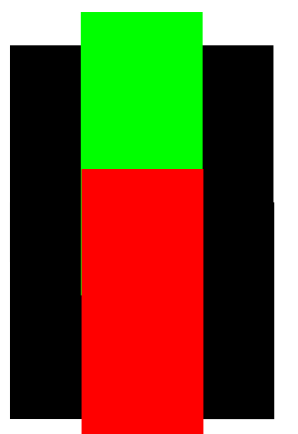


**SITE PLANS SCALE 1:40**
