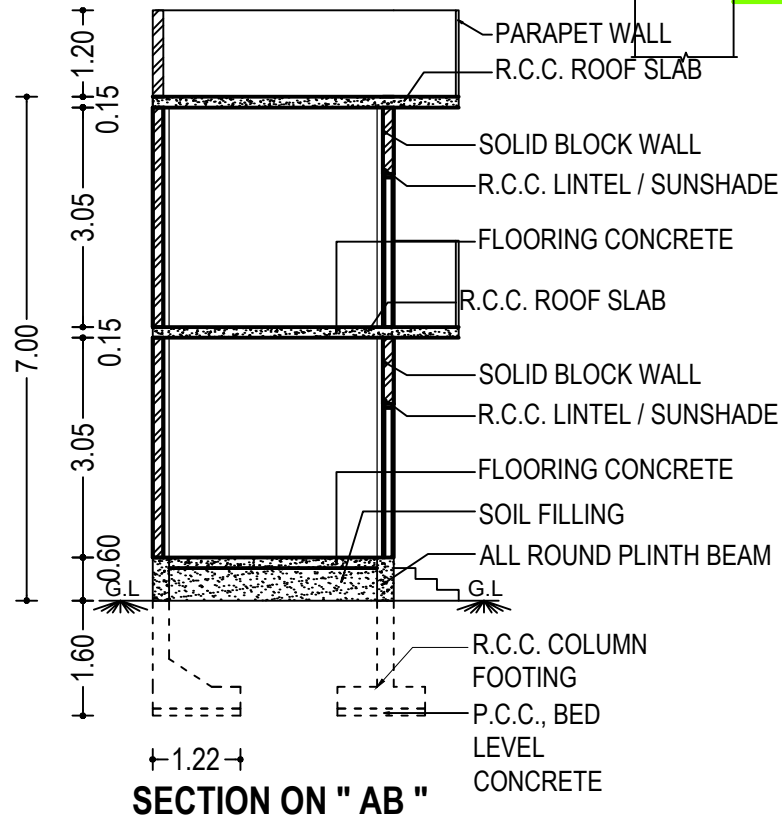

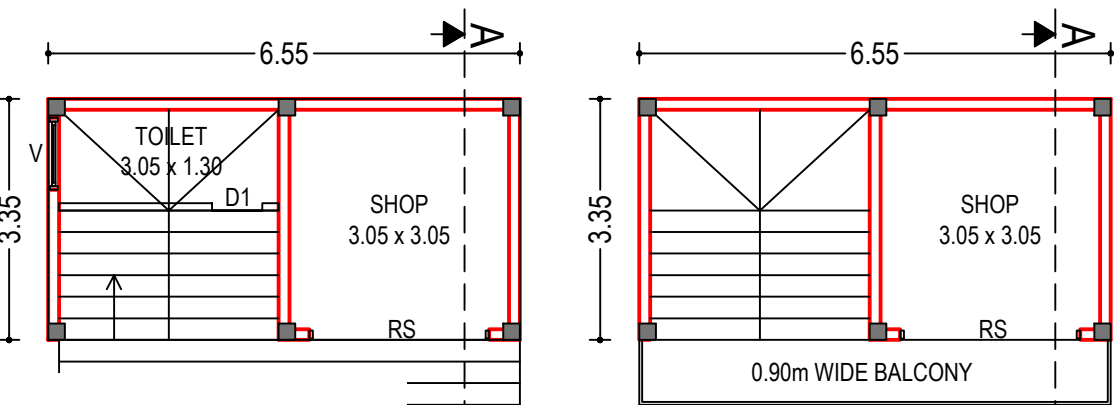

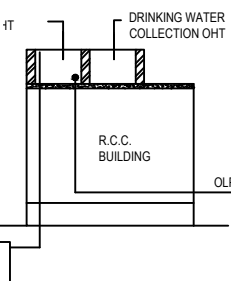

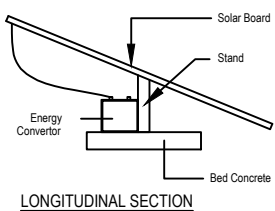

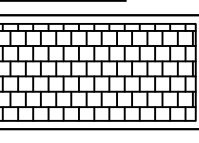
FIRST FLOOR PLAN



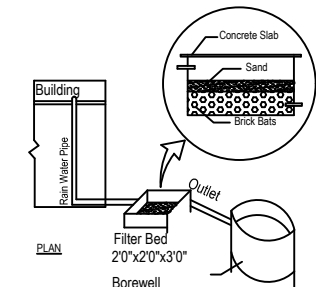

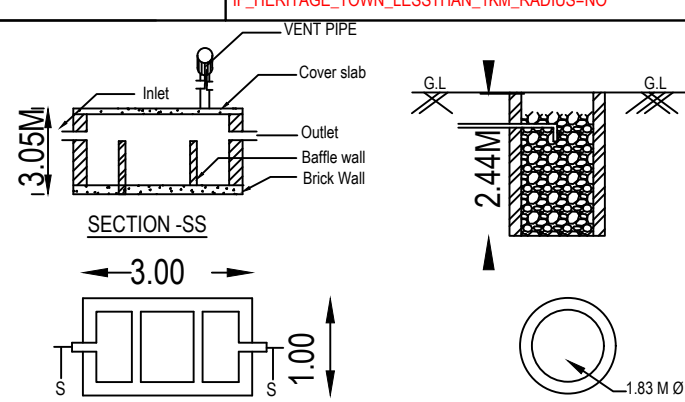

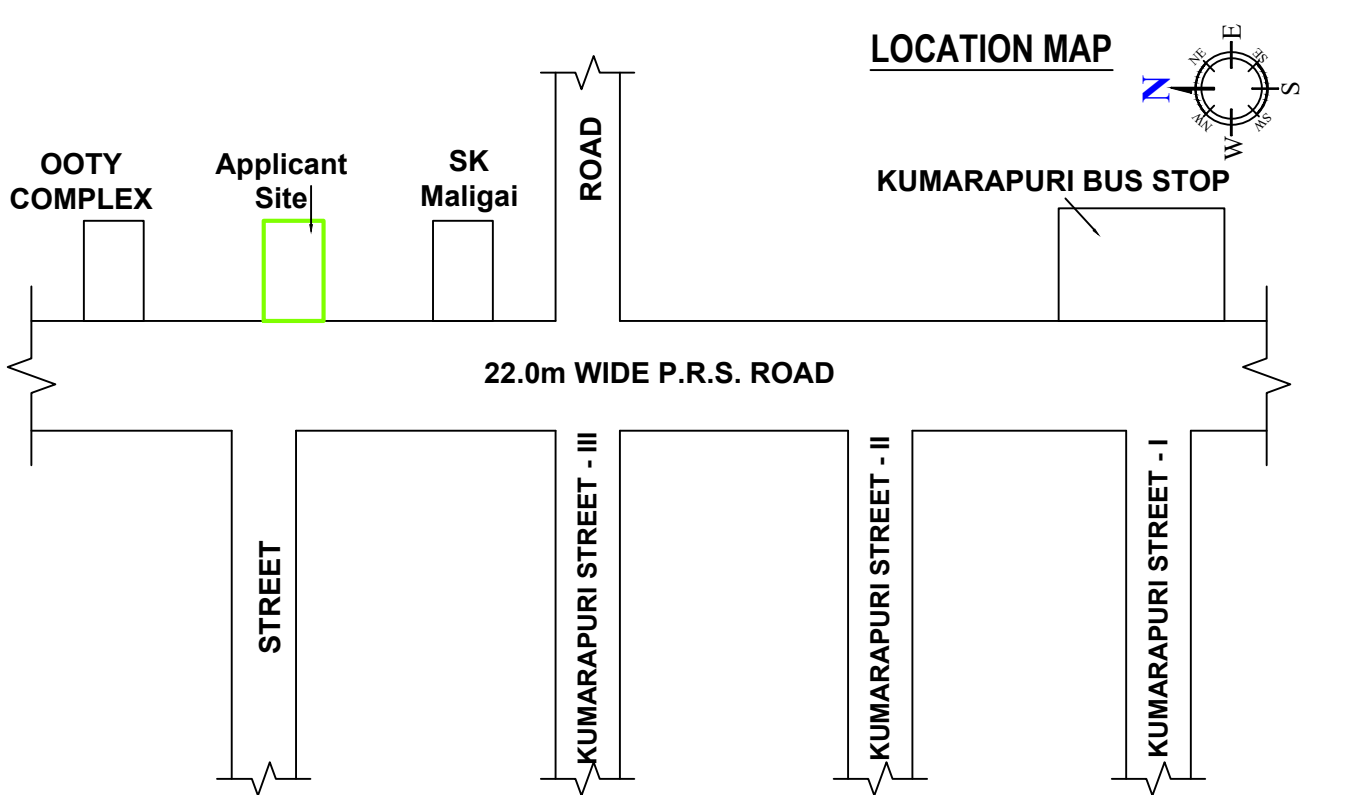
