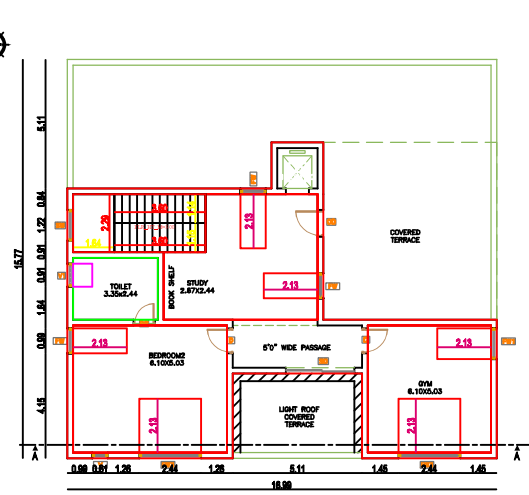

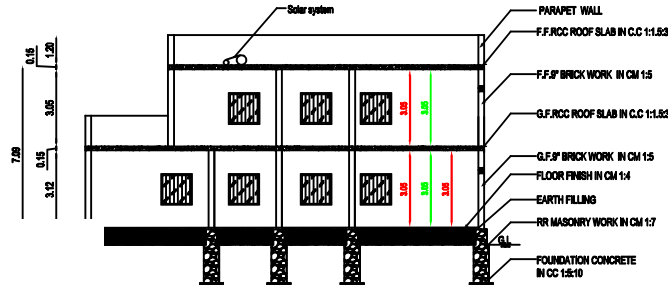

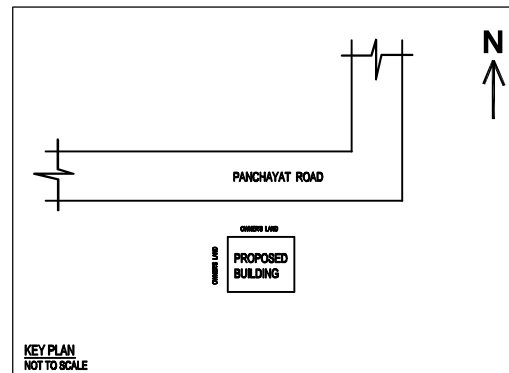
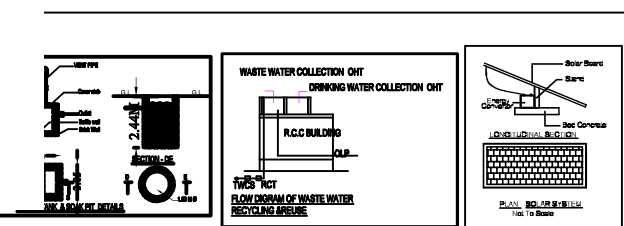
GROUND FLOOR PLAN



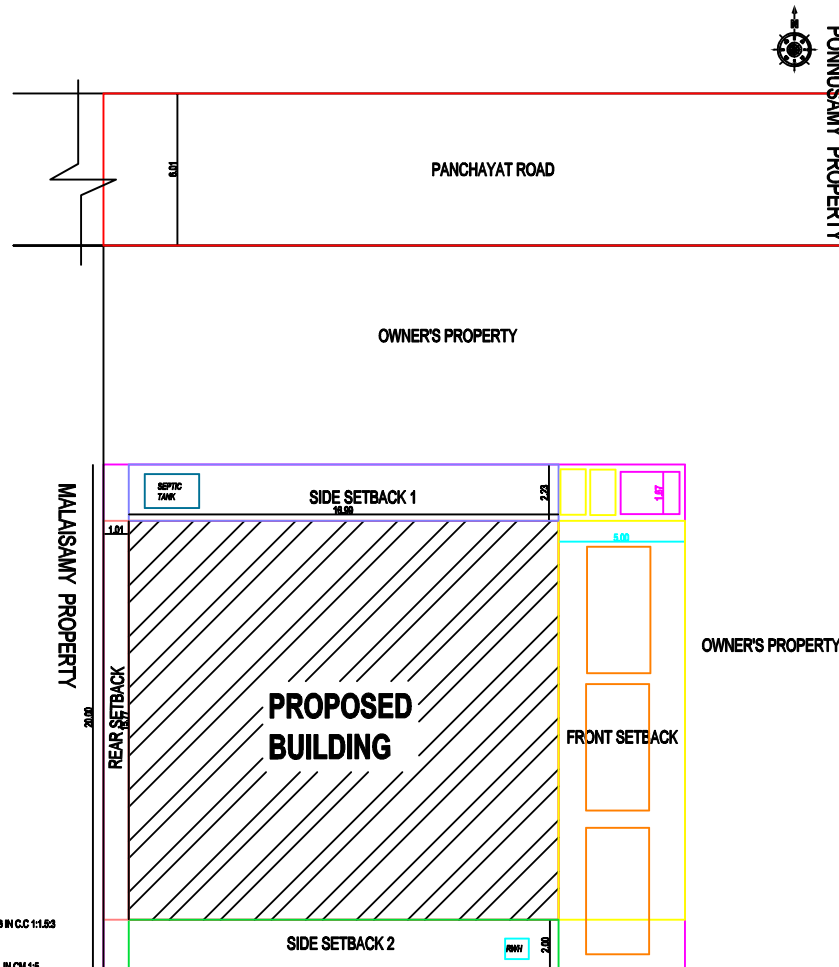
FIRST FLOOR PLAN
