With reference to the 1st Cited letter, applicant has requested for the Planning Permission of Residential Layout in Tirunelveli District, Tirunelveli Local

Planning Authority, Tirunelveli City Municipal Corporation, Melapalayam ward, Kulavanigarpuram village Part-3, S.F.No:1050 part and 1051 part New Town

Survey Ward - BP, Block -28, TS.No.9/1B,10/3B, Perumalpuram Detailed Development plan - 4, site extent of 6490.00sq.m.(1.60 Acre)

Earlier ,

with reference to the 17th cited ,the writ petition was filed by Thiru.Prasanna Guru and Thiru.Guru prakash in Madurai bench of honourable High court

of High court in W.P(MD).1422 of 2024 and orders issued under section 38 of the Tamilnadu Town and Country Planning Act 1971 for the deletion of

scheme road in Perumalpuram Detailed Development plan - 4 and the orders are as follows

,38,Release of the land - If within three years from the date of the publication of the notice in the notice in the Tamil nadu Government gazette under

section 26 or section 27 - (a) no declaration as provided in sub-section (2) of section 37 is published in respect of any land reserved, allotted or

designated for any purpose specified in a regional plan, master plan, detailed development plan or new town development plan covered by such notice; or

(b) such land is not acquired by agreement, such land shall be deemed to be released from such reservation, allotment or designation."

As per order of the Madurai Bench of the madras High court, vide reference 18th cited orders are issued for the deletion of scheme roads in, Tirunelveli

District, Tirunelveli Local Planning Authority, Tirunelveli City Municipal Corporation, Melapalayam ward, Kulavanigarpuram village Part-3, S.F.No:1050 part

and 1051 part New Town Survey Ward - BP, Block -28, TS.No.9/1B,10/3B, Perumalpuram Detailed Development plan -

4,approved by The Director of Town

and country planning Department as map No 3&4 T.P/D.T.P No -56/1967, the proposed scheme road D2D2 ,60 feet width, E6E6 road 50 feet width and

E7E7 road 50 feet width within the applicant land measuring an area of 2072 sqm

In continuation, with reference to the 2nd cited letter, road pattern for Residential Layout has been issued by the Office of the District Town and country

planning/Tirunelveli Local Planning Authority, Tirunelveli District on 18.11.2024. Further the applicant Thiru.E.Lakshmana Pandian has through gift deed the

road and road splay have been handed over to the local body vide document No. No.8976/2024 and 8979/2024

dated:26.11.2024and in lieu of providing

the OSR, a sum of Rs. 48,90,330/- is paid on28.11.2024 through online.

Hence, the residential layout has been approved and approval number is issued as L.P/TLPA No:SWP/96/2024 and Planning Permission No.P.P/L.P/TLPA

No.SWP/137/2024 with below conditions.

Conditions:

1. After obtaining the layout map and original gift deed documents from the applicant and then completing the rules mentioned in the Government

order reference 5th and 15th cited, the local body should give final approval to the layout.

2. Further, when the final approval is given by the local body, it is requested to send a copy of the conditions to this office immediately.

3. After the approval of the local body. It is requested to send the approved residential layout map to the concerned registration department office and

land survey department for information and appropriate action.

4. It is requested to send acknowledgment of receipt of receiving Maps and Proceeding orders.

5. As per circular cited in 10th it is requested to send the proceeding orders and maps to the concerned Tahsildhar to update on Tamilnilam website.

Special Conditions :-

1. (a)With reference to the 7th cited, 5th cited and 15th cited letter, if the located site lies in the Municipal/ Corporation areas: The Owners / developers

shall be allowed either to carry out infrastructure development works as per the standards specified by the local body concerned or to pay the estimate

cost to the local body. Concerned local body shall prescribe the standards for the provisions of basic infrastructure like roads, drains, water supply etc, for

the layout as per existing rules. Before taking over the infrastructure developed by the owners / developers, the local bodies shall ensure the quality of works done by the owners / developers. Reasonable period to be prescribed for up keep/maintenance of the roads and drains by the owners/ developers.

Wherever layouts develop at a slow pace, the maintenance period shall be extended till 60% of the plots developed in the layout or 5 years whichever is later.

(b) Other than Municipal/ Corporation areas: Shall collect the necessary fees and issue the final layout sketch, permit of planning authority along with the permit of local body to the applicant (s) directly, only after ensuring that the applicant lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT, provide necessary street lights etc., as per the standards specified by the local body.

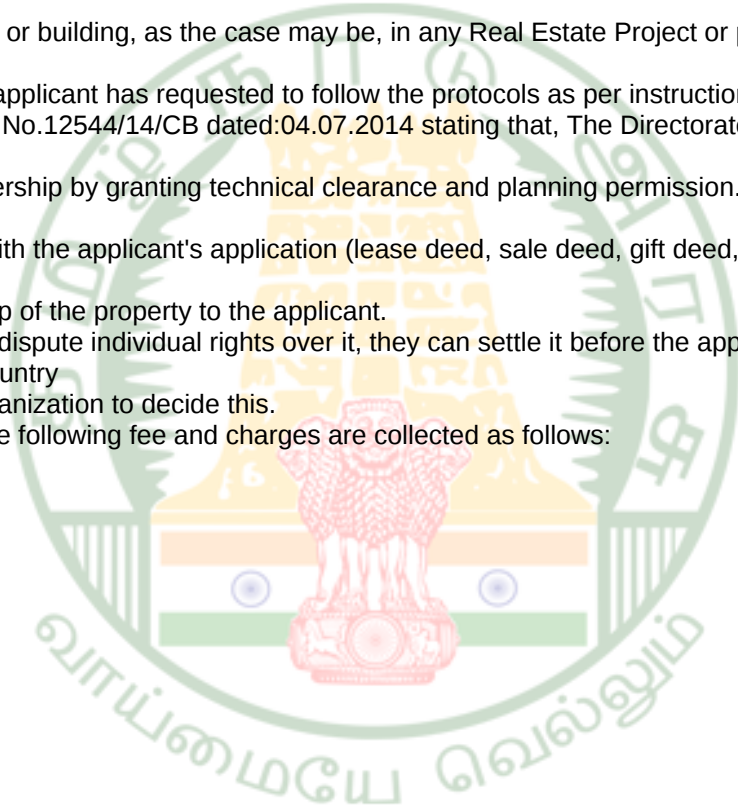
2. With reference to the 8th cited and 9th cited letter, the concern local body must issue the final approval After transfer of earmarked road, local body area, TANGEDCO area S.F.No., sub-division in favour concern local body.

3. The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016, The promoter has to advertise, Market, book sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA.

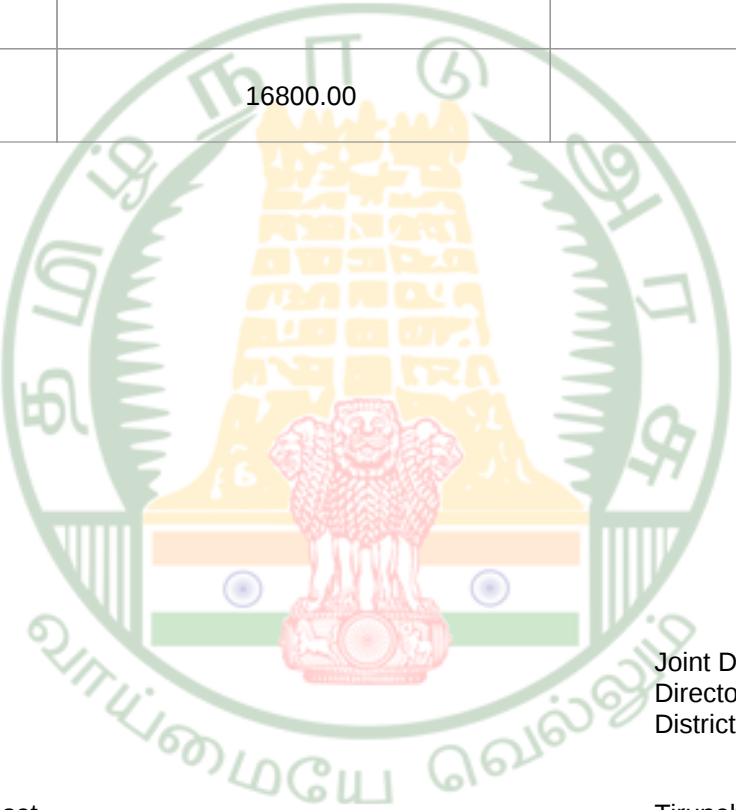
4. According to the Circular No.12544/14/CB dated:04.07.2014 stating that, The Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the applicant's entitlement to development is verified in the documents submitted with the applicant's application (lease deed, sale deed, gift deed, etc.) Any person wishing to purchase the property must individually assert ownership of the property to the applicant.

Also, if anyone else arises/ dispute individual rights over it, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning is not the right organization to decide this.
