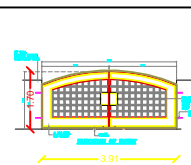
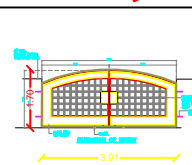
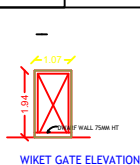
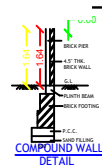


SITE PLAN

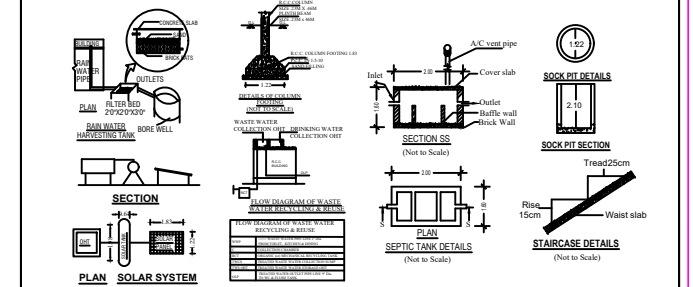
