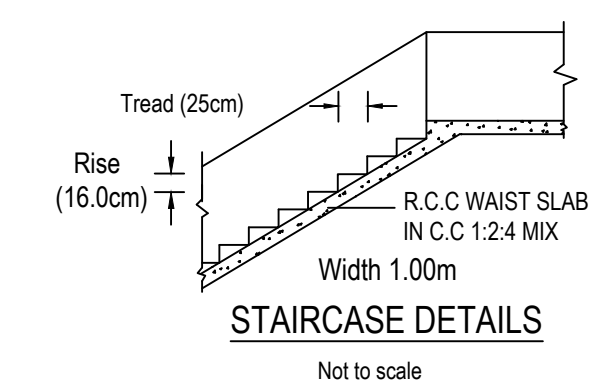


FIRST FLOOR PLAN

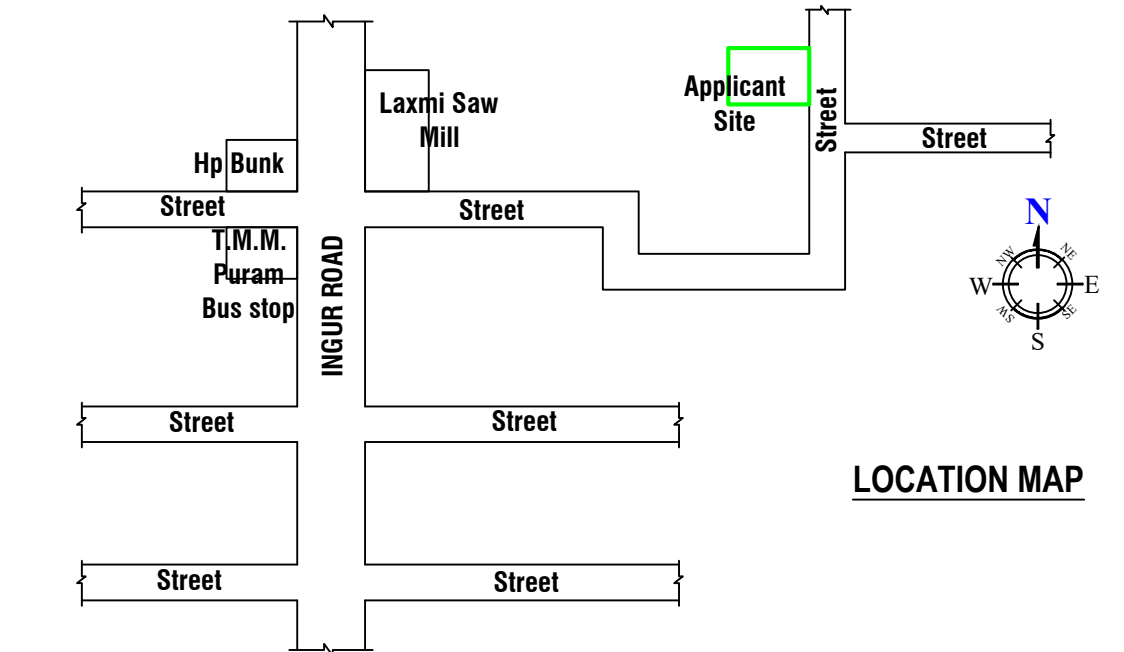
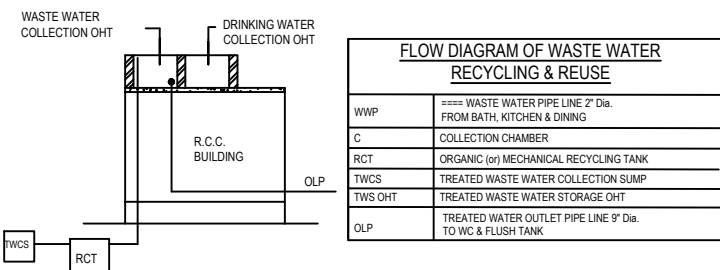
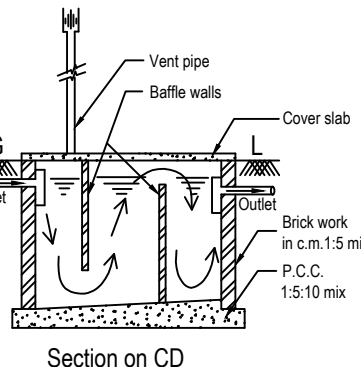
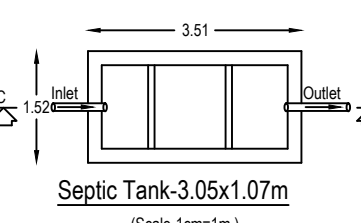
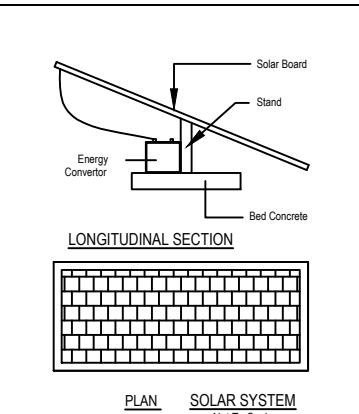
