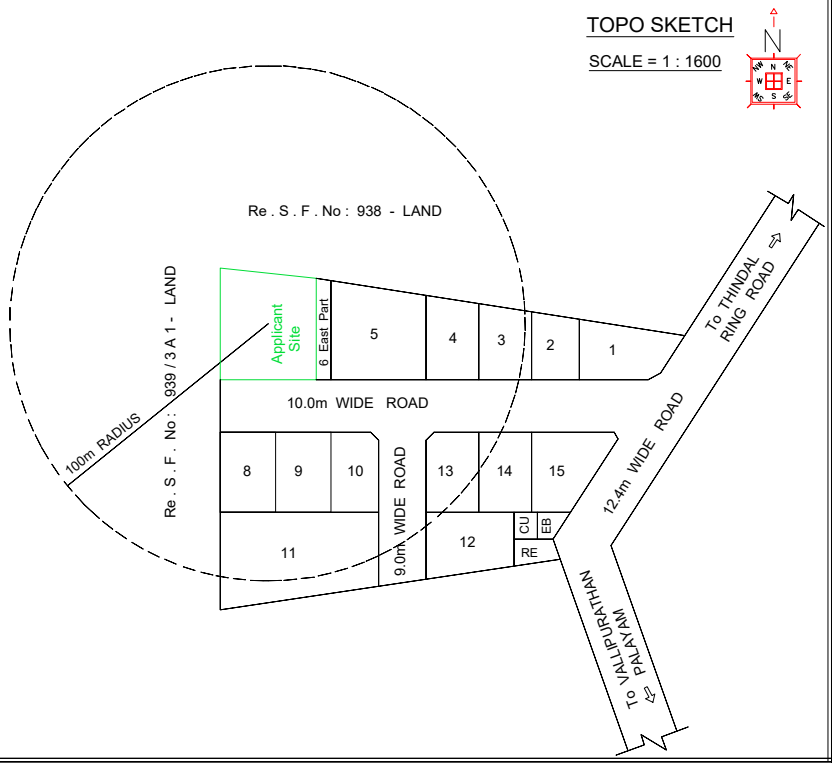
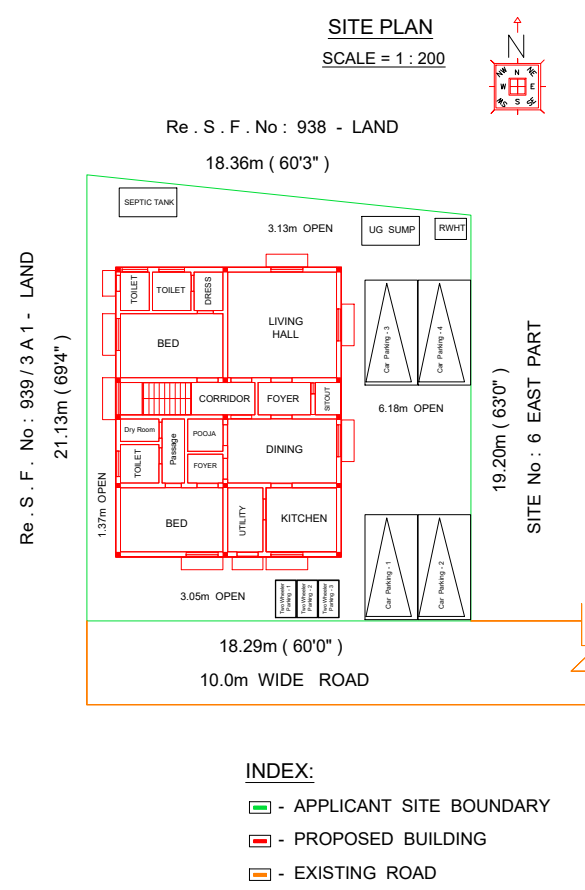
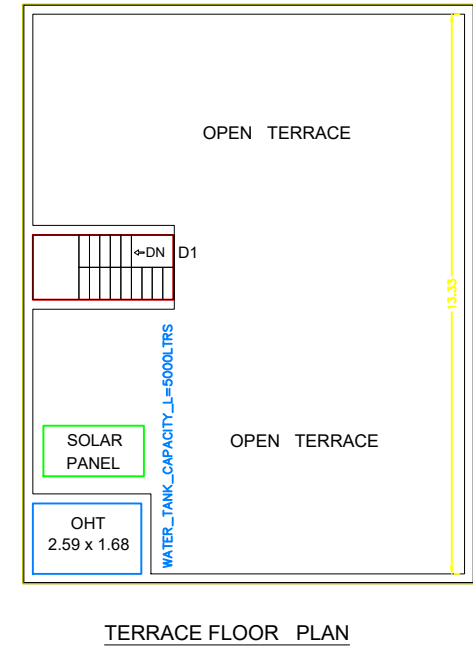
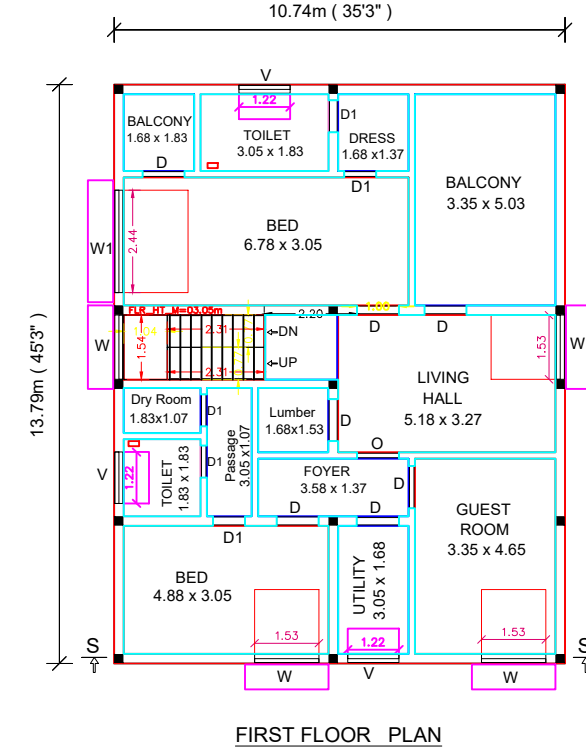
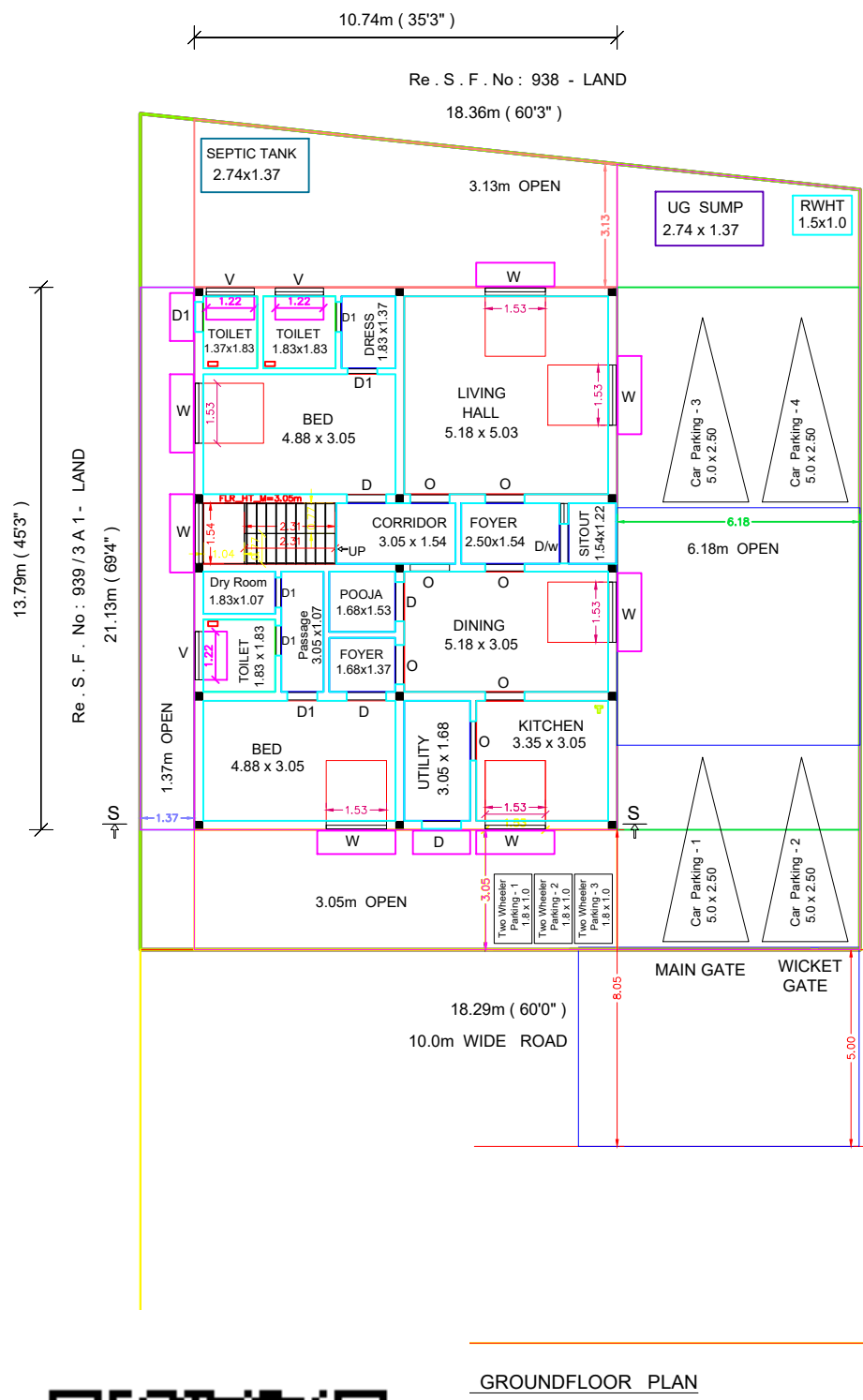
PLAN SHOWING THE PROPOSED CONSTRUCTION OF R.C.C ROOF
