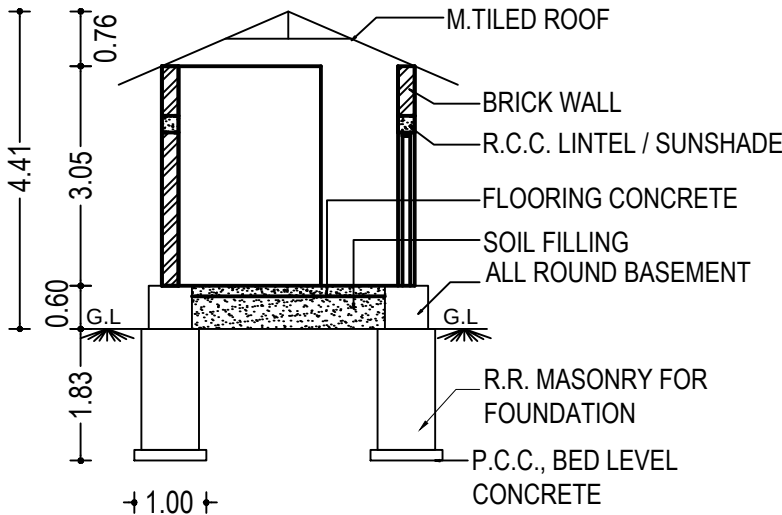

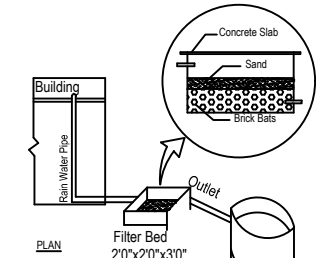

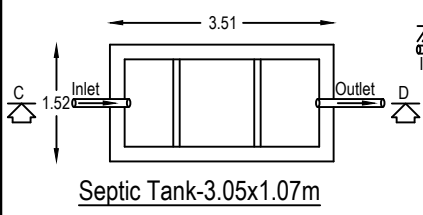

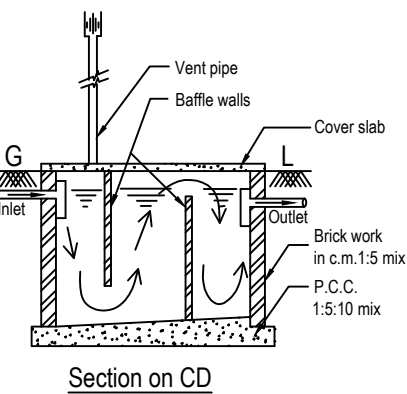
PLAN SOLAR SYSTEM



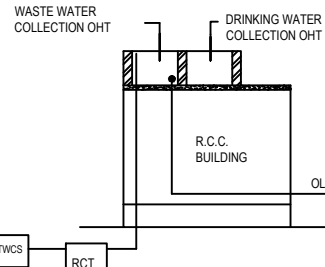

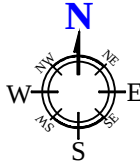

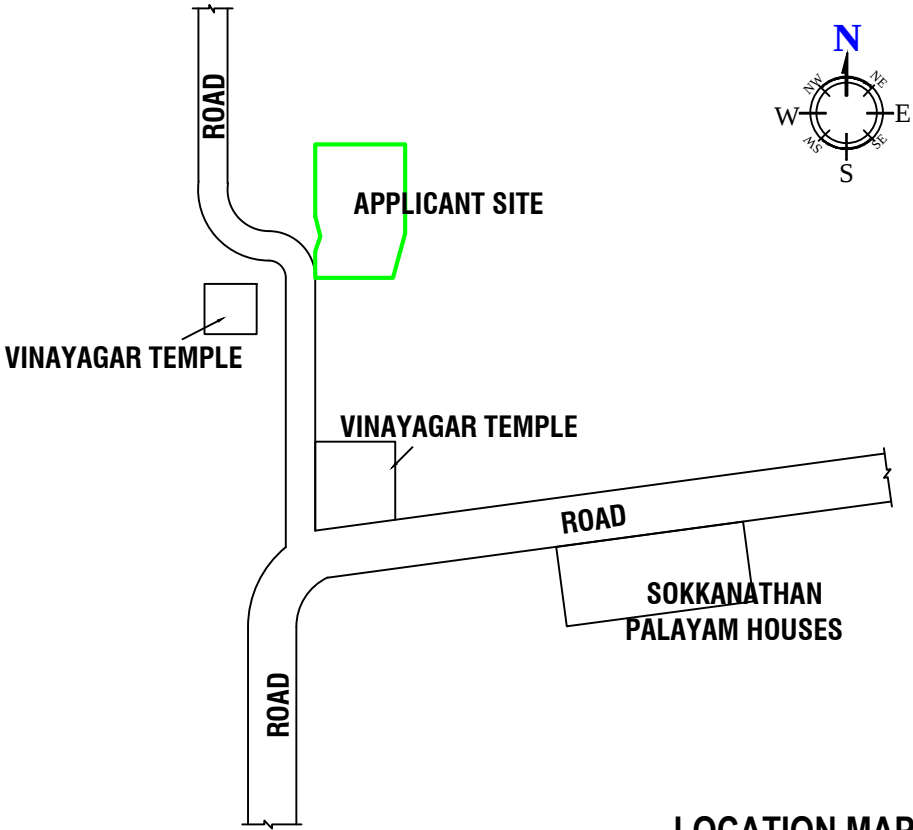
