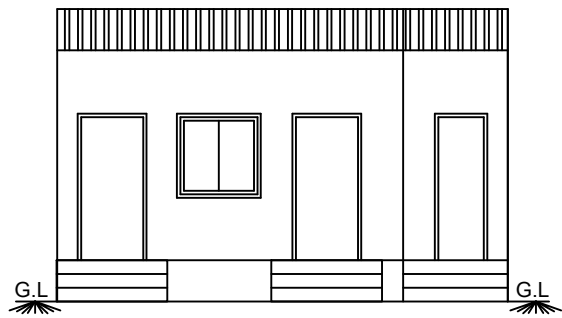

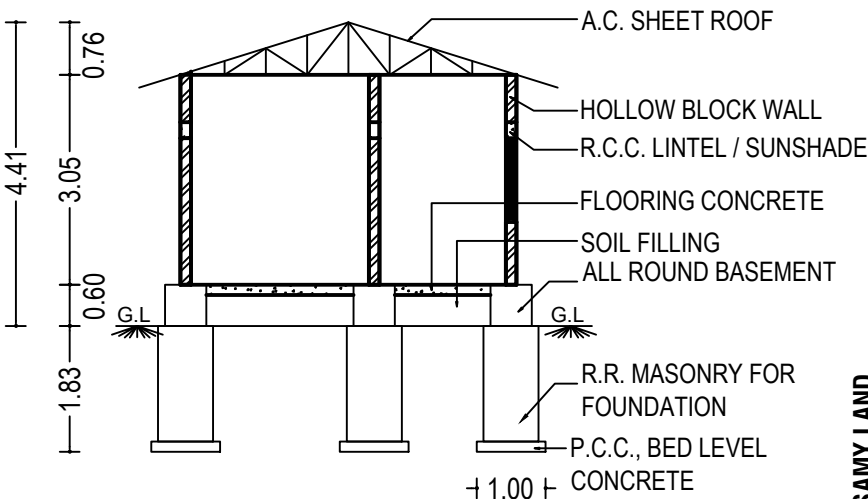
PLAN SHOWING THE PROPOSED CONSTRUCTION OF A.C. SHEET ROOF RESIDENTIAL BUILDING IN

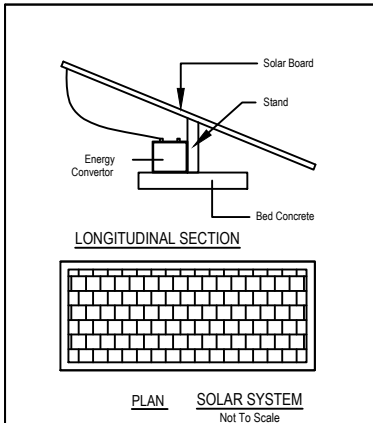

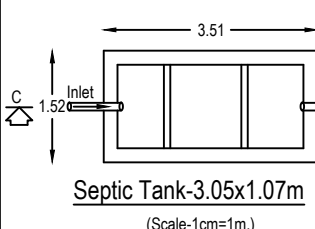

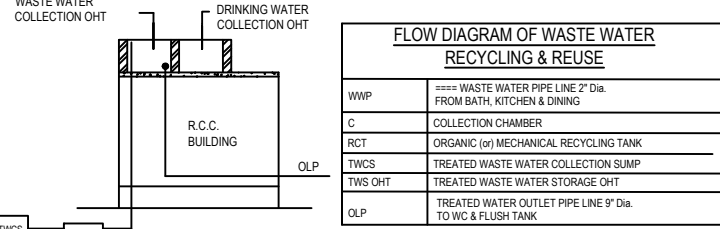
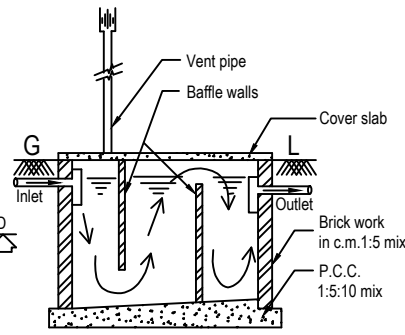
PLAN SOLAR SYSTEM

Rain Water Harvesting Tank

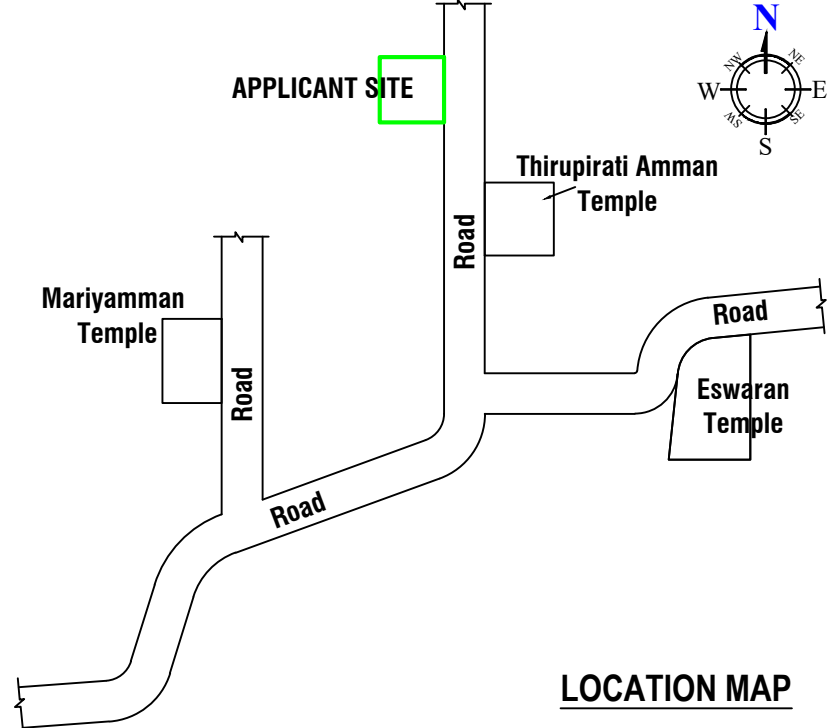
