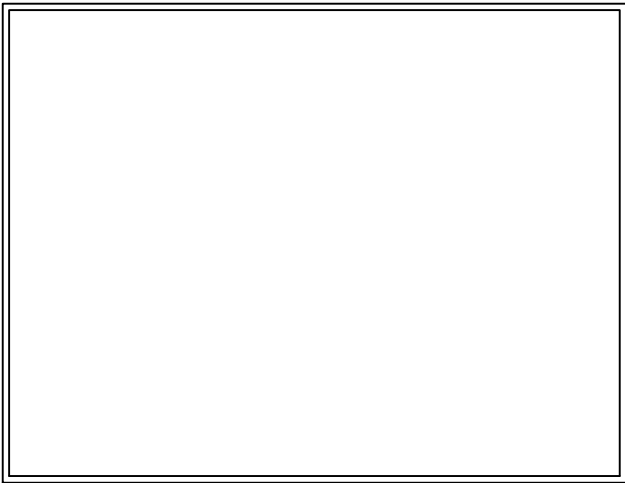

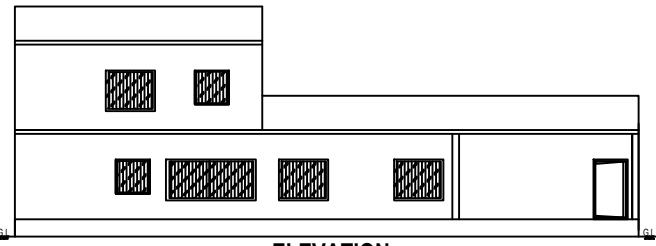

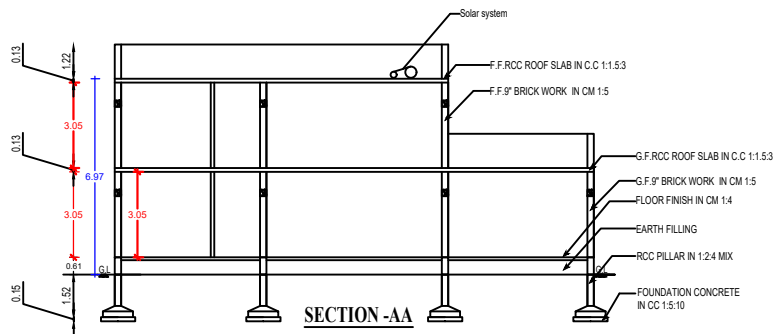
TERRACE FLOOR PLAN



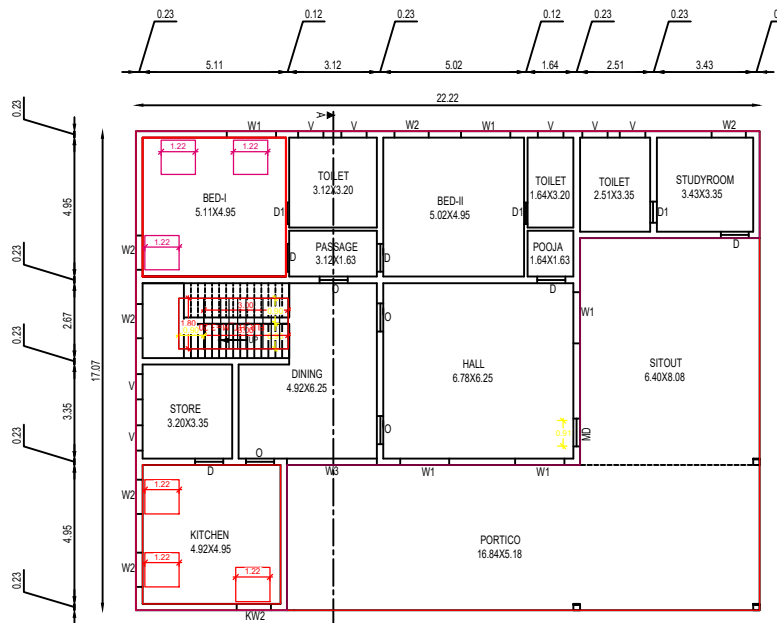

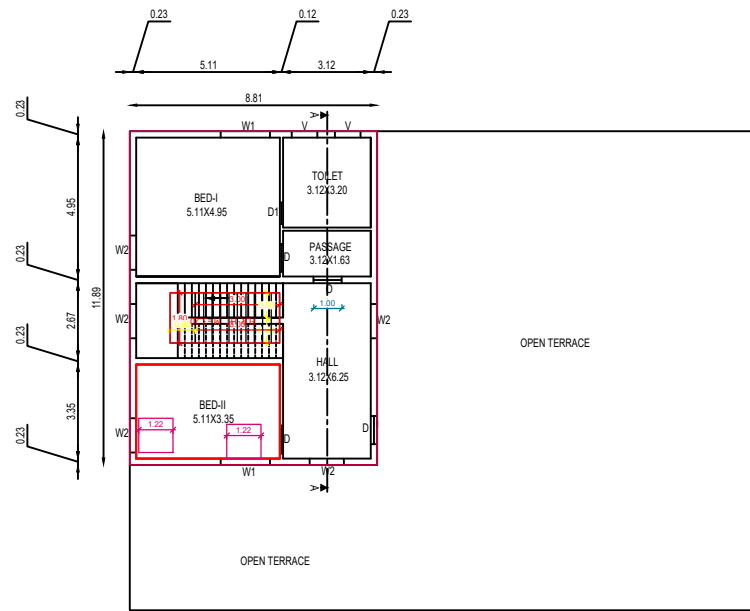
