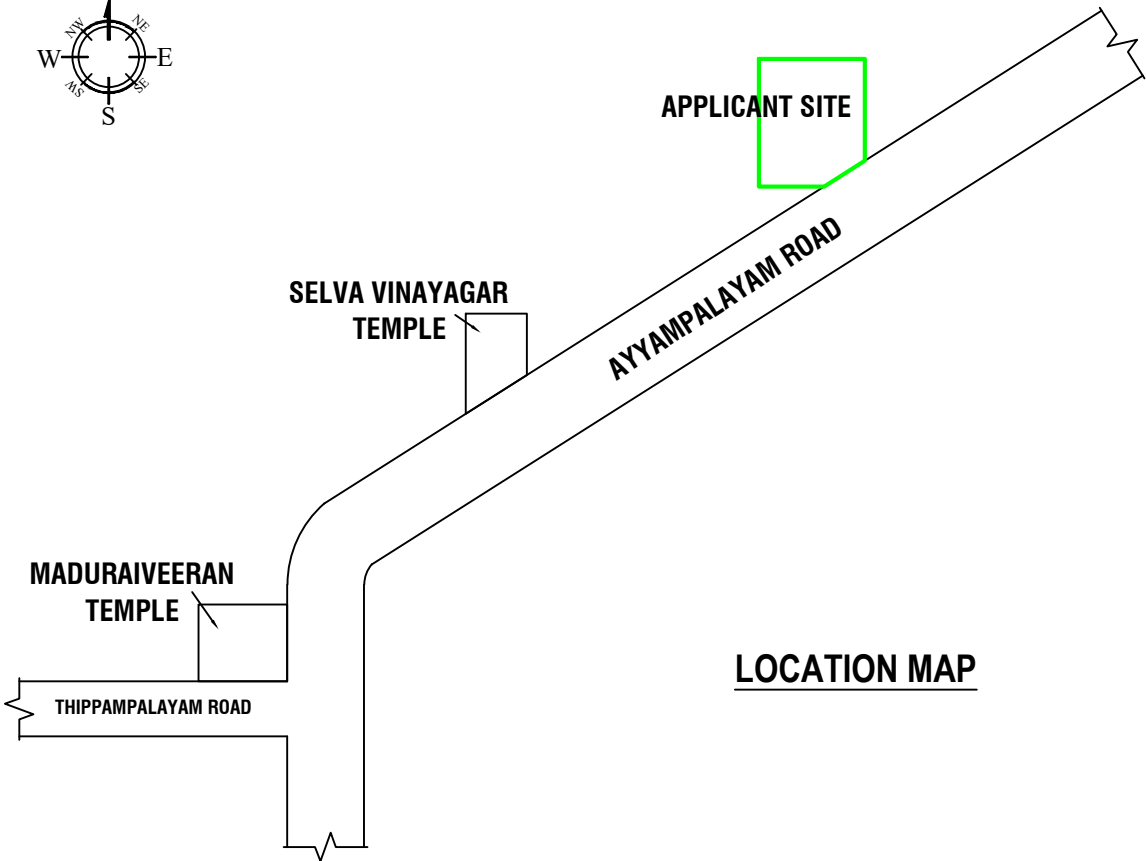
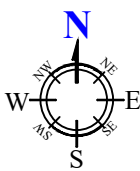
PLAN SHOWING THE PROPOSED CONSTRUCTION OF G.I. SHEET ROOF RESIDENTIAL BUILDING IN
