Order

With reference to the 1st cited letter, the applicant The Chairman, The Bhavani Educational Service Trust, Erode, has requested approval for a Nursing college Building at Erode District, Bhavani Taluk, Periyapuliur Panchayat and Village, in S.F.No.416/8B, with a site extent of 20241.64 Sq.m. The proposal includes additional construction with a total FSI area of 5082.99 Sq.m.

With reference to the 3rd cited letter, the site boundary and the Main Block (Ground Floor and First Floor plan) were already approved by the Deputy Director, Salem Regional Office, vide Roc.No.3126/2013/சே.ம3, dated 19.02.2014 and ம.வ/ம(சே) எண்:17/2014, dated 19.02.2014, wherein the site boundary was marked as "A to H."

In that same site revised and additional construction of the Nursing College were recommended based on the site inspection remarks of the Assistant Director / Deputy Director (i/c), Erode District Town and Country Planning Office. The Technical Concurrence for the above proposal has been issued under Section 47(A) of the Tamil Nadu Town and Country Planning Act, 1971, and numbered as **B.P./DTCP No.68/2026**.

In Continuation, on the receipt of requisite charges vide reference to the 17th cited above, the site approval is being issued to the above proposed building plan and numbered as **SWP/DTCP/ERODE /Building Permission No.20/2026**

2. The area statement for the revised and additional institutional building is given below.

The Technical Clearance issued with the following Special and General Conditions: -

Special Conditions

1. The OSR area measuring 2154.00 Sq.m., shown as points '1 to 5' in the site plan, shall be retained as Open Space Reservation in accordance with Rule 41(1), Explanation (i) of the Tamil Nadu Combined Development and Building Rules, 2019
2. As indicated in the site plan, the specified areas shall be demolished prior to the issuance of Technical Approval from Erode District Town and Country Planning Office.
3. The conditions imposed in the Fire NOC in the 14th cited reference shall be followed scrupulously.
4. It is responsibility of the builders to ensure safe bearing capacity of the soil and adequacy of the foundation.
5. Conditions stipulated in the No Objection certificates obtained from the central and state Government Departments must be fulfilled scrupulously.
6. Planning Permission is issued in accordance with the provisions of the Town and Country Planning Act and the rules made there under and does not cover the structural stability aspects including the safety during the construction which are covered under the Building Rules under the Local Bodies Act. Planning Permission is issued subject to the condition that the applicant/developer and also the architect/Licensed Surveyors and the Structural Engineer associated with the development shall ensure that developments shall be structurally sound and adequate safety measures are taken during the process of construction.
7. The Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Initial verification of the documents (lease deed, sale deed, gift deed, etc.,)

submitted by the applicant's is being verified for the applicant's entitlement to develop in the site.

If any person wishes to purchase the property must individually ascertain the ownership of the applicant's property. Also, if anyone else claims rights over the property, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide on this.

8. The provisions in the G.O (Ms) No.17, Housing and Urban Development (UD4 (3)) Department dated: 05.02.2016 relating to installation and use of solar energy system should be followed.

General Conditions:

1. Solar water heating system to be provided to the proposed Additional and Alteration construction of building. Solar photo voltaic panels to be erected at the 1/3 portion of total terrace area.
2. Parking area to be utilized only for parking purpose mentioned as per approved drawing.
3. No additions / alterations to be made without necessary permission of this office. In case any alterations required proper revised approval should be obtained.
4. Rain water harvesting should be provided as per the directions mentioned in G.O.18 & G.O.16 Department of Municipal Administration and Water Supply, Dated: 04.02.2019 & 31.01.2020.
5. Applicant should arrange to dispose sewage by vehicle at his own cost and necessary drinking water provision to be provided at applicant's own cost.
6. Mosquito netting to be provided at OHT and well.
7. Fire rescue equipment should be provided as per Rules.
8. As per GO No 341 MAWS dated 03.11.2004 "U" Trap in the septic tank design to be provided.
9. Fly Ash bricks and Materials must be used for construction.
10. As per G.O. No. 18, Department of Municipal Administration and Water Supply, dated.04.02.2019 a display board of size 60cm x 120 cm to be erected which shows site details, building details and municipality engineer details at the place of construction.
11. As per G.O.79 Housing and Urban Development Department, dated: 04.05.2017, in- case of non-planned area rule 3 - it has been requested to collect Rs.1000 as scrutiny fee for each plots. And under rule 9 - concerned local body should collect the 3% Market Land Value as Land conversation charges, before issuing the final approval
