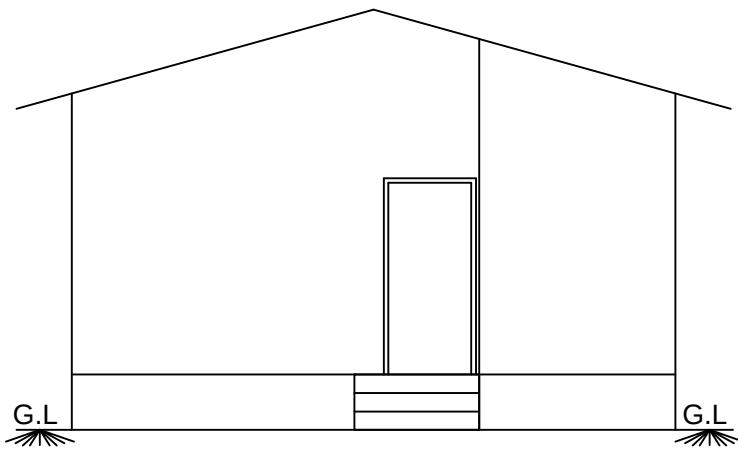

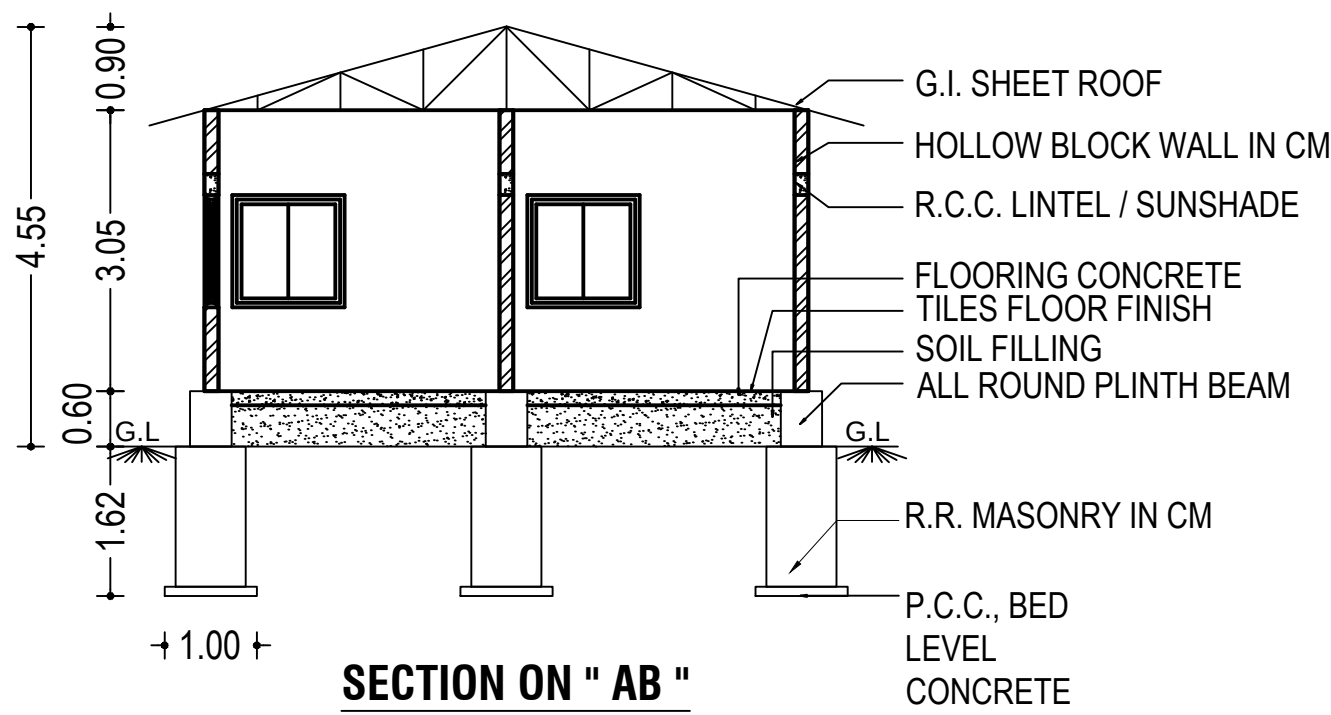

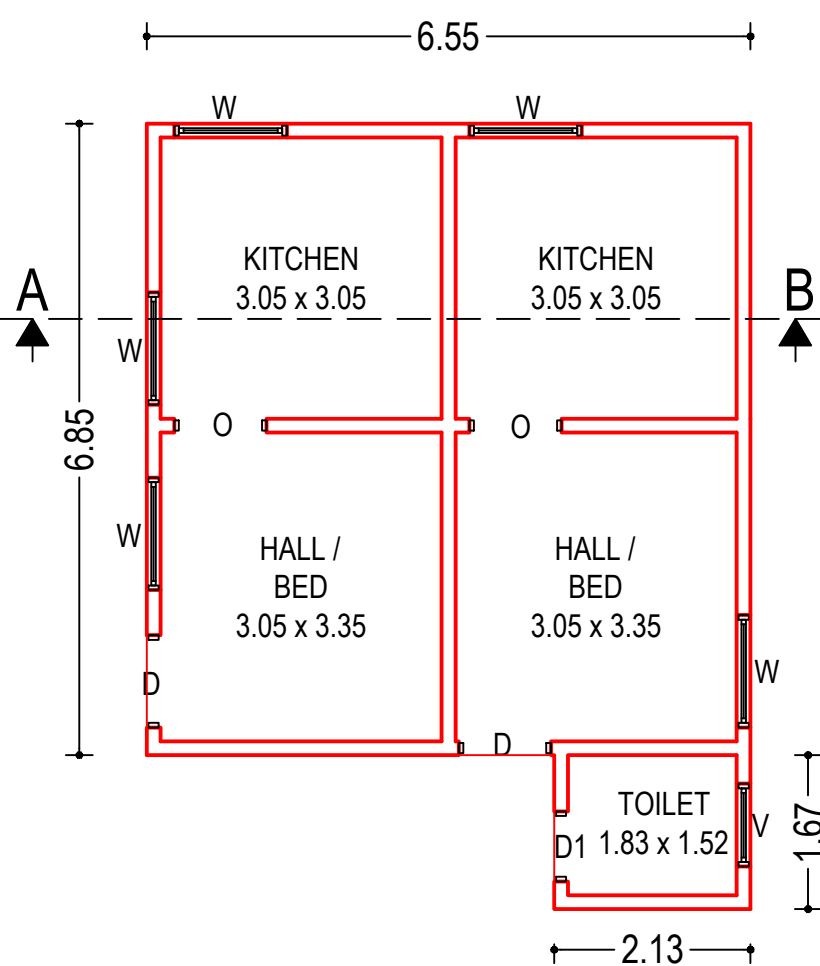

ELEVATION

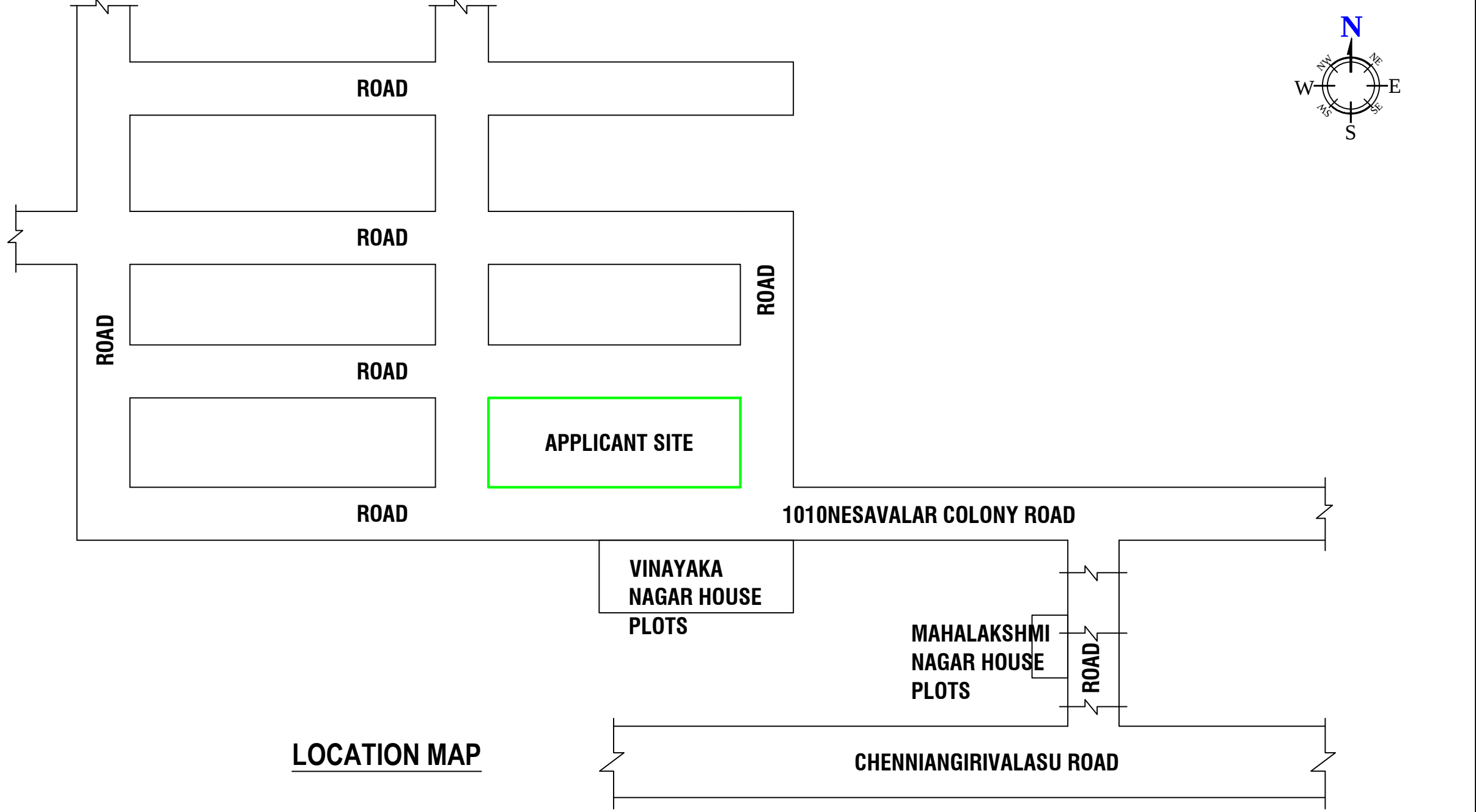

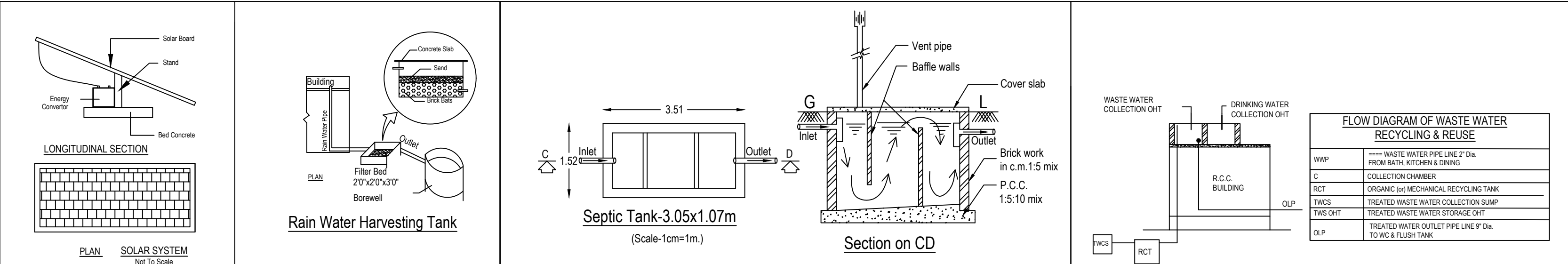
