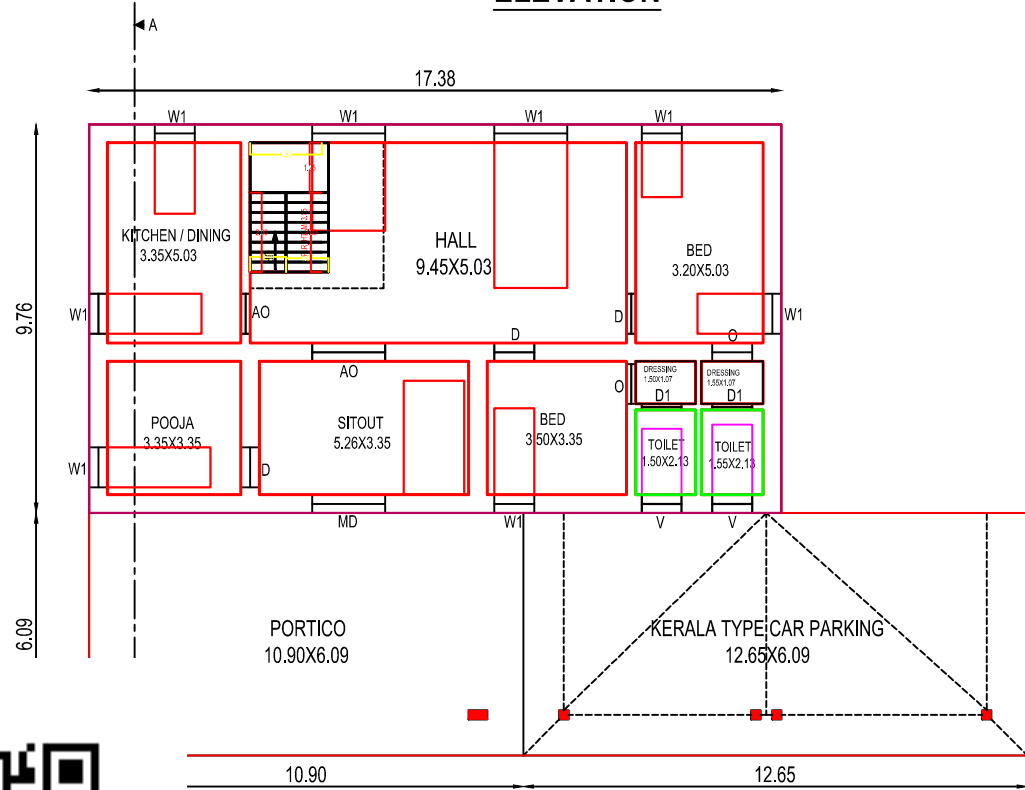

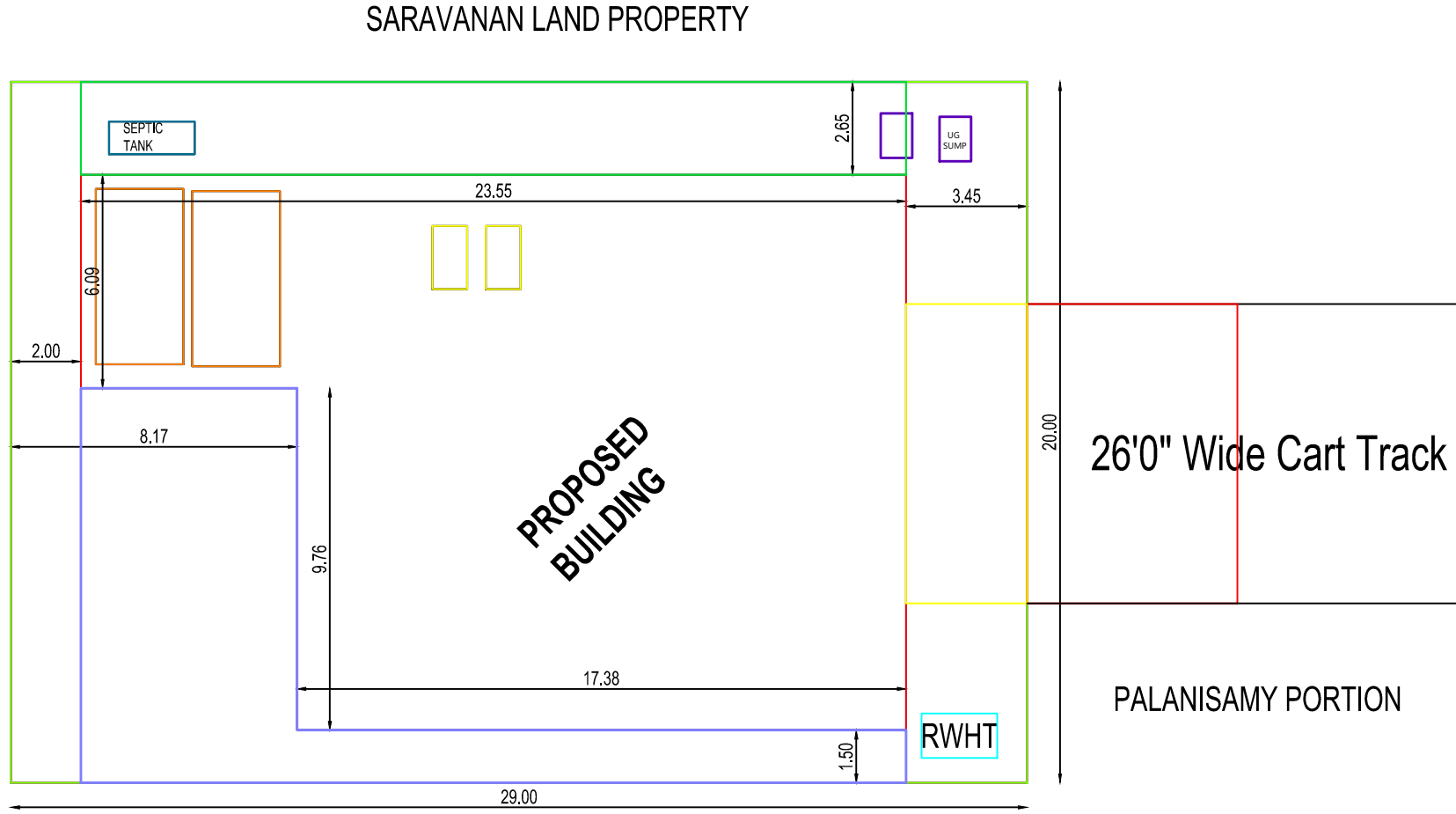

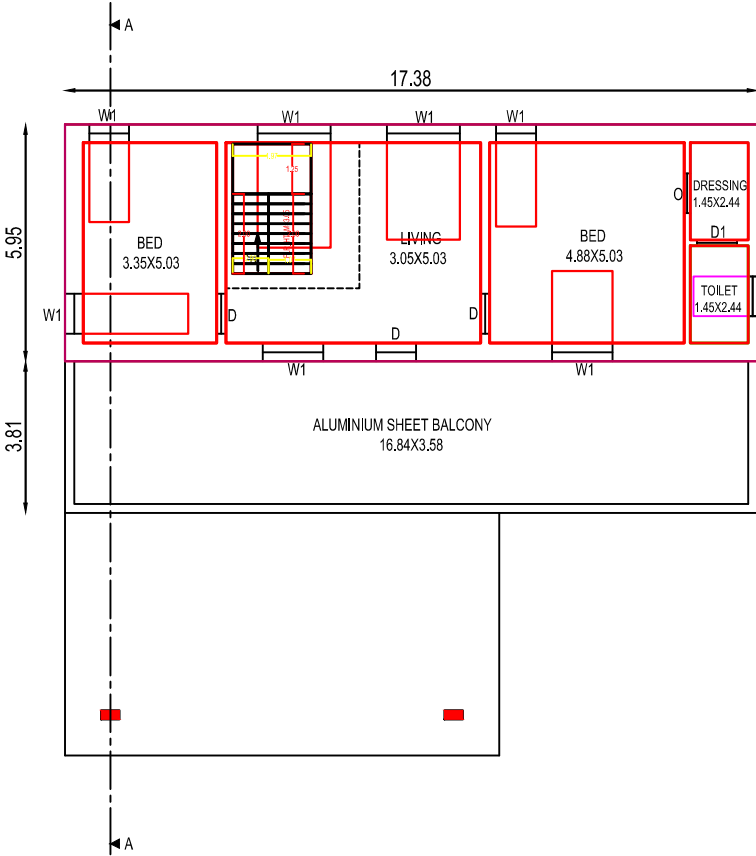


GROUND FLOOR PLAN
(Scale : 1:100)

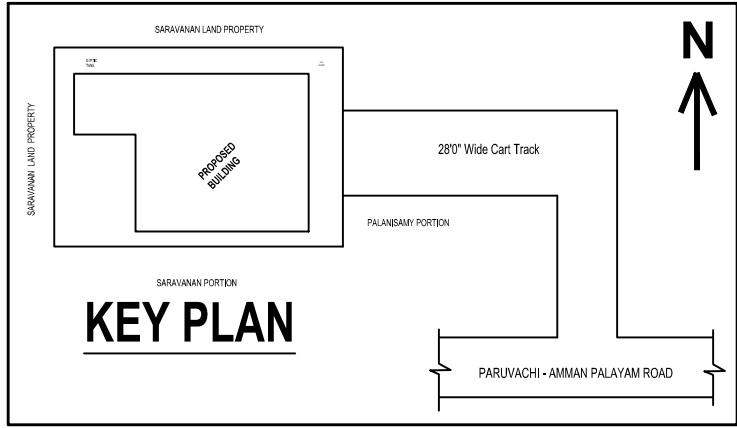
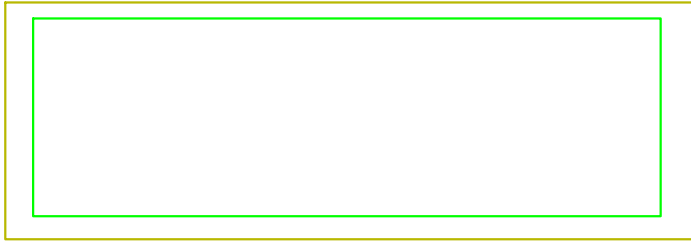


SITE PLAN
(Scale : 1:100)

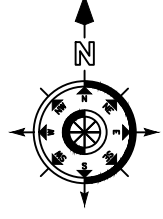
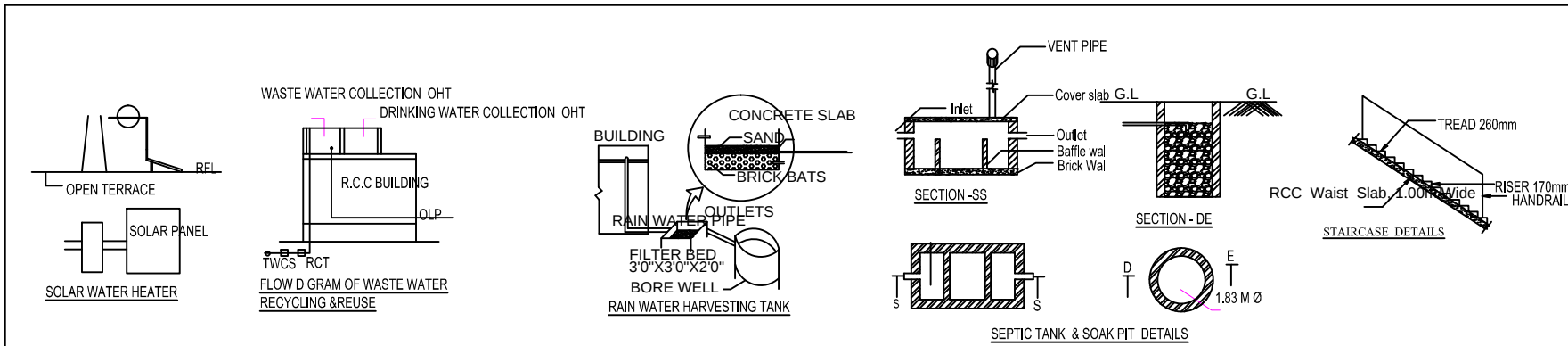
