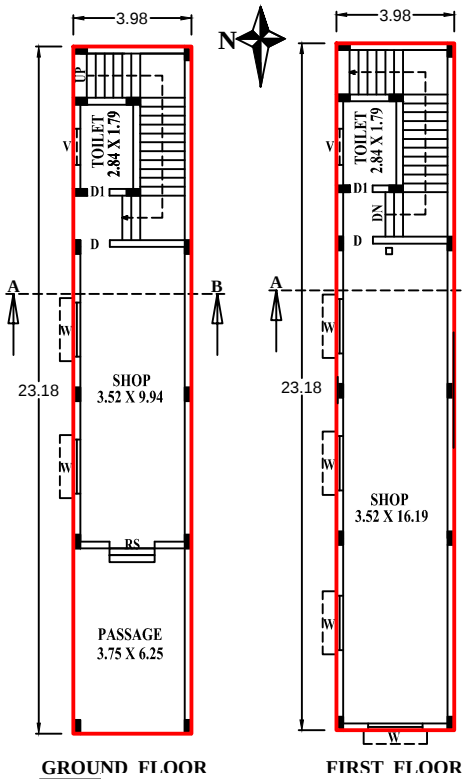

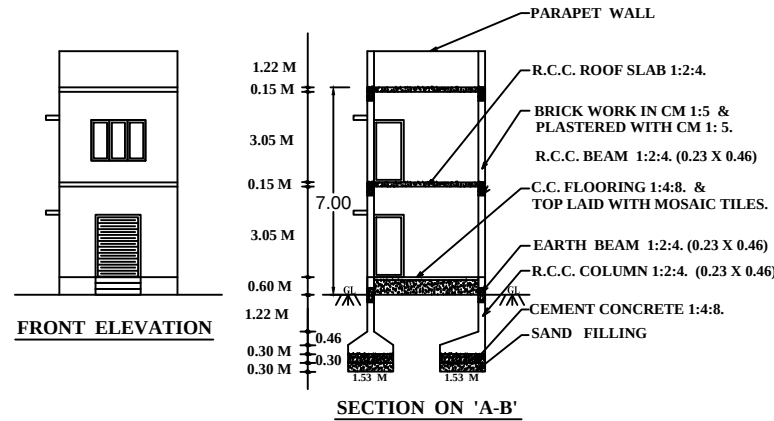

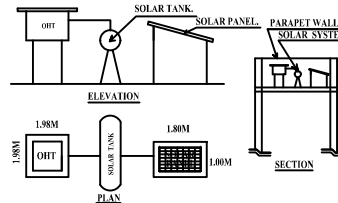
#### STAIRCASE DETAILS (NTS)



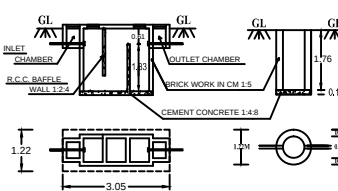

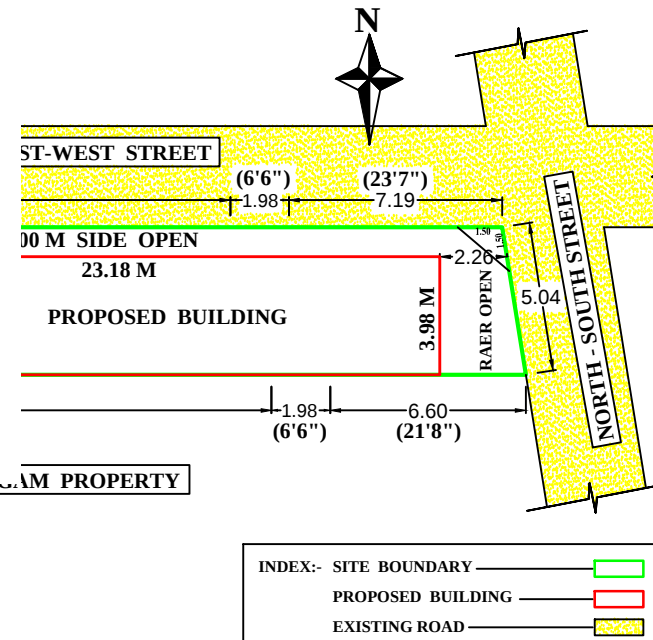
