PERUNDURAI TALUK, ERODE DISTRICT.

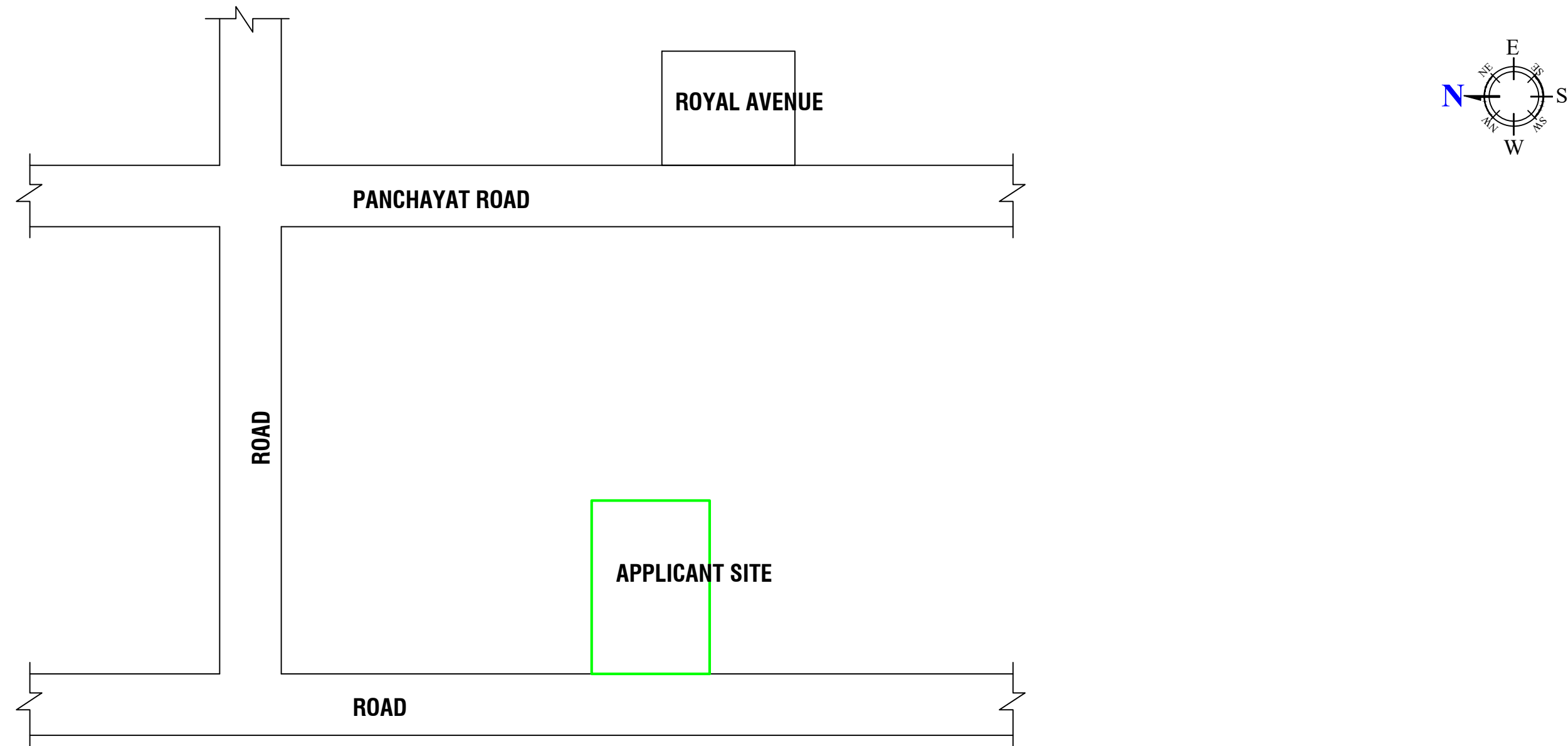

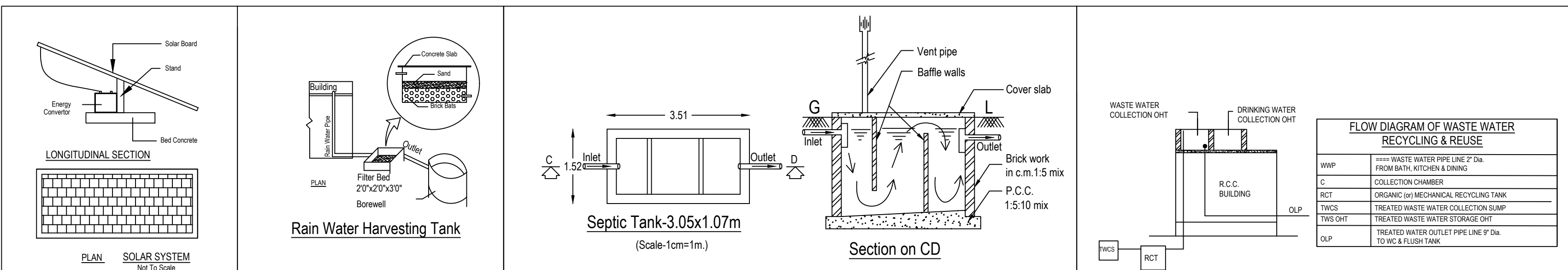
