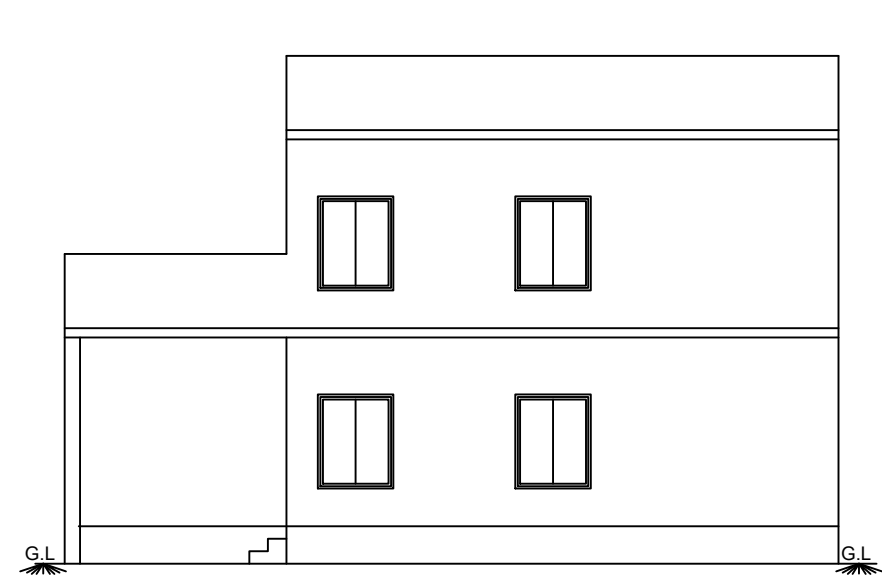

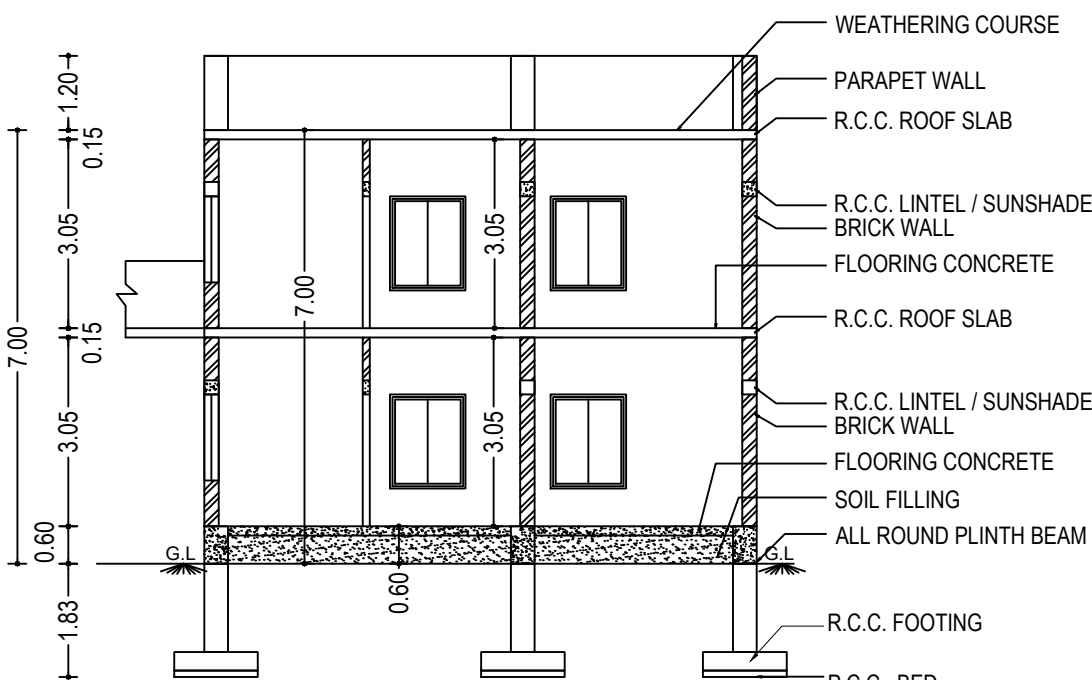
PLAN SHOWING THE PROPOSED CONSTRUCTION OF R.C.C. ROOF GROUND & FIRST FLOOR

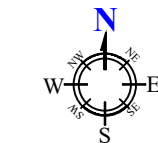

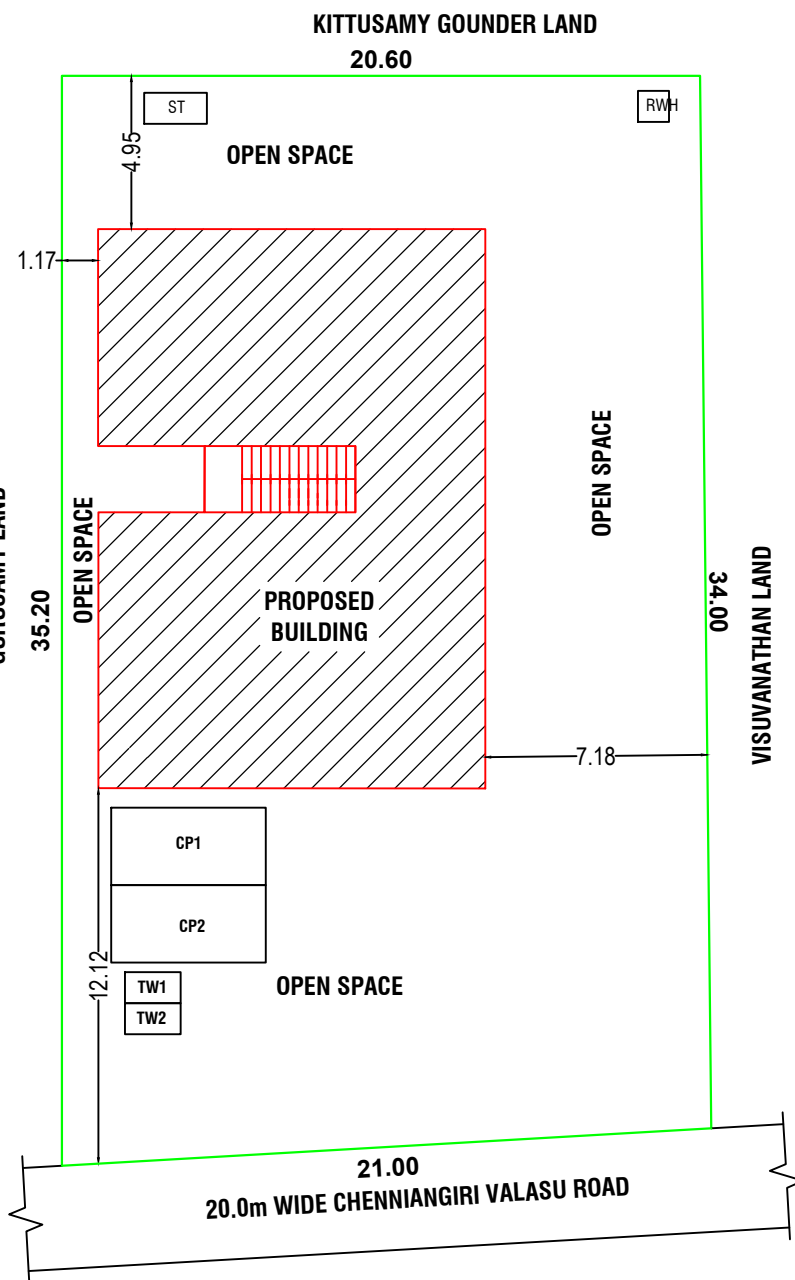

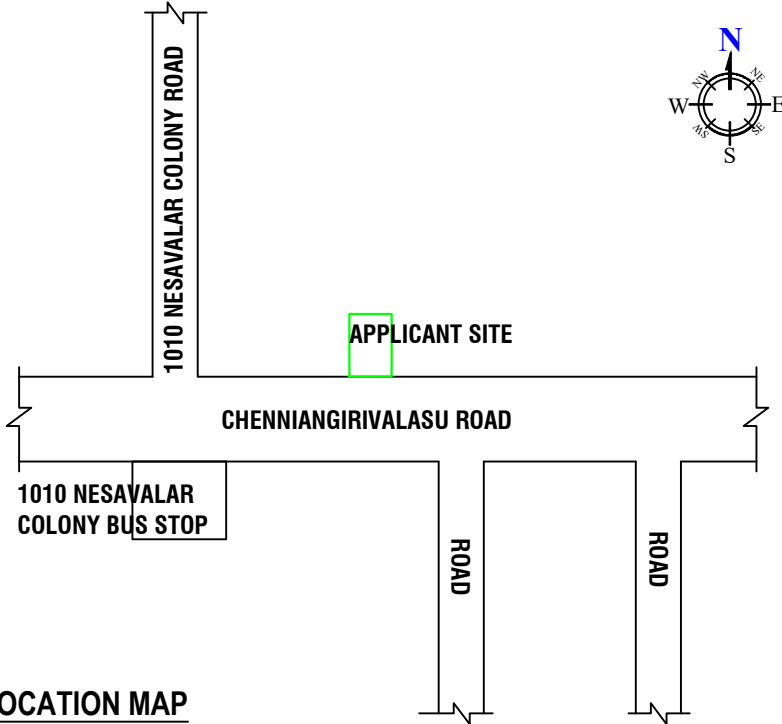
FIRST FLOOR PLAN

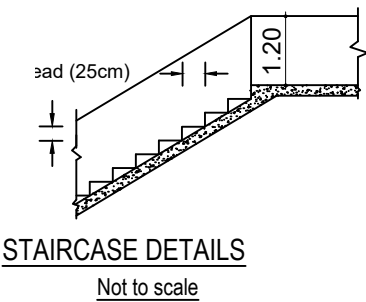

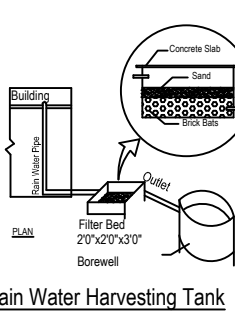

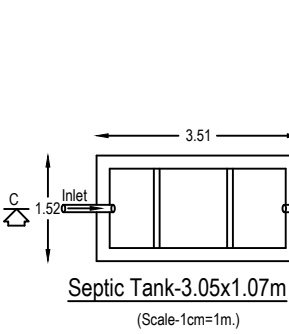
STAIRCASE DETAILS

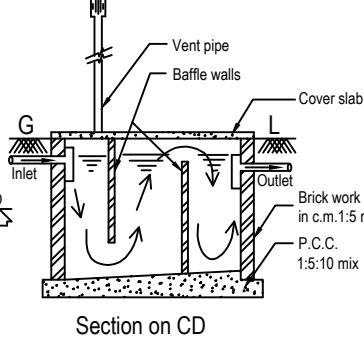
PLAN SOLAR SYSTEM

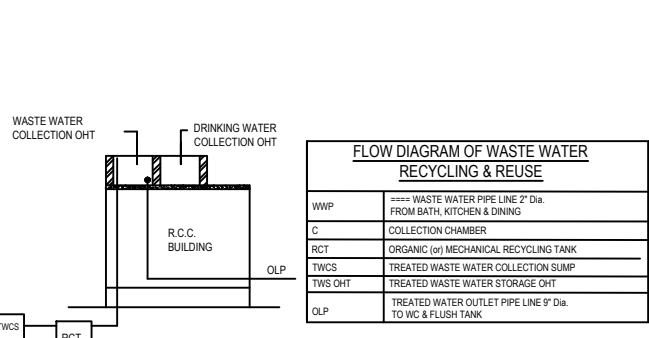
Rain Water Harvesting Tank
