With reference to the 1st Cited letter, the applicant has requested for the approval of the existing and proposed additional construction of the RCC Roof of School Building in S.F.No S.F.No.64/1 at Measuring to an extent of 18423.00 Sq.m with an FSI Area 2960.03 Sq.m in Chikkarasampalayam Panchayat, Pattavarthi Ayyampalayam Village, Sathyamangalam Taluk, Erode District. For the above-mentioned same site, regularisation approval has been accorded for a built-up area of 739.57 sq.m, as per Government Order (G.O.) No. 76, vide the proceedings of the Director of Town and Country Planning, Chennai, in Letter No. 6668/2023/TCP3, dated 21.06.2023.

On the receipt of requisite charges vide reference 17th cited above, the site approval is issued to the above proposed site has been marked as "A to E" and numbered as **SWP/DTCP/ERODE/Site Approval No. 208/2026** and The Technical Clearance is issued under section 47A of Town and country planning Act, 1971 for the above proposal and numbered as **SWP/DTCP/ERODE/Building Permission No. 56/2026**.

The Technical Clearance issued with the following Special and General Conditions: –

Special Conditions:

1. The OSR 1 to 4 area 1992.90 sq.m., shown in the site plan should be retained as open space reservation as per Explanation (i) of TNCD BR 2019 rule 41(1)
2. It is responsibility of the builders to ensure safe bearing capacity of the soil and adequacy of the foundation

3. Conditions stipulated in the No Objection certificates obtained from the central and state Government Departments must be fulfilled scrupulously.
4. Building Permission is issued in accordance with the provisions of the Town and Country Planning Act and the rules made there under and does not cover the structural stability aspects including the safety during the construction which are covered under the Building Rules under the Local Bodies Act. Planning Permission is issued subject to the condition that the applicant/developer and also the architect/Licensed Surveyors and the Structural Engineer associated with the development shall ensure that developments shall be structurally sound and adequate safety measures are taken during the process of construction.
5. Applicant should obtain consent from Tamil Nadu Pollution control Board under Section 25 of the Water Act 1974 for discharge of sewage.
6. The Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Initial verification of the documents (lease deed, sale deed, gift deed, etc) submitted by the applicant's is being verified for the applicant's entitlement to develop in the site.

If any person wishes to purchase the property must individually ascertain the ownership of the applicant's property. Also, if anyone else claims rights over the property, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide on this.
7. The provisions in the G.O (Ms) No.17, Housing and Urban Development (UD4(3)) Department dated: 05.02.2016 relating to installation and use of solar energy system should be followed.
8. If any court case would be pending with reference to this proposal, the Technical Concurrence would be treated as INVALID.
9. Building to be Used Strictly as per mentioned purpose in Approved Building Plan.

10. In addition, all the stipulated conditions mentioned in the various NOC obtained from relevant departments reference cited no. 14 and 15 should be followed.

General Conditions: –

1. The building permission issued in accordance with Tamil Nadu Town and Country Planning Act 1971 (Section 47A)
3. In case the documents submitted for approval found fake the Technical Concurrence would be cancelled without intimation to the applicant
4. Solar water heating system to be provided to the proposed building. Solar photo voltaic panels to be erected at the 1/3 portion of total terrace area.
5. Parking area to be utilized only for parking purpose mentioned as per approved drawing.
6. No additions / alterations to be made without necessary permission of this office. In case any alterations required proper revised approval should be obtained.
7. Rain water harvesting should be provided as per the directions mentioned in G.O.18 & G.O.16 Department of Municipal Administration and Water Supply, Dated: 04.02.2019&
8. Applicant should arrange to dispose sewage by vehicle at his own cost and necessary drinking water provision to be provided at applicant's own cost.
9. Mosquito netting to be provided at OHT and well.
10. Fire rescue equipment should be provided as per Rules.
11. As per GO No 341 MAWS dated 03.11.2004 "U" Trap in the septic tank design to be provided.
12. Fly Ash bricks and Materials must be used for construction.
13. As per G.O. No. 18, Department of Municipal Administration and Water Supply, dated.04.02.2019 a display board of size 60cm x 120 cm to be erected which shows site details, building details and municipality/BDO/UE engineer details at the place of construction.
14. Parking area to be utilized only for parking purpose mentioned as per approved drawing

15. Government Registered electrical Contractor must be employed for wiring works during construction
16. Seismic Resistance Procedure to be Follow
17. Provide Sufficient Fire Resistance and Fire equipment in proposed Building
18. Approved order and drawing copies to be handover to buyer by the owner by the time of sale
19. Enforcement action under section 56 & 57 of Tamil Nadu Town and Country Planning Act 1971 must be taken by the Local body if the construction is done with Additional/Deviation to be approved plan before Levy of the applicable Taxes
20. The Applicants/developer and also the architects/RE/Licensed Surveyors and the structural Engineer associated with the development shall ensure that developments shall be structurally sound and adequate safety measures are taken during the process of construction.
21. The installation of closed-circuit television units in Public Buildings shall be in accordance with Annexure XXI of TNCBR –2019 rules.
22. If the Building is located in an area other than planning area, the local authority shall also collect the Scrutiny fee Rs.1000/- per plot and 3% of market value of land as land use conversion charges before issuing the final approval as envisaged in Government Order under the reference 7th cited above. The payment of charges shall be made under the following Head of Account.
