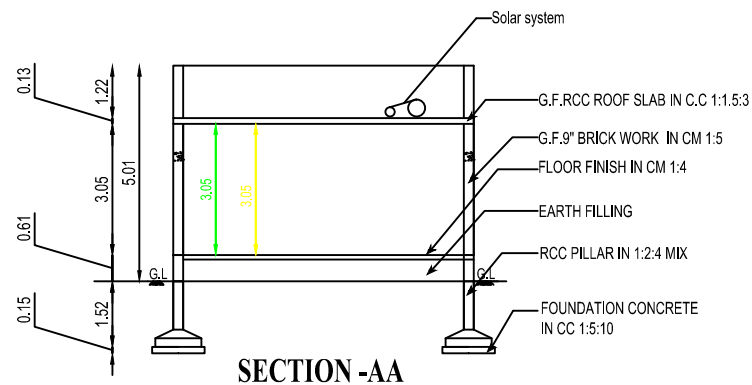

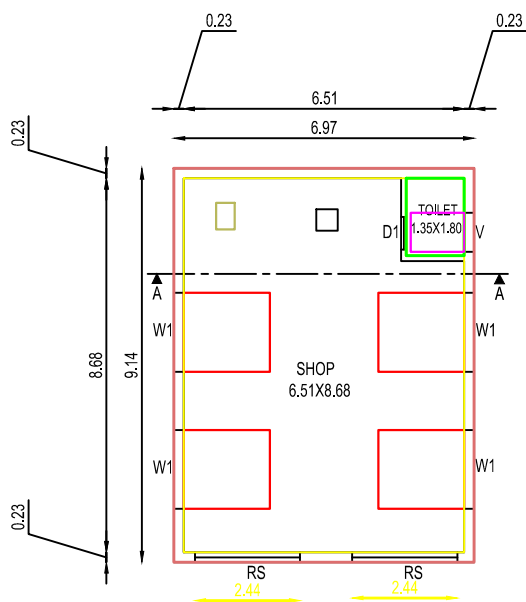

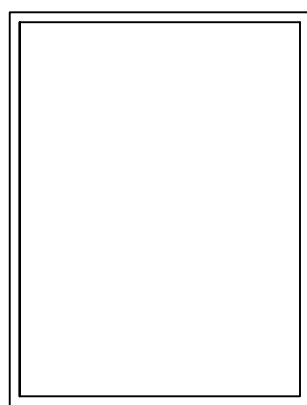

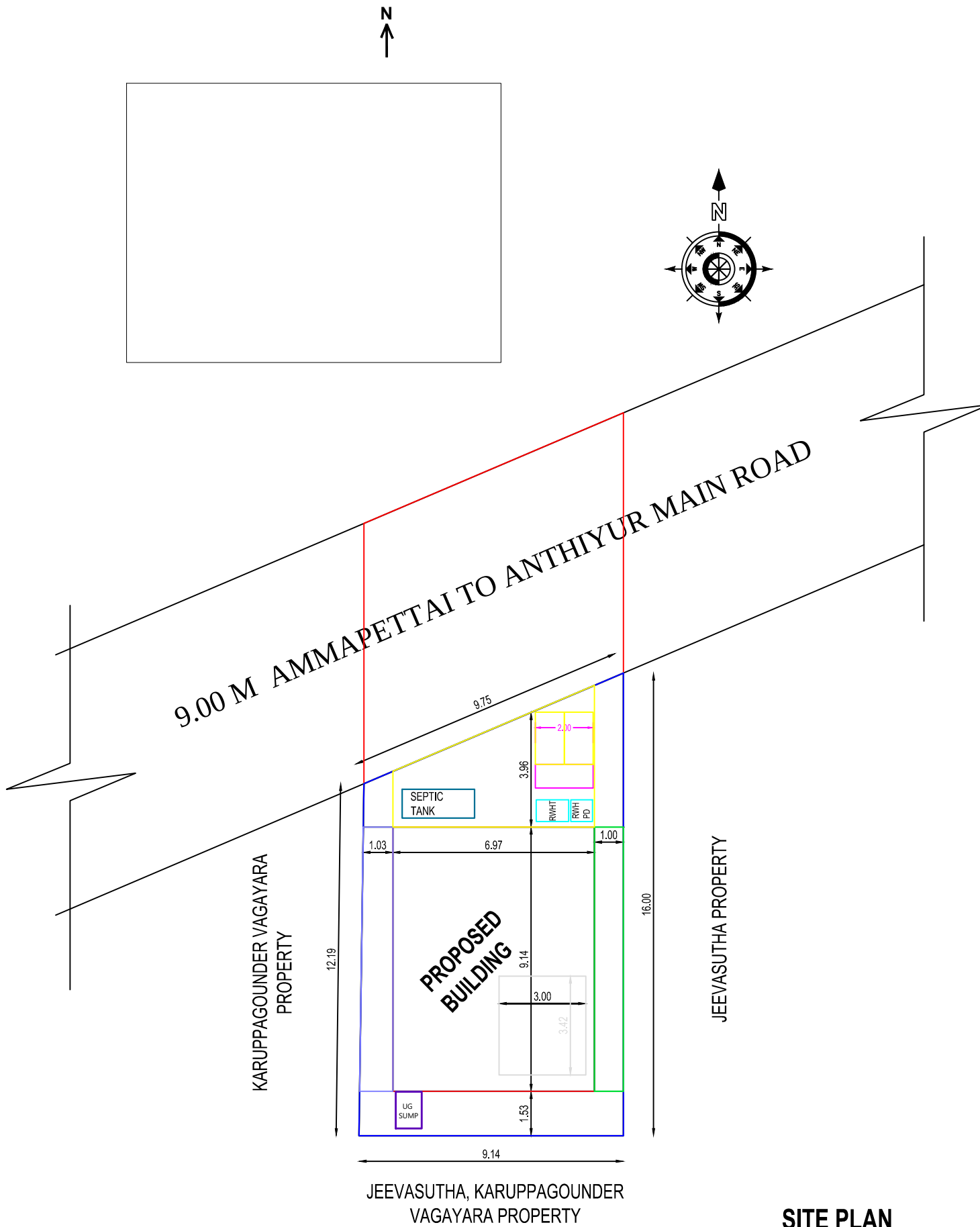
SECTION-AA

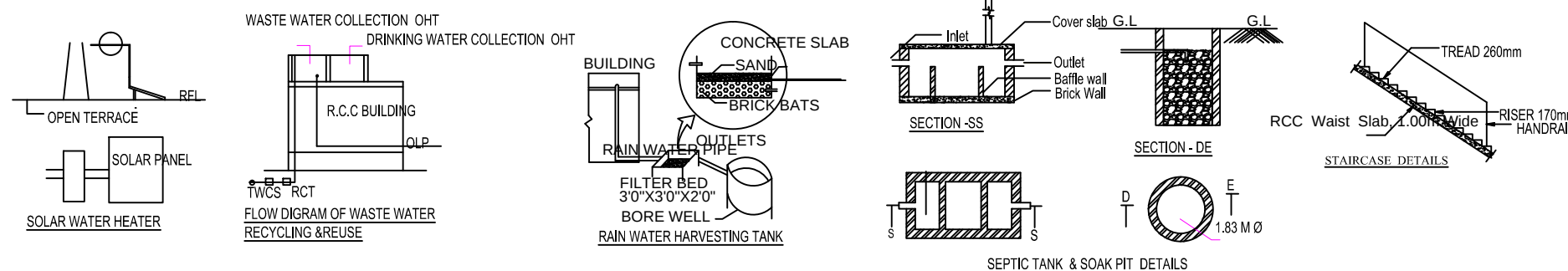
