ORDER:

The application seeking planning permission for the proposed formation of Residential layout extent of 15818.20 sq.m in the land Hosur Corporation, Chennathur village-Sf.no. 408/1, 410, 412/1, 413, 415, 416/1, 416/2, 417, 418/1, 2, 430/3pt, 433, 434/1, 2, 438/1B1, 2A, 2B1, 438/1B2, 1B3, 2B2, 439/1pt, 2, 3, 439/6pt, 442/1,2, 443/1,2, 447, 448, 449, 450/1, 2, 664/1A, 2A, 665/1, 670, 672, 678, 681/1, 2, 682/1pt, 2, 684, 696, 697, 698, 701, 702/2, 703, 704/2A, 2B2, 2C, 3A2, 3B, 705/2, 706/2, 783/1Apt, 783/1B, 783/3pt and Shoolagiri Panchayat Union, Perandapalli Panchayat, Moranapalli village S. F. Nos. 366/1, 367/1, 368/1, 369, 370/1, 2, 371, 380/1, 381, 382, 383, 384, 385/2, Extent of the layout- 441363.80 sq.m – of Krishnagiri District, was processed as per the prevailing rules and after perusing the records and after conducting site inspection, the applicant was directed to handover the portion of land earmarked for roads, public purposes meant for local body and TANGEDCO vide reference 13th cited above.

On receipt of gift deeds vide reference 14th cited above and on receipt of payment of charges such as Centage charges, Development charges and OSR charges vide reference 15th cited above, the technical clearance is issued to the mentioned layout subject to the following conditions.

The above Layout have been already approved vide order 16th cited above, numbered as L.P/H.N.T.D.A (K.D) No. 26/2019 & Planning Permission No. 16/2019 issued planning permission on 06.07.2020.

The Revised Technical Clearance is issued to the above mentioned layout and the number is assigned as L.P/ H.N.T.D.A(K.D) (SWP) No: 145/2026 and Revised Planning permission (SWP) NO 56/2026.

- 1) The local authority shall accord permission duly following the rules / regulations/ Orders issued from time to time under the respective acts.
- 2) The Local authority shall accord Final approval after collecting requisite fees / charges as applicable and the copy of the approval issued shall be forwarded to this office for record.
- 3) Also, the local authority shall forward the copy of such Final approval to the office of Sub registrar of Registration department and the office of the Assistant Director of Survey and land records concerned for information and for making mutation in their records.
- 4) Also, the local authority shall forward the copy of such Final approval to the Tahsildar concerned with a direction to the applicant to pay the requisite charges for making mutation in the Tamil Nilam / Collabland website.
- 5) The acknowledgement of receipt of proceedings and drawing shall be forwarded to this office through mail.

SPECIAL CONDITIONS:

- 1) This office has not legally certified the title to the ownership by granting the technical clearance and planning permission. Only the purchase the property must individually ascertain the ownership of the property of the developer / seller. If any dispute arises ownership, the same shall be settled through the appropriate forum. This office is not the appropriate authority to decide on this.
- 2) The owners / developers shall be allowed either to carry out Infrastructure development works as per the standards specified by the local body concerned or to pay the estimate cost to the local body. Concerned local body shall prescribe the standards for the provisions of basic infrastructure like roads, drains, water supply etc. for the layout, as per existing rules. Before taking over the Infrastructure developed by the owners/

developers, the local bodies shall ensure the quality of the works done by the owners/ developers Reasonable period to be prescribed for up keep / maintenance of the roads and drains by the owners / developers. Wherever layouts develop at a slow pace, the maintenance period shall be extended till 60% of the plots developed in the layout or 5 years whichever is later as envisaged under the directions issued by the Government Order vide references 5th, 7th, 8th and 12th cited above.

3) The local authority shall also ensure that the sub division for the land earmarked for road and land meant for public purposes such as Local body and TANGEDCO are properly carried out and transferred in favour of the local body / TANGEDCO concerned before issuing the final approval.

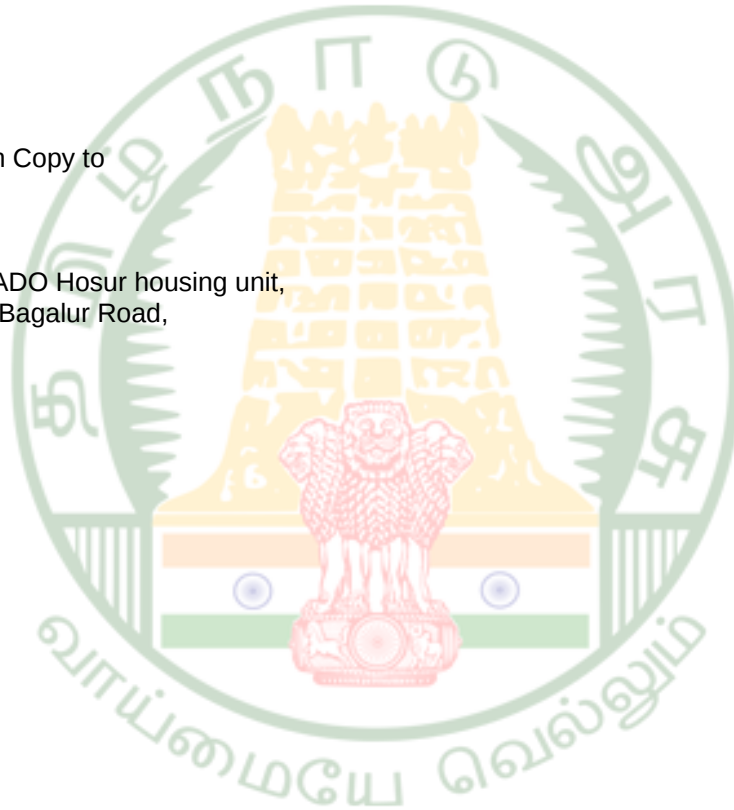
4) As envisaged under the "Tamil Nadu Real Estate (Regulation & Development) Act 2016, the promoter has to advertise, market, book, sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or Part of it only after registering the real Estate project with the Real Estate Authority. The applicant has to comply the said provisions.

5) Suitable setbacks (Construction Prohibited Area) to be provided as per Norms in where the plots Adjacent to water body/Channels.

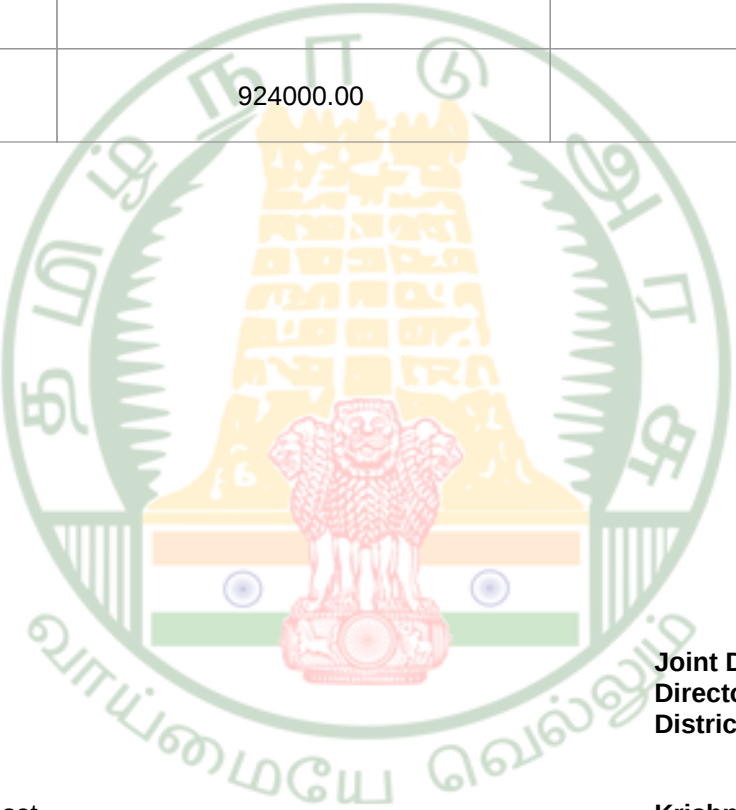
