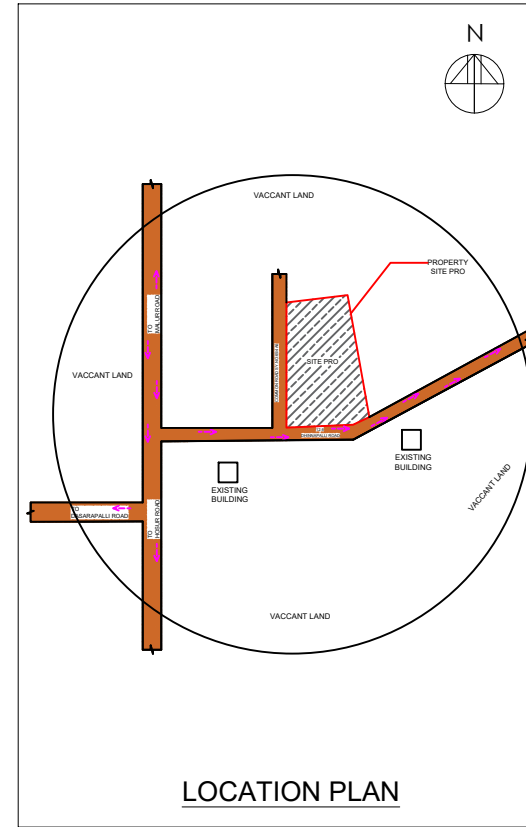

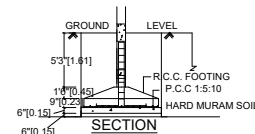
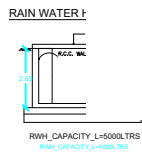
SECTION ON A-A



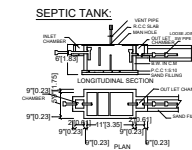
SITE PLAN



LOCATION PLAN

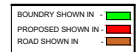
