planning authority along with the permit of local body to the applicant (s) directly, only after ensuring that the applicant

lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT,

provide necessary street lights etc., as per the standards specified by the local body

submitted with the applicant's

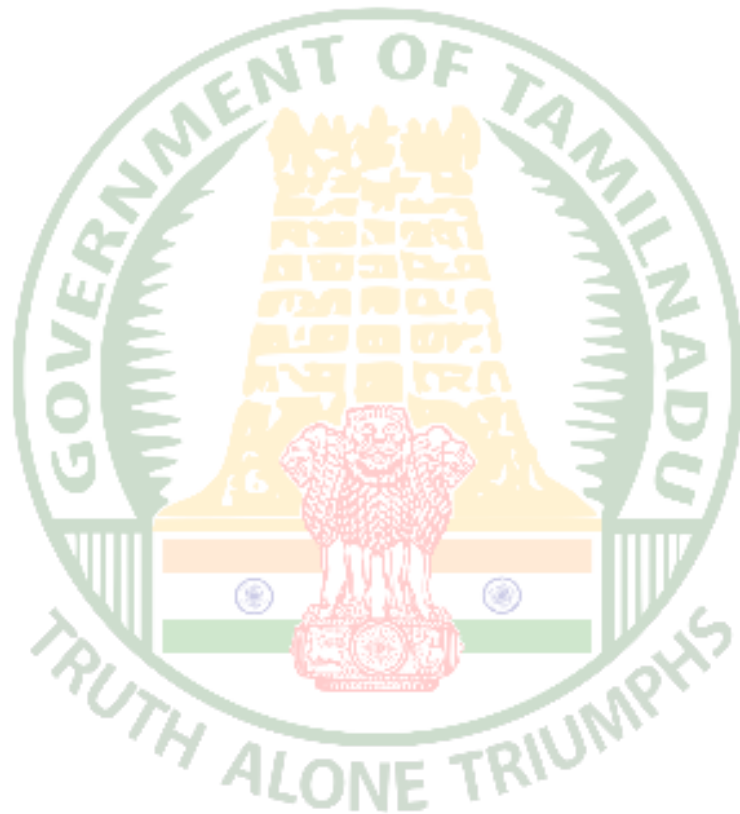
application (lease deed, sale deed, gift deed, etc)Any person wishing to purchase the property must individually assert
