With reference to the letter in the 1st cited, applicant has requested for the approval of Residential layout in Madurai District, Vadipatti Taluk, Vadipatti panchayat union, Mullipallam Panchayat, Mullipallam Village, S.No- 98/1A, Extent- 16600.00 Sq.m (4.10 Acre) 1.66.00 Hectare.

In the continuation, with reference to the letter in the 2nd cited, road pattern for residential layout has been issued by the Assistant Director / Member Secretary (i/c), Madurai District Town and Country Planning on 21.04.2026. Further the applicant has submitted gift deed of road and road splay areas by handing over to the local body on 25.05.2026. Hence, this residential layout is given approval with following conditions.

1. As per the condition, the layout has been approved and approved number is issued as LP/MLPA/No.270/2026 and Panning Permission No.288/2026 and enclosed with 2 set of original maps and gift deeded documents has been forwarded with it for further action.

i. Total No of Plots Given – 96 nos, EWS Plots (67-80, 85-96),

Owner Use-2 Nos

ii. Local Body Space –66.85 Sq.m(0.55%)

iii. TANGEDCO Space –68.64 Sq.m (0.56%)

iv. Road area – 4429.04 Sq.m

v. Park area – 1248.91 Sq.m (10.26%)

2. Further, when the final approval is given by the local body, it is requested to send a copy of the proceedings to this office immediately.

3. After the approval of the local body. It is requested to send the approved residential layout map to the concerned registration department office and land survey department for information and appropriate action.

4. It is requested to send acknowledgment of receipt of having receipt of maps and proceeding orders.

5. As per circular in 1ar to update in Tamilnilam website special conditions.3thcited, it is requested to send the proceeding orders and maps to the concerned Thasildh

Special Conditions

1. a) With reference to the 5th cited and 9th cited letter [TNCDBR-2019, Rule No. 47(11)], if the located site lies in the Municipal/Corporation areas: Collecting the necessary fees including the charges for providing amenities like roads, storm water drains and street lights from the applicants after collecting the necessary fees the final layout sketch, permit of planning authority along with approval of local body shall be issued to the applicants directly.

b) Other than Municipal / Corporation areas: Shall collect the necessary fees and issue the final layout sketch, permit of planning authority along with the permit of local body to the applicant(s) directly, only after ensuring that the applicant lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT, provide necessary street lights etc., as per the standards specified by the local body.

2. With reference to the 10thcited and 11thcited letter, the concern local body must issue the final approval after transfer of earmarked road, park areas in favour concern local body.

3. The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016, The promoter has to advertise, Market, Book sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA.

4. According to the Circular no.12544/14/CB dated 04.07.2014 stating that, the Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the applicant's entitlement to development is verified in the documents submitted with the applicant's application (lease deed, sale deed, gift deed, etc) Any person wishing to purchase the property must individually assert ownership of the property to the applicant. Also, if anyone else dispute arises individual rights over it, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide this.

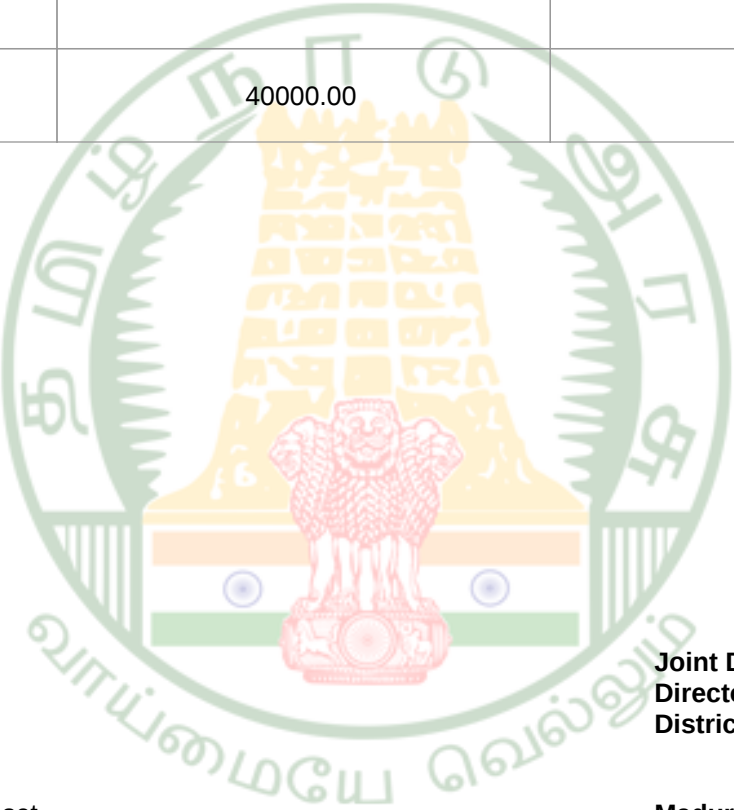
