In the continuation, with reference to the 2nd cited letter, road pattern for Industrial layout have been issued by the Assistant Director, Ranipet District Town and Country Planning Office on 28.01.2025. Further the Applicant Ms. M. Suganya (The Project officer, SIPCOT Industrial Park, Panapakkam) has maintain the road, road splay, OSR Space, Public Purpose & TANGEDCO Purpose areas. Hence, this SIPCOT Industrial layout has been approved with below conditions.

1. As per the condition, the layout has been approved and approved number issued as L.P. / D.T.C.P. (RPT) No. 09/2025 has been revised as L.P. / D.T.C.P. (RPT) No. 84/2026 and enclosed with 2 set of original maps has been forwarded with it for further action.
2. Further, when the final approval is given by the local body, it is requested to send a copy of the conditions to this office immediately as per Condition no.10 (b).
3. After the approval of the local body, It is requested to send the approved Industrial layout map to the concerned registration department office and land survey department for information for appropriate action.
4. It is requested to send acknowledgment of receipt of receiving Maps and Proceeding orders to this office.
5. As per circular cited in 12th, it is requested to send the proceeding orders and maps to the concerned Tahsildar to update in Tamilnilam website Special Conditions.
6. As per Tamil Nadu Combined Development Building Rules – 2019 Rule No.68 (2). – In granting of building

permit for any development the Executive Authority may wherever it is appropriate, make adequate provision for the preservation or planting of trees, as may be specified. On all streets exceeding 7.2 meters in width, shade trees shall be planted not more than 9.00 meters in succession and within 1.00 meters of the road boundary and the Land Owner developer should plant a tree for every 600 Sq.ft of the plot area which be monitored by the concern Local Body.

Special Conditions:

1. The Project Officer, SIPCOT Industrial Park, Panapakkam, should maintain the road, road splay, OSR space, public purpose areas, and TANGEDCO purpose areas as per the approved plan.

2. a) With reference to the 19th cited and 21st cited letter, if the located site lies in the Municipal/Corporation areas: Collecting the necessary fees including the charges for providing amenities like roads, storm water drains and street lights from the applicant. After collecting the necessary fees, the final layout sketch, permit of planning authority along with approval of Local Body shall be issued to the applicant directly.

b) Other than Municipal/ Corporation areas: Shall collect the necessary fees and issue the final layout sketch, permit of planning authority along with the permit of local body to the applicant directly, only after ensuring that the applicant lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT, provide necessary street lights etc., as per the standards specified by the local body.

3. The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017. have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016, The promoter has to advertise, Market, book sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA.

4. According to the Circular No. 12544/14/CB dated: 04.07.2014 stating that, The Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the applicant entitlement to development is verified in the documents submitted with the applicant application (lease deed, sale deed, gift deed, etc.,) any person wishing to purchase the property must individually assert ownership of the property to the applicant. Also, if anyone else dispute arises individual rights over it; they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide this.

5. As per TNCDBR-2019 the following fee and charges are already collected as follows:

Scrutiny Fee - Rs. 7000000.00, Dated: 07/01/2025 and Rs. 110000.00, Dated: 05/02/2025. Centage Fee - Rs. 29000.00, Dated: 04/02/2025.

Display Board Charges – Rs. 10000.00, Dated: 04/02/2025. Flag Day Fund - Rs. 10000.00, Dated: 04/02/2025.

Development Charges - Rs. 4900000.00, Dated: 04/02/2025.

6. Since the court cases WP No. 22083/2022, WP No. 22085/2022, and WP No. 22091/2022 are pending for Agavalam Village Survey Nos. 502/2A1, 502/2A2, 20/1, 20/3A, 20/3B, 20/3C, 20/3D1 and 26/2 respectively, if there are any changes in the approved Layout upon receipt of the final judgment, the revised Layout should be approved with the consent of the Town and Country Planning Department. Furthermore, no steps such as sale or lease of the plots located in the above survey numbers should be taken until the final judgment is received.

7. A Driveway should be formed to the water bodies located in Plot Nos. 1A, 1B, and S1 in the approved layout. This Driveway should be maintained as a clear pathway without any alterations, and no structures should be constructed in the driveway portion. Furthermore, no obstruction should be placed to hinder government officials visiting these water bodies. If building permission is granted for the above plots, this condition should be imposed.

8. The L.T. line, H.T. line, and transformer yard in the Layout should be relocated along the road portion with the

permission of the TANGEDCO Department.

9. Wells located in this layout should be closed in a scientific manner. If construction is carried out in the area where the well is located, the stability of the building should be ensured. The Directorate of Town and Country Planning Department is not the right organization to decide this.

10. The patta channels in this layout should be connected to the stormwater drainage channels without any obstruction along the road, with the permission of the concerned department.

11. Before giving final concurrence, the local body should ensure that the site is levelled to the road level.

12. The Project Officer of SIPCOT Industrial Park, Panapakkam, must issue a copy of the Layout Approval Plan and Proceeding Order to the buyer or lessee of the plots in this layout.

Conditions:

1. The permission granted by the competent authority shall not mean responsibility or clearance as per TNCDBR 2019, Rule No.11 of the following aspects:

a) Title or ownership of the site or building,

b) Easement Rights,

c) The Registered Architect/Register Engineer/Structural Engineer shall be responsible for defects in the design of Structural Reports, Structural Drawing and Structural aspects,

d) Workmanship, soundness of structure and materials use,

e) Quality of building services and amenities the construction of building and

f) Other requirements or licenses or clearance required for the site or premises or activity under various other laws.

2. Alteration of plot sizes, layouts of roads, dimensions, common allotment sizes and further subdivision of plots contrary to the map approved by the Town and country Planning Department shall not be done without the prior approval of the Town and Country Planning Department.

3. Corners of plot located at the junction of two roads should be laid with the splay shown on the approved map.

4. No plot shall be sold, leased or transferred in any other manner or any building shall be constructed on any plot before the fulfilment of the above two conditions.

5. Any plot shown on the approved map shall be used only for the construction of Industrial Building other than plots selected for public purposes. Also, only where the change of land use is requested, only those mentioned in the Industrial Use mentioned in TNCDBR-2019 should be allowed by the local body only after obtaining the prior approval of the Town and country Planning Department.

6. If a low voltage/high voltage power line/telegraph line/Transformer Yard is laid through the layout, the line should be shifted to the edge of the road or as shown on the approved Layout plan.

7. The hollow portion of the layout should be raised to street level.

8. On all streets exceeding 7.2 meters in width, shade trees shall be planted within 1.00 meters of the road boundary not exceeding 9.00 meters in succession.

9. The petitioner should obtain approval from the local authority concerned for the layout. Before constructing any buildings on the land in the Layout, permission for each building must be obtained from the Town and country Planning department and the local body.

10. a) Since only Technical Sanction has been given to the said layout by the Town and country Planning Department, if there is any problem regarding the right of land for the layout, the local body should consider and take a decision.

b) When the said layout is approved by the local authority, a copy of the approval authority's presence action should be sent to this authority. Evidence of handing over of public spaces to the local body should also be attached.

11. Once permission is obtained from the petitioner Town and country Planning Department and approval of the layout plan from the local authority, the approved layout plan shall be permanently published at the location where the layout has been approved without any change/omission through a permanent information board at the entrance of the layout for public viewing and also clearly indicating the date and resolution number of the board of approval of the layout.

12. The land Ownership is considered as per the land title documents submitted by the petitioner. Therefore, it is also submitted that no right can be asserted on the

ground that a layout has been approved for a place where there is no actual land Ownership.

13. If the proofs given regarding the land license and the documents submitted for consideration are known to be incorrect or if there is a situation where the planning permission/concurrence approval for the layout may be affected, Technical Sanction approval given to the layout will be cancelled by the Town and Country Planning department without any prior notice.

14. A copy of the plan approved by the Town and Country Planning department along with a copy of this order shall be compulsorily supplied to the purchasers while selling the plots for sale.

15. If any case is pending in the field numbers where the layout is situated, the approval given to the layout will be cancelled without any prior notice and action will be taken.

16. If any false or malpractices in the Documents Submitted by the applicant are found, the technical concurrence of the Layout approval would be cancelled by the Town and Country Planning department without prior intimation to the applicant.

17. If any part of the layout area is identified to be under Panjami land or condition patta or Boomidhana Land in future at any cost, the technical concurrence will be cancelled by the Town and Country Planning department without prior intimation.

18. If any feature is found affecting the water bodies due to the issued technical concurrence under any circumstances, the same will be cancelled by the department without any intimation to the applicant.

19. Technical Concurrence given only on the basis of the documents produced by the applicant; any interest of ownership could not be done basis of the issue of technical concurrence. If any false or malpractices in the certificate produced by the applicant are found leads to cancellation of Industrial Layout approval without prior intimation to the applicant.

20. Conditions and Special conditions given in the Layout Plan must be followed by the applicant.

21. If the proposed site is located in the land acquisition area related to Railway Department Project, Highway Department Project, and Condition patta land, the technical approval given by the Department shall be cancelled by the Department without any prior notice.

22. This approval is valid only for the Plots not for the building. Apply separately for building construction based on the power delegated.

23. The roads in the layout must be open to the public for access and should connect to the adjoining lands to ensure access to the areas surrounding the industrial layout.

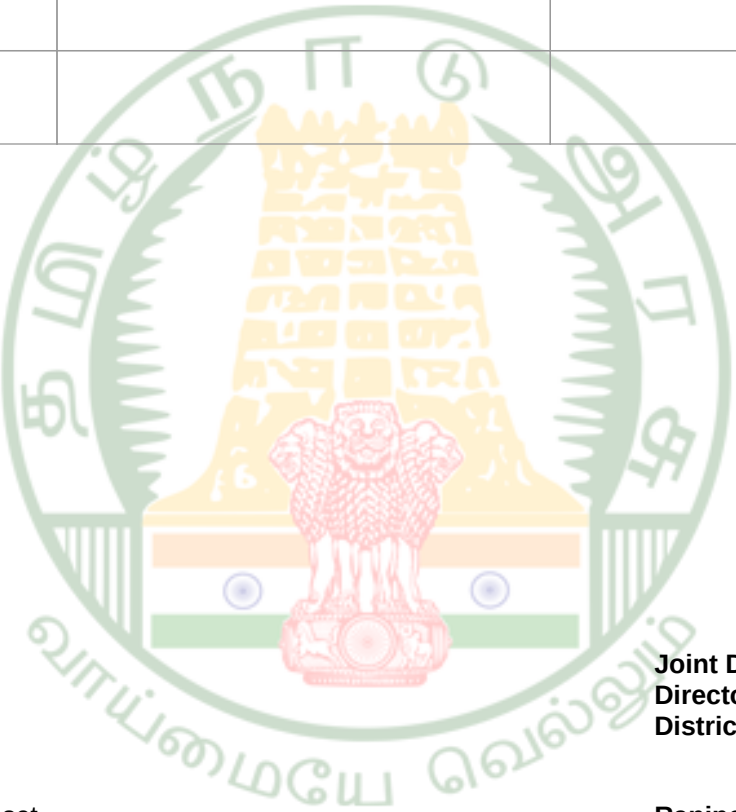
