ORDER :

With reference to the 2nd Cited letter, applicant has requested for the approval of residential layout Theni District, Theni Taluk, Palanichettipatti Town Panchayat,Veerapandi Village,Comprised in S.Nos- 1455, 1466/2A, 1468/1A1, 1468/1A2, 1468/1B, 1468/2A, 1468/2B, 1468/3, 1468/4A, 1468/4B, 1468/5A2, 1468/5B, 1469/1B, 1471/1A4A3, 1471/1A5, 1471/1A6, 1471/1A7, 1471/1A8, 1471/1A9, 1471/1B1, 1471/1B2, 1471/1B3, 1471/2A2A2, 1471/2A3, 1471/2B1, 1471/2B2 and 1471/2C, Site Extent of 13.03 Acres With reference to the 1st Cited Director of Town and Country Planning,Chennai, Plot pattern Technical concurrence issued forwarded for further action.

In the continuation, with reference to the 3rd cited letter, road pattern for residential layout has been issued by the Directorate on 27.01.2023.

Further the applicant Mr.V.T.Narayanasamy. Has gift the road, road splay areas has been handed over to the Local body by Gift deed document no.4050/2023, dated:25.04.2023 and TANGEDCO Gift deed document no.4048/2023, dated:25.04.2023. Hence, this residential layout has been approved with below conditions.

1.As per the condition, the layout has been approved and approved number is issued as LP/ DTCP NO;SWP/44/2023 and enclosed with 2 set of original maps and gift deeded documents has been forwarded with it for further action.

2.Further, when the final approval is given by the local body, it is informed to send the final Order copy to this office.

3.After the approval of the local body. It is informed to send the approved residential layout map to the concerned registration Department office and Land Survey Department for information and appropriate action.

4.It is informed to send acknowledgment of receipt of receiving Maps and Proceeding orders.

5.As per circular cited in 15th, it is informed to send the proceeding orders and maps to the concerned Thasildhar to update in Tamilnilam website.

Special Conditions

1.a) With reference to the 10th cited, 12th cited and 19th cited letter, if the located site lies in the Municipal/ Corporation areas: The

Owners/developers shall be allowed either to carry out infrastructure development works as per the standards specified by the local body concerned or to pay the estimate cost to the local body. Concerned local body shall prescribe the standards for the provisions of basic infrastructure like roads, drains, water supply etc, for the layout as per existing rules. Before taking over the infrastructure developed by the owners /developers, the local bodies shall ensure the quality of works done by the owners / developers. Reasonable period to be prescribed for upkeep/maintenance of the roads and drains by the owners/ developers. Wherever layouts develop at a slow pace, the maintenance period shall be extended till 60% of the plots developed in the layout or 5 years whichever is later.

b) Other than Municipal/ Corporation areas: Shall collect the necessary fees and issue the final layout sketch, permit of planning authority along with the permit of local body to the applicant (s) directly, only after ensuring that the applicant lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT, provide necessary street lights etc., as per the standards specified by the local body.

2. With reference to the 13th cited and 14th cited letter, the concerned local body must issue the final approval after transfer of earmarked road areas

S.F. No sub-division in favour of concerned local body.

3. The Tamil Nadu Government in G.O. Ms. No. 112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016. The promoter has to advertise, market, book sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA

4. As per G.O. 79 Housing and Urban Development Department, dated: 04.05.2017, in case of non-planned area rule 3 it has been requested to collect Rs. 1000 as scrutiny fee for each plot. And under rule 9 concerned local body should collect the 3% Market Land Value as Land conversation charges, before issuing the final approval

5. According to the Circular No. 12544/14 / CB dated: 04.07.2014 stating that, The Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the applicant's entitlement to development is verified in the documents submitted with the applicant's application (lease deed, sale deed, gift deed, etc). Any person wishing to purchase the property must individually assert ownership of the property to the applicant. Also, if anyone else dispute arises individual rights over it, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide this.

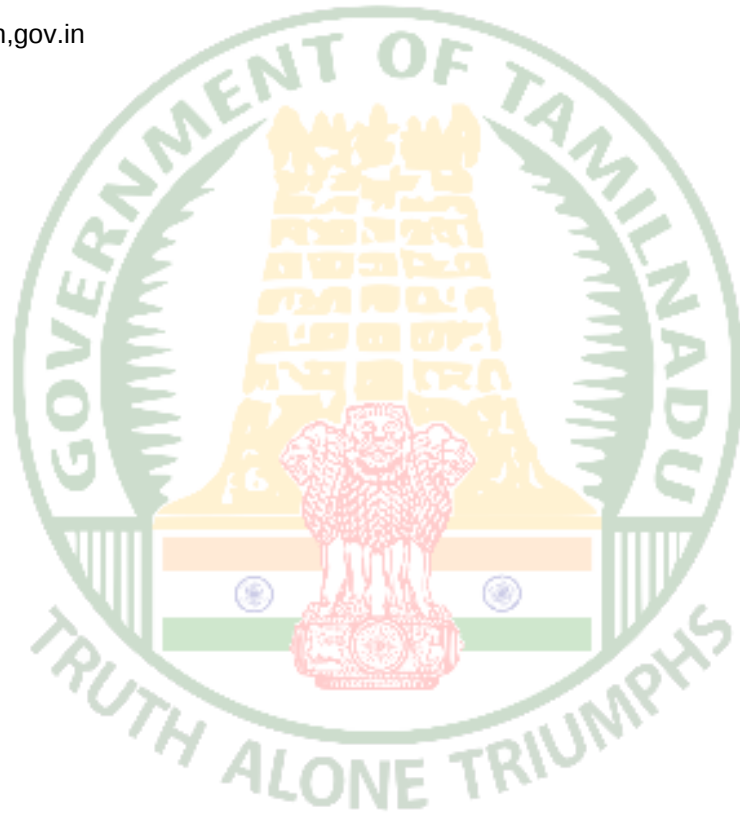
