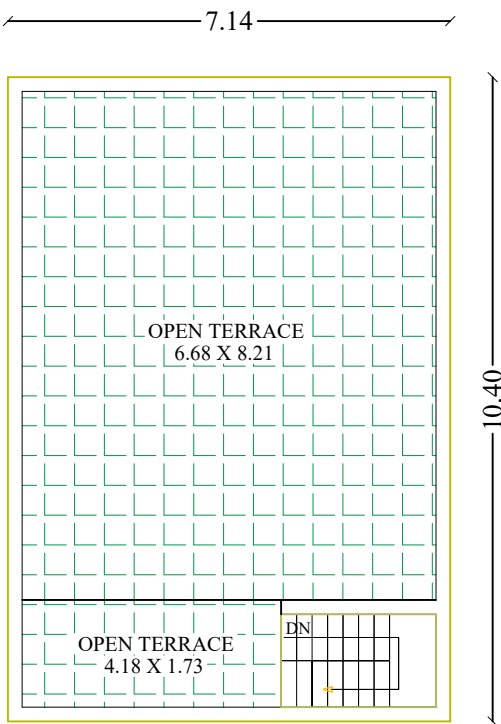
FRONT ELEVATION

GROUND FLOOR PLAN

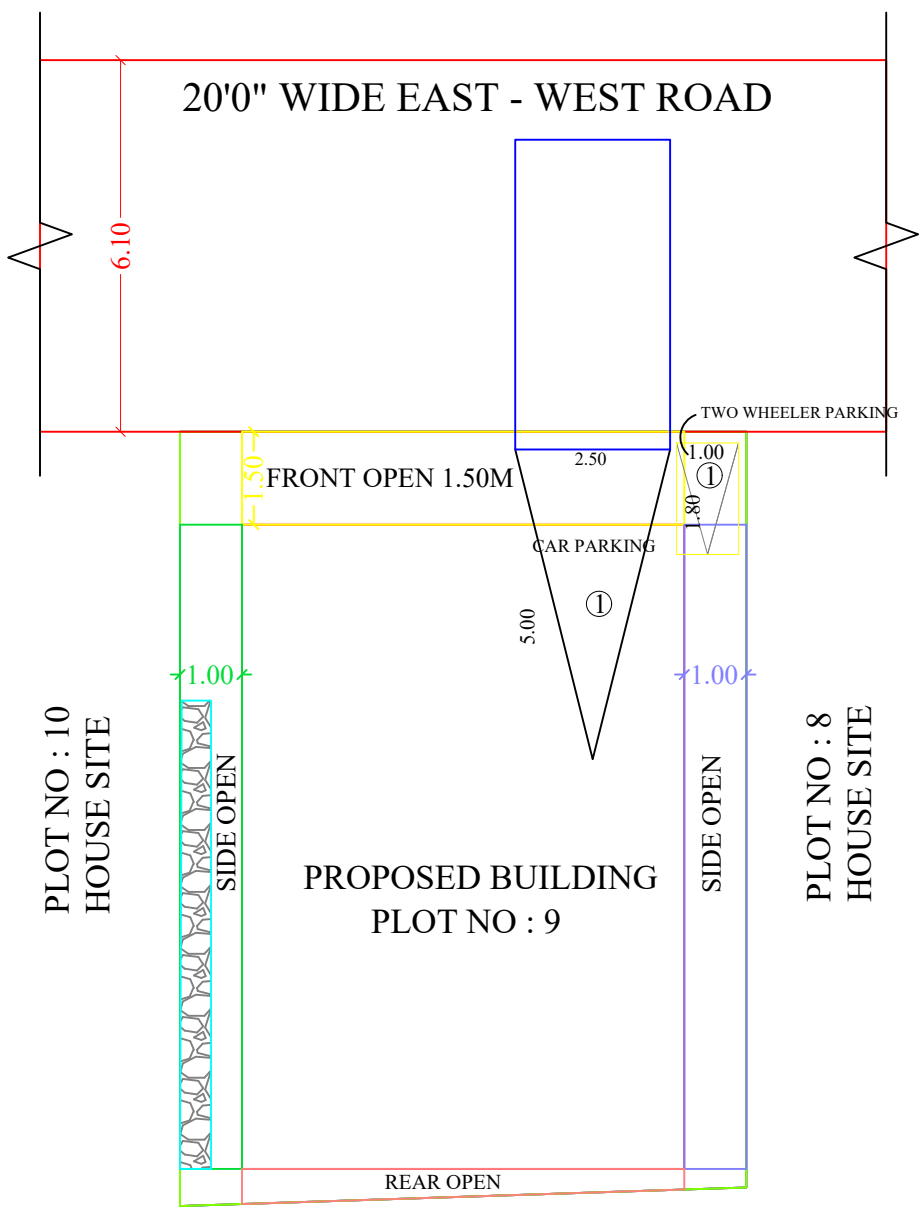


TERRACE FLOOR PLAN

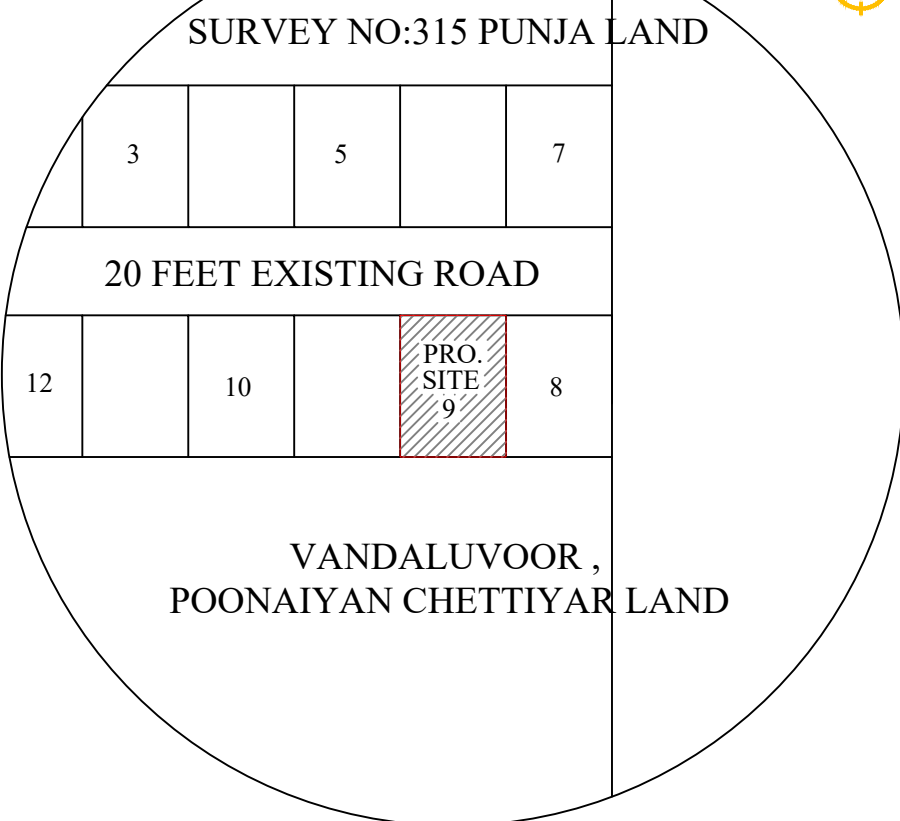

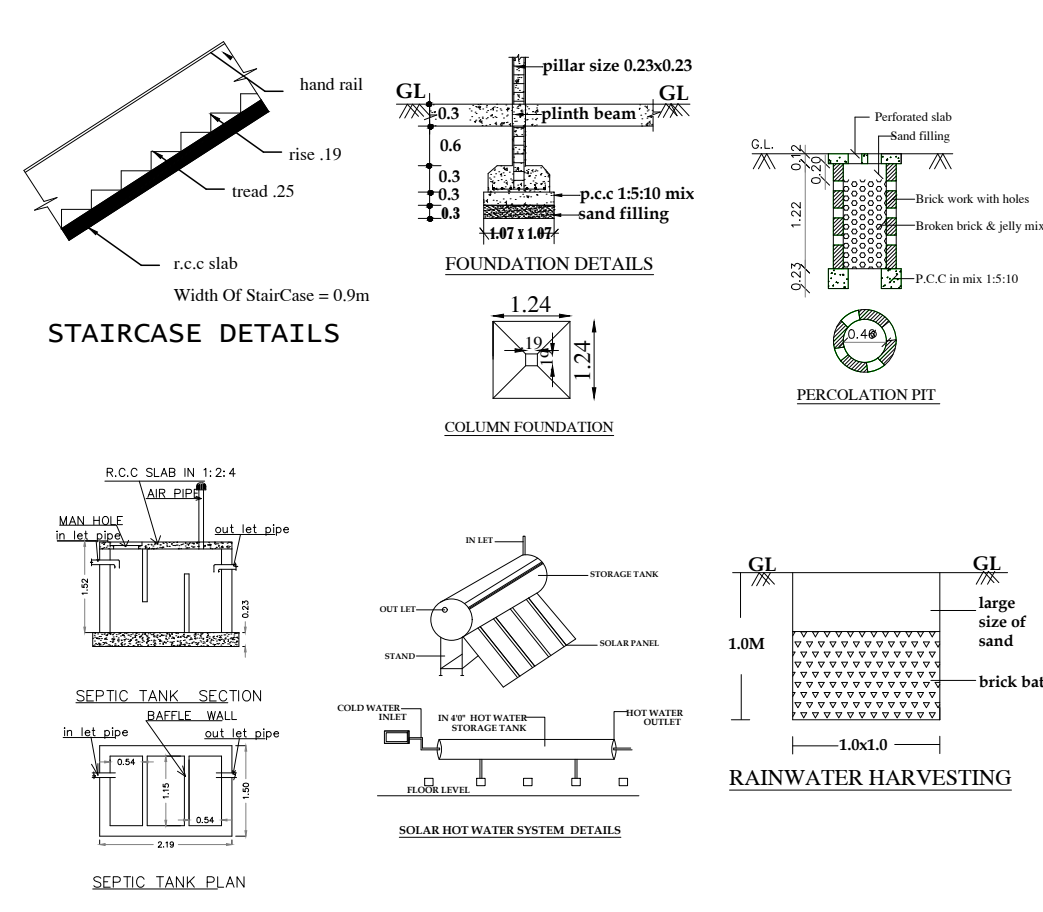
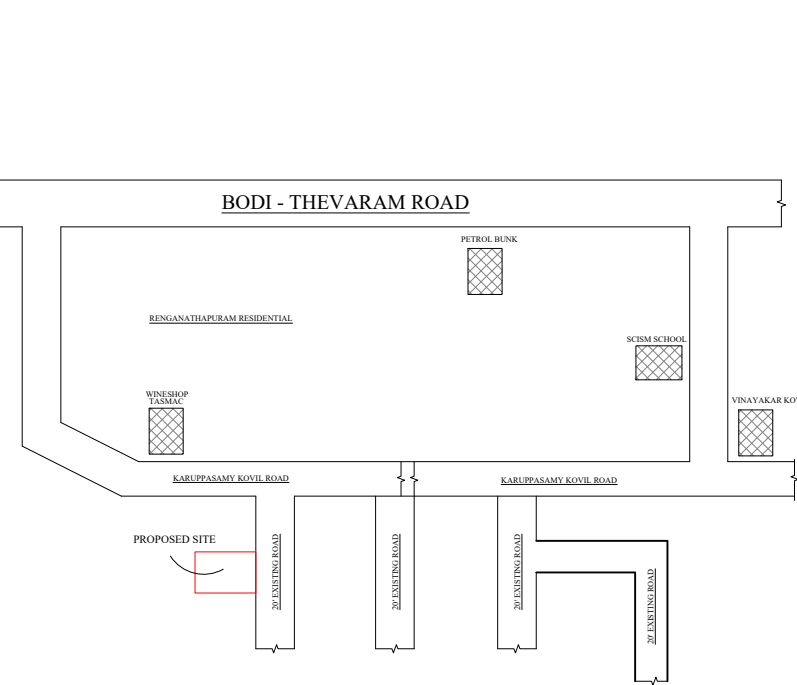
TOPO PLAN
