The applicant has requested to follow the protocols as per instruction given by TNRERA

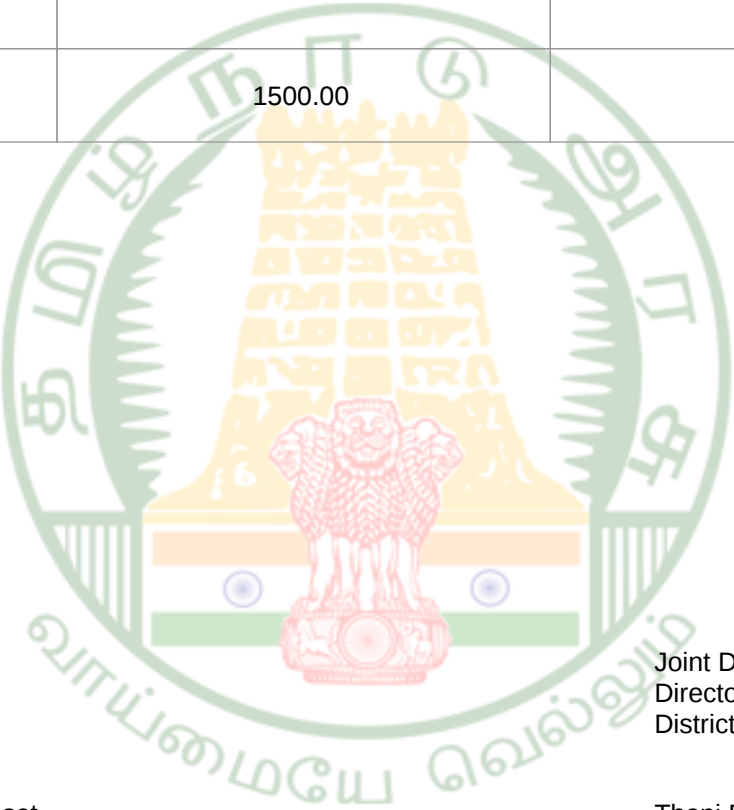
