With reference to the letter in the 2nd cited, applicant has requested for the approval of residential layout in – Thoothukudi District, Thoothukudi Thaluk Thoothukudi Local Planning area, Thoothukudi Corporation, Mullakkadu Village-- S.F.Nos. 99/1C1A, 99/1C1B, 106/1, 106/2, 107 & 108/2 - Site Extent – 9.69 Acres (39242.00 sq.m) forwarded to Director of Town and Country Planning for Concurrence.

In the continuation to that the application was forwarded to Director of Town and Country Planning for Concurrence with reference to the letter 3rd cited, road pattern for the residential layout has been issued by the Director on 13.02.2025. Further the applicant has gifted road and road splay and park areas to the concerned local body by a registered gift deed on 25.02.2025. Hence, the technical concurrence issued for the residential layout is given by Director of Town and Country Planning, Chennai Order No. Roc no. 1UMKOOBM /2024/TCP6, Dated: 05.03.2025 and Also Planning Permission No in lussed by This office with following conditions.

1.As per the condition, Technical Concurrence has been issued for the Residential Layout with number LP/DTCP No. 22 /2025.and This office from lussed for Planning Permission No 23/2025 The approved Layout plan is enclosed herewith for taking further action in the regard. The applicant should submit the original Gift deed cited in the reference 4 to the concerned local body

2.Further, when the final approval is given by the local body, it is requested to send a copy of the proceedings to this office immediately.

3.After the approval is issued by the local body, it is requested to send the approved residential layout map to the concerned registration department office and land survey department for appropriate information and action.

4.It is also requested to send acknowledgment of receipt of maps and proceeding orders.

5.As per the 14th cited circular, it is requested to send the proceeding orders and maps to the concerned Thasildhar to update in Tamilnilam website

Special Conditions

1.a) With reference to the 7th cited and 8th cited letter [TNCD BR-2019, Rule No. 47(11)], if the site is located in the Municipal/Corporation areas, only after Collecting the necessary fees including the charges for providing amenities like roads, storm water drains and street lights from the applicants, the final layout sketch, permit of planning authority along with approval of local body shall be issued to the applicants directly.

b) Other than Municipal / Corporation areas, Local bodies Shall collect the necessary fees and issue the final layout sketch, permit of planning authority along with the permit of local body to the applicant(s) directly, only after ensuring that the applicant lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT, provide necessary street lights etc., as per the standards specified by the local body.

2.With reference to the 12th cited and 13th cited letter, the concerned local body must issue the final approval after transfer of earmarked road, park areas in favour of concerned local body.

3.The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016, The promoter has to advertise, Market, Book, sell or offer for sale or invite persons to purchase any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Regulatory Authority. The applicant is hereby requested to follow the protocols as per instruction given by TNRERA.

4.According to the Circular no.12544/14/CB dated 04.07.2014, it is informed that the Directorate of Town and Country Planning Department has not legally certified the title of the ownership by granting technical clearance and planning permission. Only the applicant's entitlement to development is verified in the documents submitted with the applicant's application (lease deed, sale deed, gift deed, etc). Any person wishing to purchase the property must individually assert ownership of the property to the applicant. Also, if anyone dispute rises on individual rights, they can settle it before the appropriate competent court of law. The Directorate of Town and Country Planning Department is not the right organization to decide on this.

5.Plots reserved for Economically Weaker Section (EWS) should not be amalgamated or rearranged. But in rural areas, if the EWS plots are not sold even after a time period of more than 3 years, after the plot approval, as per G.O.16, Municipal Administration and Water Supply Department, dated: 31.01.2020, should be applied in appropriate permission for amalgamation of EWS plots7.As per TNCD BR 2019 the following fee and charges are collected as follows:

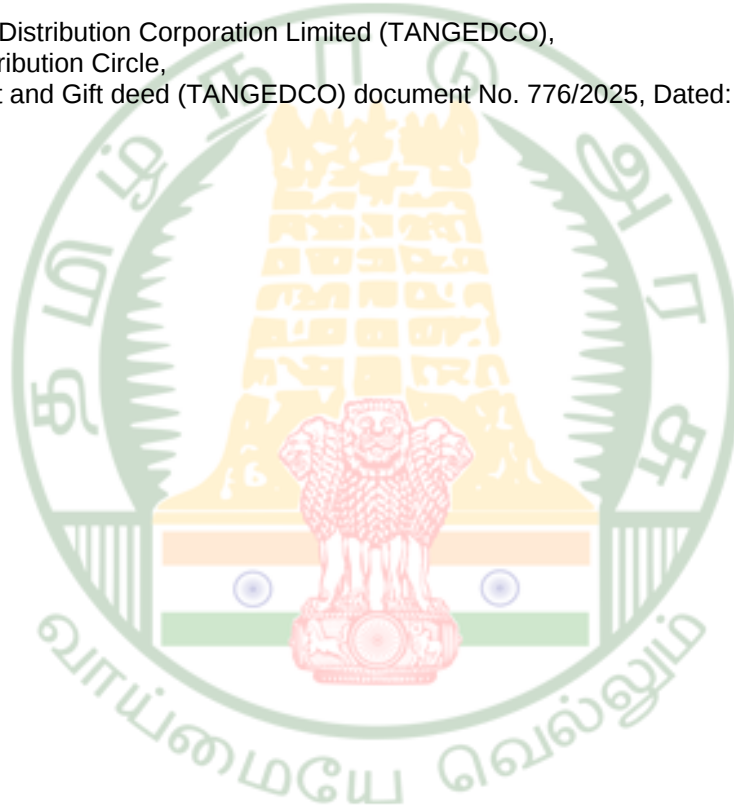

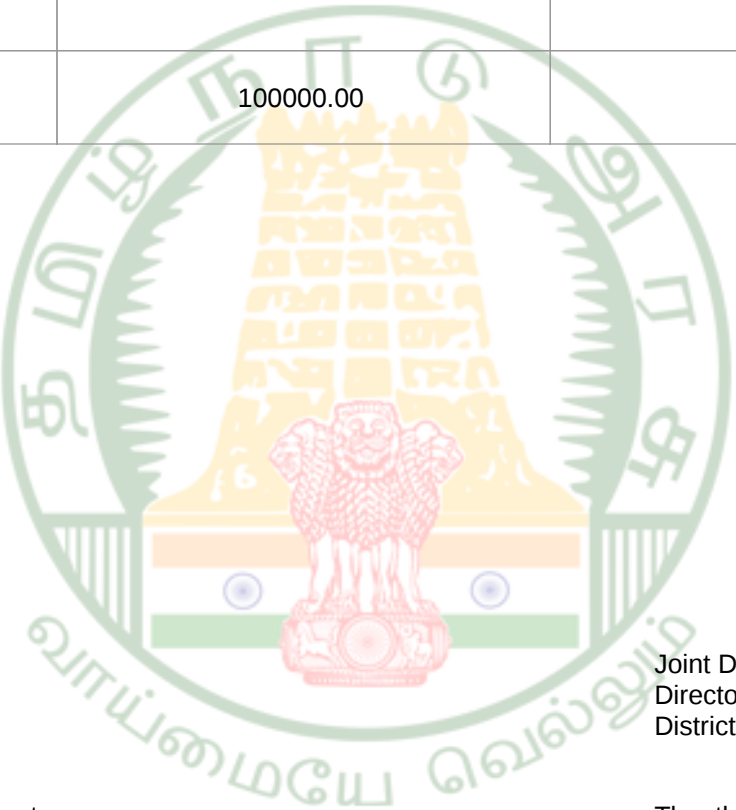
