5. As per circular in 10th cited, it is requested to send the proceeding orders and maps to the concerned Thasildhar to update in Tamilnilam website special conditions.

Special Conditions

1.a) As per GO(MS) No.157, the spaces set a part for road, recreation purpose such as parks / playground etc. the concerned Government agency shall retain and maintain the same for the purpose for which these space have been reserved in the approved layout. The road in the layout must be open to the public for access.

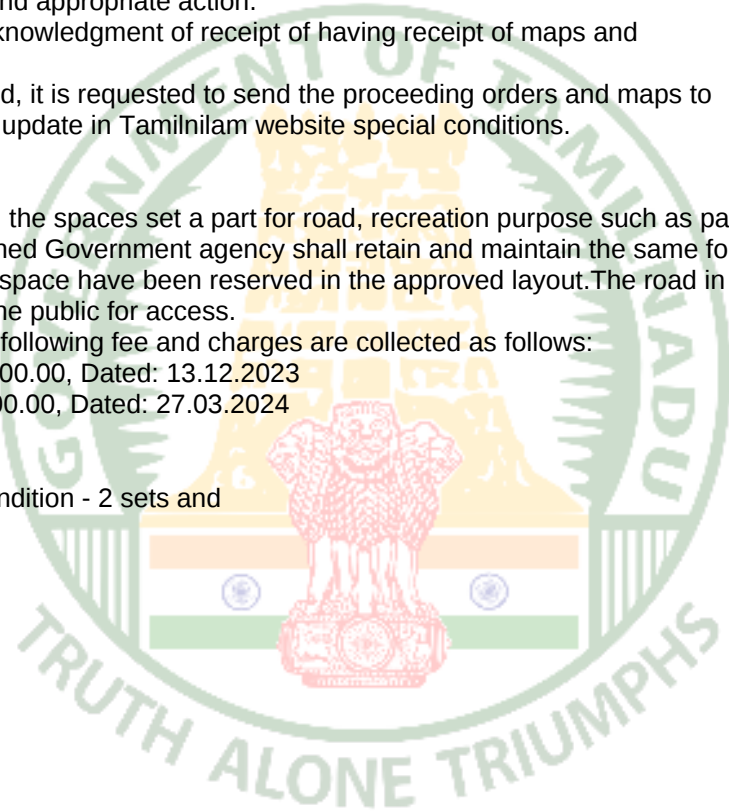

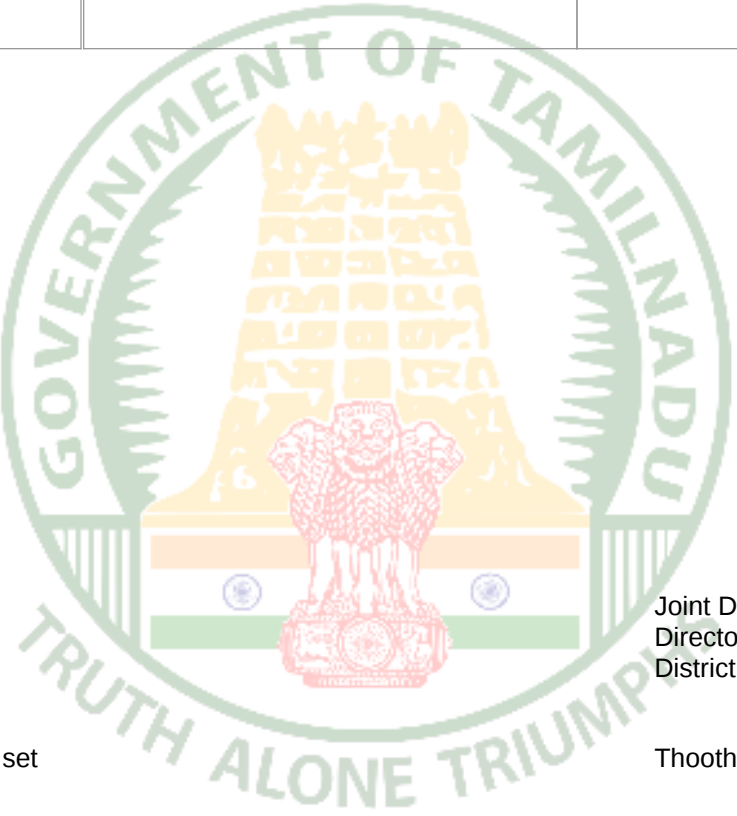
