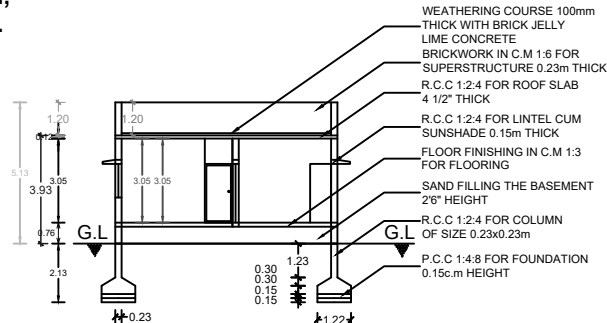

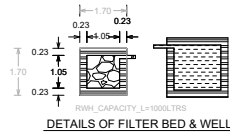

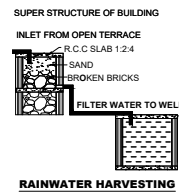
DETAILS OF STAIRCASE



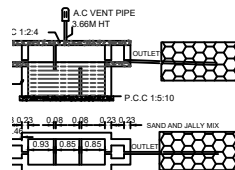

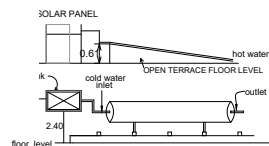
DETAILS OF FILTER BED & WELL



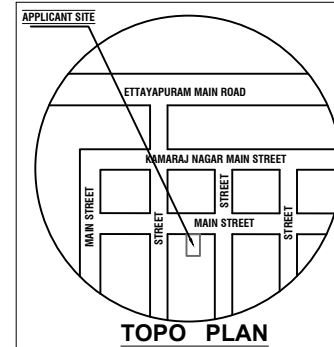
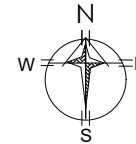

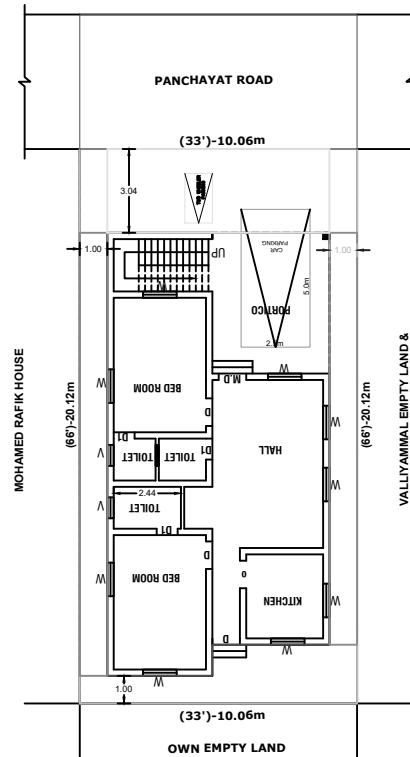


Details of solar water heating system
