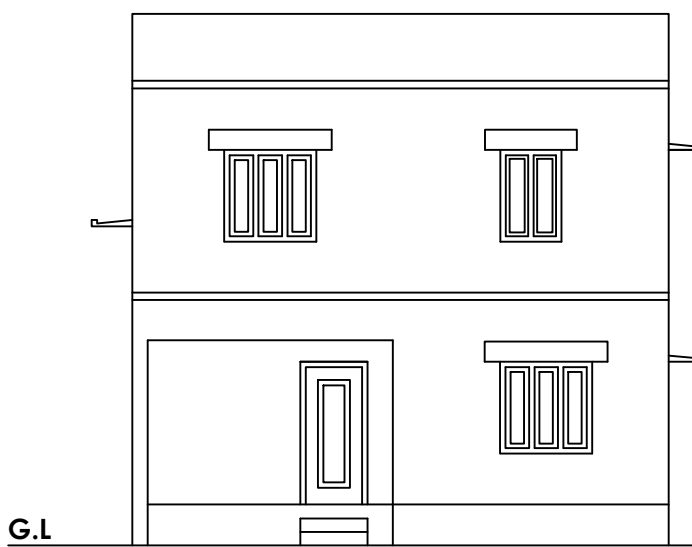

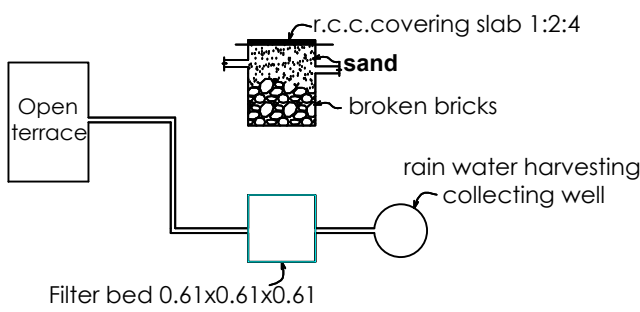
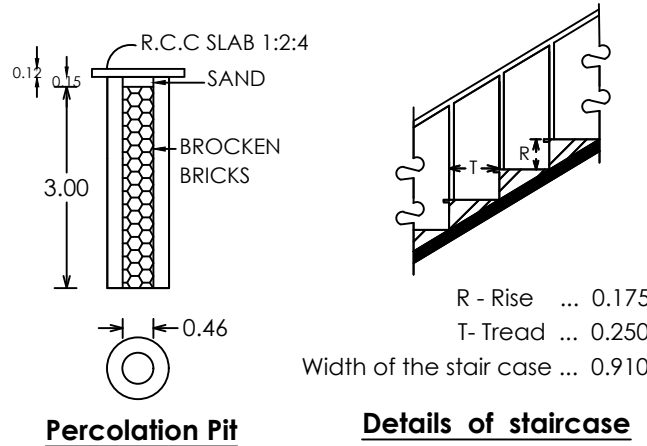
FRONT ELEVATION



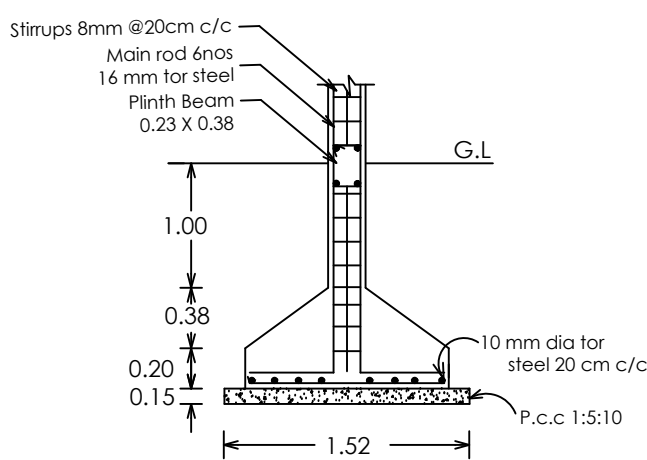

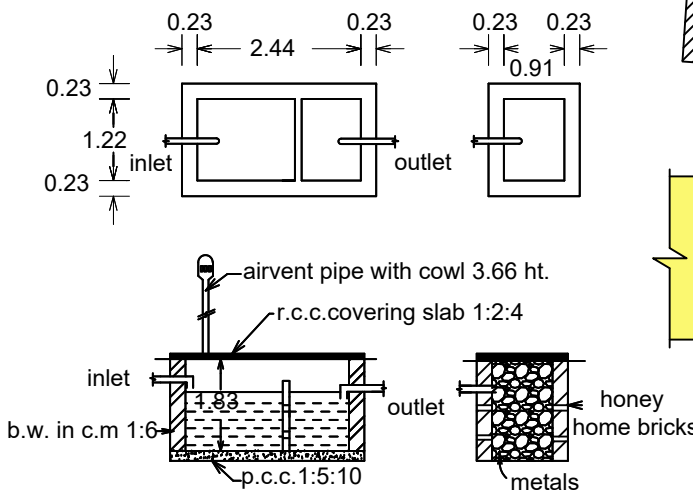
FIRST FLOOR PLAN

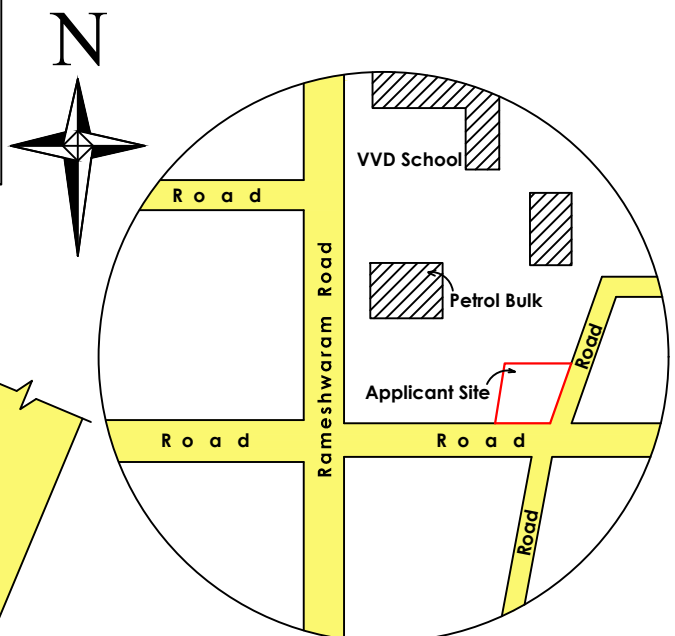

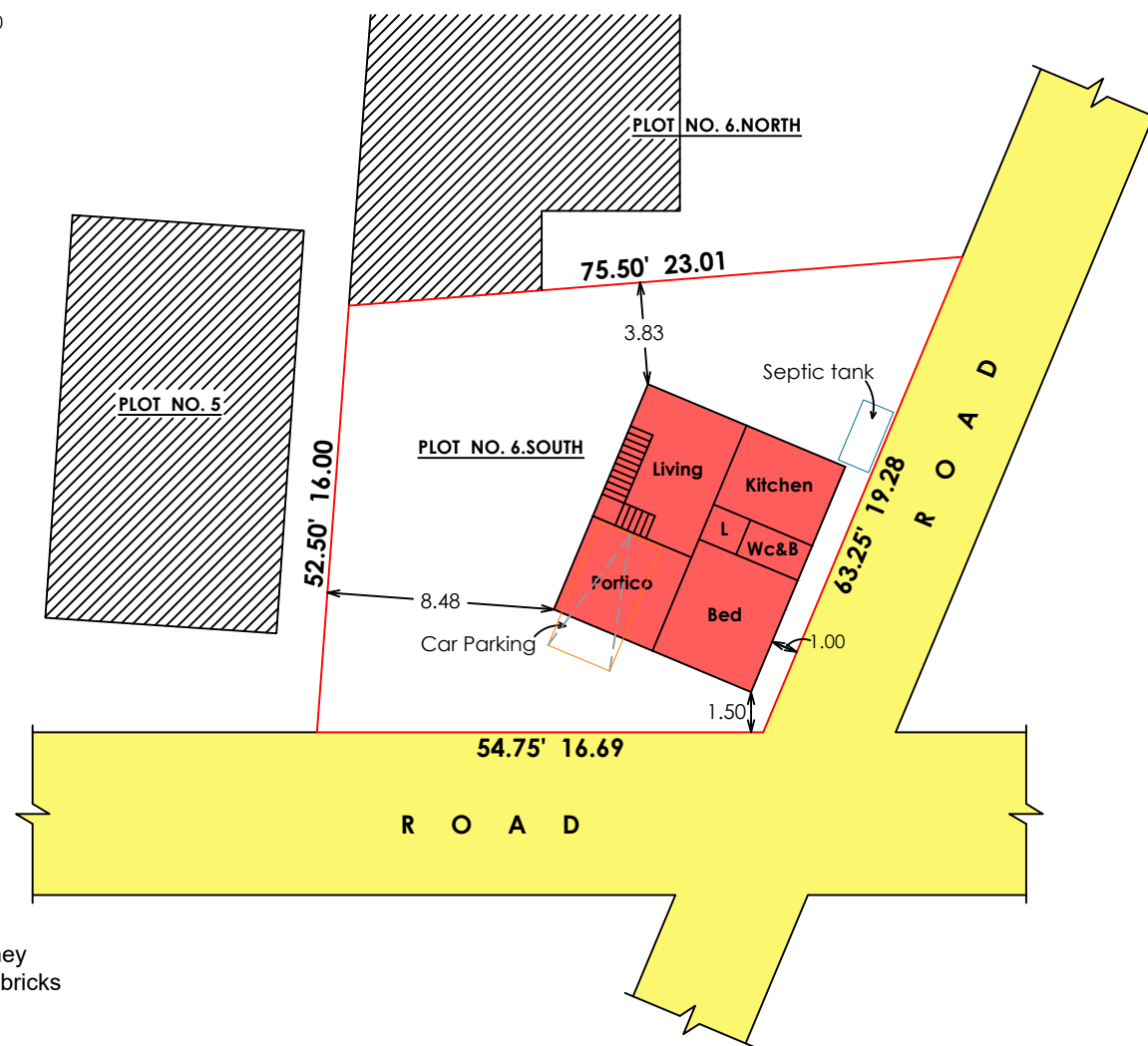
