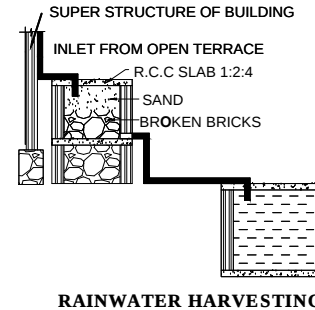
PLAN SHOWING THE PROPOSED ADDITIONAL CONSTRUCTION OF TWO SHOPS IN GROUND FLOOR BEARING

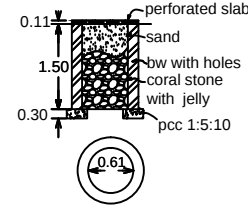

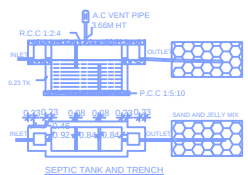
