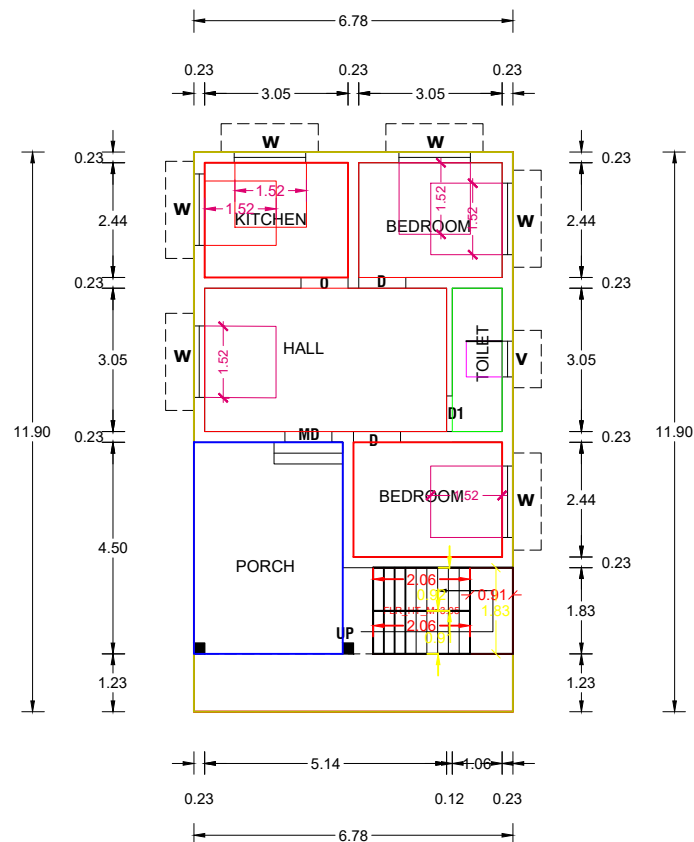

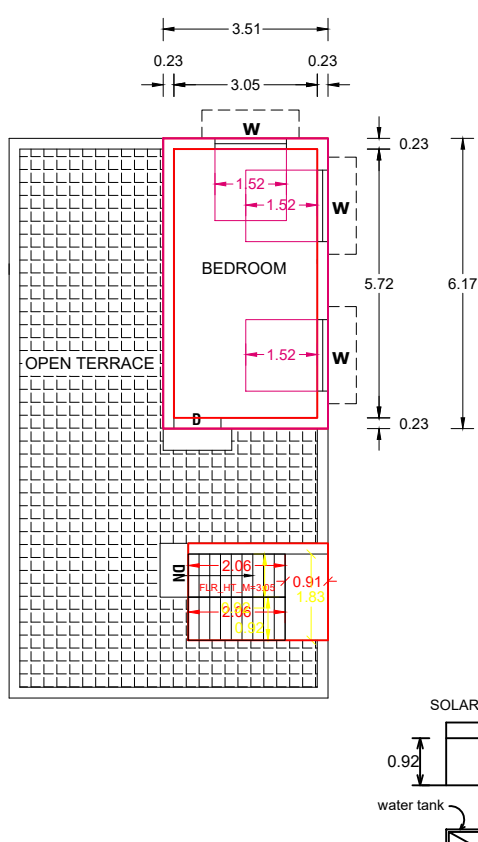

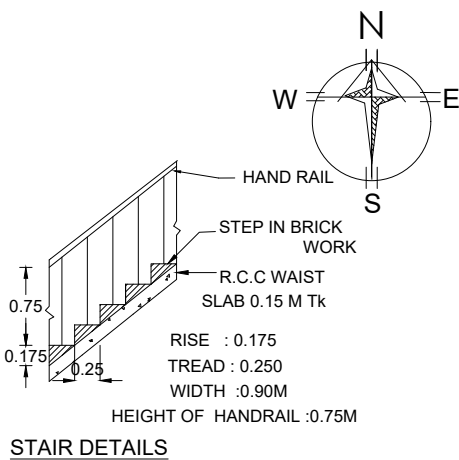

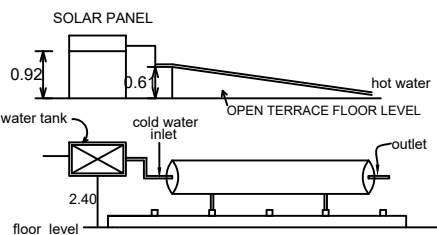
PRO .GROUND FLOOR PLAN



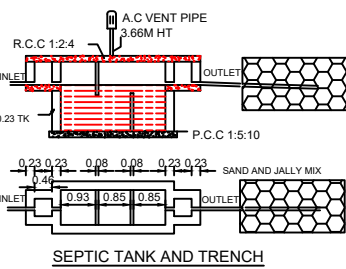
PRO .FIRST FLOOR PLAN



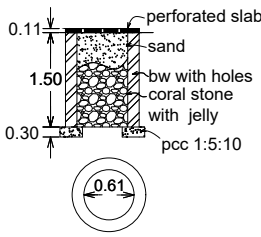

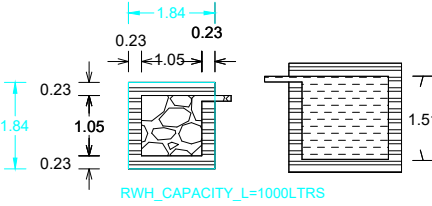
Details of solar water heating system



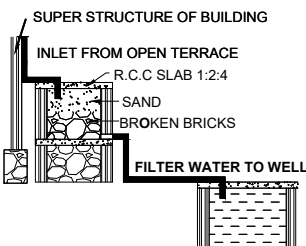

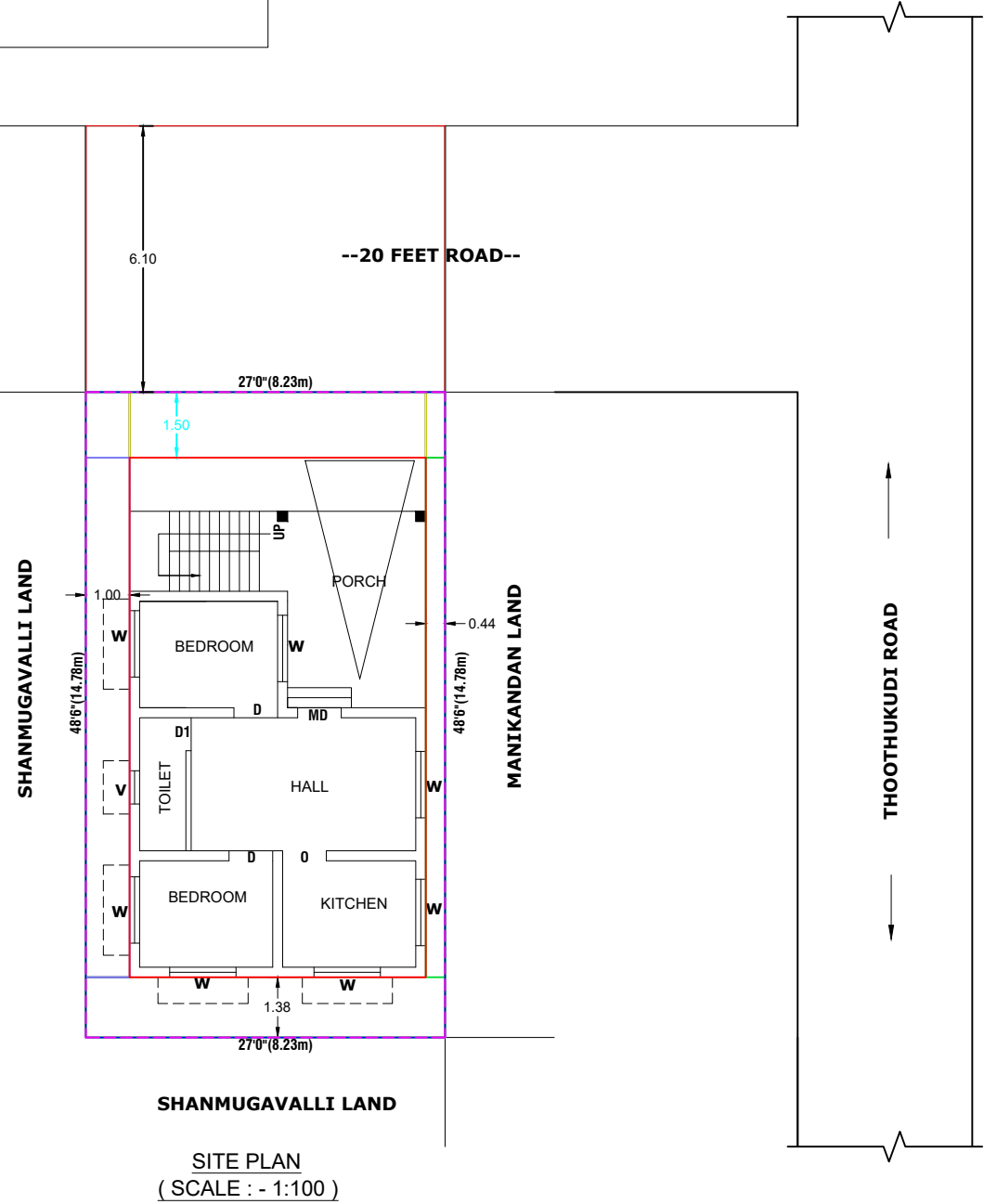
