With reference to the letter in the 1st cited, applicant has requested for the approval of Subdivision in Thoothukudi District, Vilathikulam Taluk, Vilathikulam Town Panchayat, Vilathikulam Village, Survey No 24/2A1A1A, 2A1A2, 2A1A3, 2A1B, 2A1C, 52 - Extent of 2000.00 Sqmt (0.49Acres)

In the continuation, with reference to the letter in the 2nd cited, OSR Demand for Subdivision has been issued by the Assistant Director, Thoothukudi District Town and Country Planning on 14.03.2025 . Further the applicant has paid the

Centage Charge on 01.05.2025. Hence,
this Subdivision is given approval with following conditions.

1. As per the condition, Subdivision for Residential use marked as "A to D" has been approved and approved number is issued as SWP/DTCP/THOOTHUKUDI/SUBDIVISION No.77/2025 and enclosed with 2 set of original maps has been forwarded with it for further action. Further, when the final approval is given by the local body, it is requested to send a copy of the proceedings to this office immediately.
2. After the approval of the local body. It is requested to send the approved Subdivision map to the concerned registration department office and land survey department for information and appropriate action.
3. It is requested to send acknowledgment of receipt of having receipt of maps and proceeding orders.
4. As per circular in 12th cited, it is requested to send the proceeding orders and maps to the concerned Thasildhar to update in Tamilnilam website.

Special Conditions

1. a) With reference to the 7th cited and 8th cited letter [TNCDBR-2019, Rule No. 47(11)], if the located site lies in the Municipal/Corporation areas: Collecting the necessary fees including the charges for providing amenities like roads, storm water drains and street lights from the applicants after collecting the necessary fees the final Subdivision sketch, permit of planning authority along with approval of local body shall be issued to the applicants directly.
b) Other than Municipal / Corporation areas: Shall collect the necessary fees and issue the final Subdivision sketch, permit of planning authority along with the permit of local body to the applicant(s) directly, only after ensuring that the applicant lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT, provide necessary street lights etc., as per the standards specified by the local body.
2. As per G.O.79 Housing and Urban Development Department, dated: 04.05.2017, in-case of non-planned area rule 3 it has been requested to collect Rs.1000 as scrutiny fee for each plot. And under rule 9 concerned local body should collect the 3% Market Land Value as Land conversation charges, before issuing the final approval Head of Account: 0217 Urban Development - 60 other Urban Development Schemes -800 other Receipts - AS Receipts under Land Use Conversion Charges-27 NonTaxation fees - 09 Collections (DPC: 0217-60-800-AS 22709)
3. The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016, The promoter has to advertise, Market, Book sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA.
4. According to the Circular no.12544/14/CB dated 04.07.2014 stating that, the Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the applicant's entitlement to development is verified in the documents submitted with the applicant's application (lease deed, sale deed, gift deed, etc) Any person wishing to purchase the property must individually assert ownership of the property to the applicant. Also, if any dispute arises over individual rights, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide this.
5. Befere Issuing final approval, the local body should ensure that the building located in the subdivision should

be
given building approval as per norms.

6. As per TNCDBR 2019 the following fee and charges are collected as follows:

OSR Charges - Rs.261000, Dated: 11.04.2025

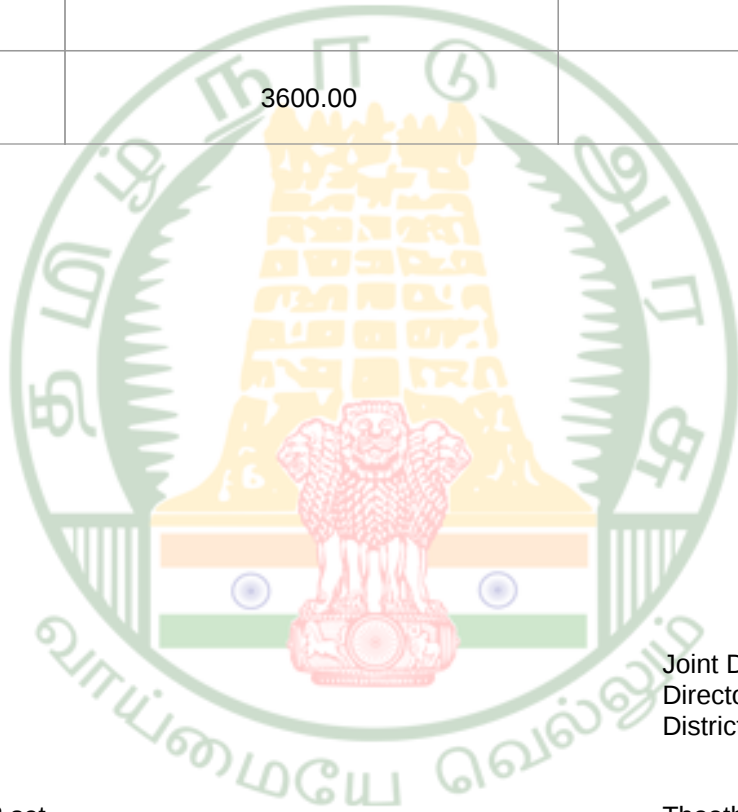
