TANGEDCO on 21.12.2022 Hence, this residential layout has been approved with below conditions.

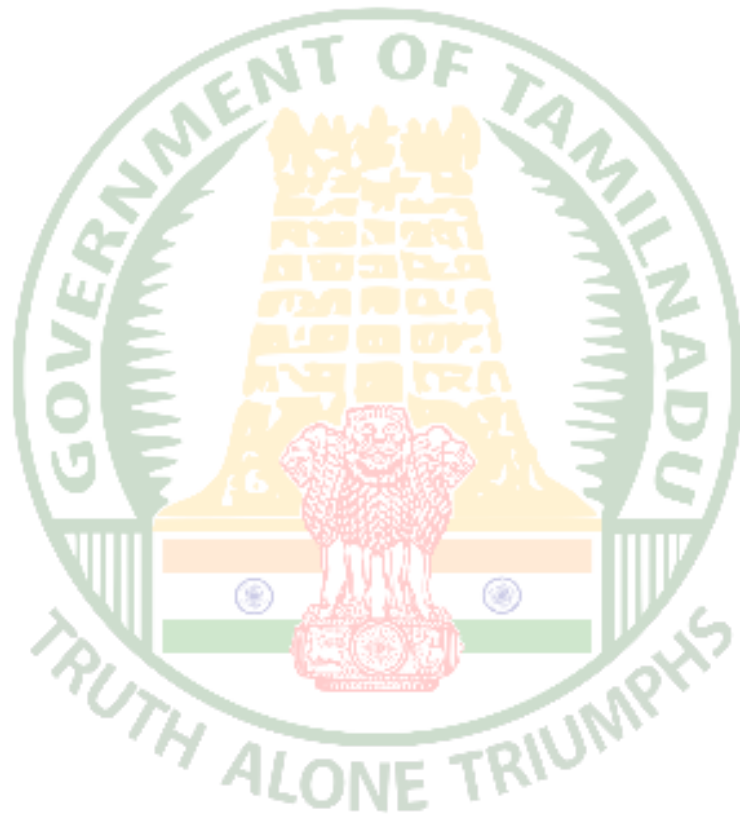

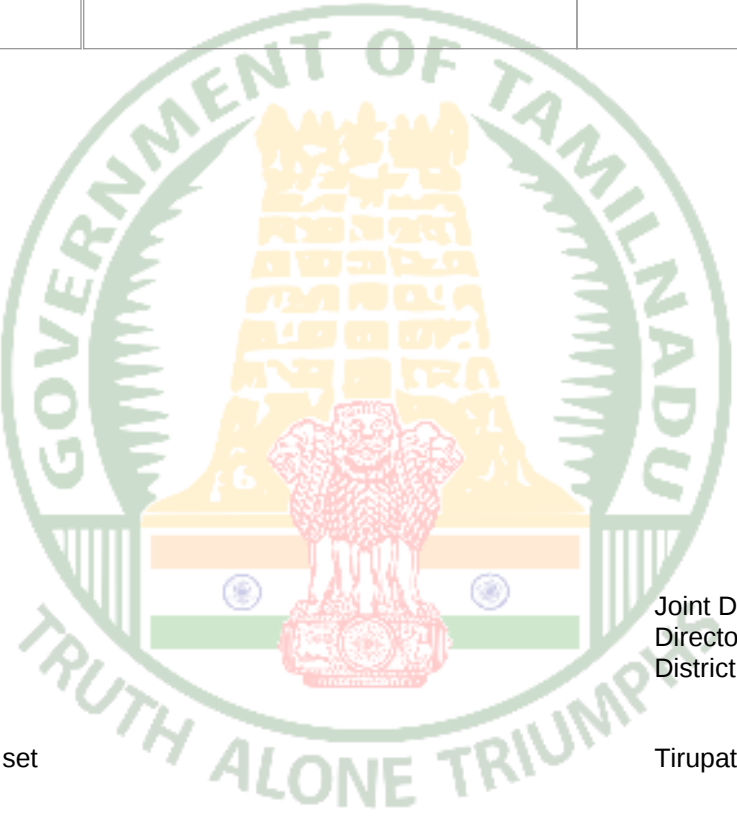
