ORDER:-

The application was processed as per the prevailing rules and after perusing the records and after conducting site inspection, the

applicant was directed to handover the portion of land earmarked for roads and public purposes meant for local body and TANGEDCO vide

reference 2nd cited above.

On receipt of gift deed vide reference 5th cited above, the applicants, Thiru.Rupesh Kumar and two others, have executed a gift deed through

which the Park, Road, Road Splay, Public Purpose, and TANGEDCO Purpose areas have been handed over to The Panchayat President,

Adukkamparai Panchayat, by Gift Deed Document No. 2596/2025, dated 23.10.2025 and on receipt of payment of charges such as Scrutiny fee,

Centage charge, Display board Deposit, Armed Forces Flag Day Fund, Sub Division Charges and Development Charges vide reference 18th

cited above, the Technical Approval is issued to the mentioned layout subject to the following conditions:

1. The Technical Approval is issued to the above mentioned layout and the number is assigned as L.P. / D.T.C.P. (VLPA) No. 27/2025 & P.P.No.

27/2025.

2. The local authority shall accord permission duly following the rules /regulations/Orders issued from time to time under the respective Acts.

3. The local authority shall accord permission/approval after collecting requisite fees/charges as applicable and the copy of the approval issued

shall be forwarded to this office for record.

4. Also, the local authority shall forward the copy of such permission/approval to the office of the Sub registrar of Registration department and

the office of the Assistant Director of Survey and land records concerned for information and for making mutation in their records.

5. Also, the local authority shall forward the copy of such permission/approval to the Tahsildhar concerned with a direction to the applicant to

pay the requisite charges for making mutation in the TamilNilam/Collabland website.

6. As per Tamil Nadu Combined Development Building Rules – 2019 Rule No.68 (2). – In granting of building permit for any development the

Executive Authority may wherever it is appropriate, make adequate provision for the preservation or planting of trees, as may be specified.

On all streets exceeding 7.2 meters in width, shade trees shall be planted not more than 9.00 meters in succession and within 1.00 meters

of the road boundary and the Land Owner developer should plant a tree for every 600 Sq.ft of the plot area which be monitored by the

concern Local Body.

SPECIAL CONDITIONS:

1. This office has not legally certified the title to the ownership by granting the technical clearance and planning permission. Only the

entitlement to develop the land by the applicant is verified through the documents uploaded in the web portal. Any person wishing to

purchase the property must individually ascertain the ownership of the property of the developer/seller. If any dispute arises towards the

ownership, the same shall be settled through the appropriate forum. This office is not the appropriate authority to decide on this.

2. The owners / developers shall be allowed either to carry out Infrastructure development works as per the standards specified by the local

body concerned or to pay the estimate cost to the local body. Concerned local body shall prescribe the standards for the provisions of basic

infrastructure like roads, drains, water supply etc. for the layout, as per existing rules. Before taking over the infrastructure developed by the

owners / developers, the local bodies shall ensure the quality of the works done by the owners/ developers.

3. The local authority shall also ensure that the sub division for the land earmarked for road and land meant for public purposes such as Local

body and TANGEDCO are properly carried out and transferred in favour of the local body/TANGEDCO concerned before issuing the final

approval.

4. As envisaged under the "Tamil Nadu Real Estate (Regulation & Development) Act 2016, the promoter has to advertise, market, book, sell or

offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part

of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has to comply the said provisions.

5. If the layout is located in an area other than planning area, the local authority shall also collect the Scrutiny fee Rs-1000/- per plot and 3% of market value of land as land use conversion charges before issuing the final approval as envisaged in Government Order under the reference 7th cited above. The payment of charges shall be made under the following head of account.

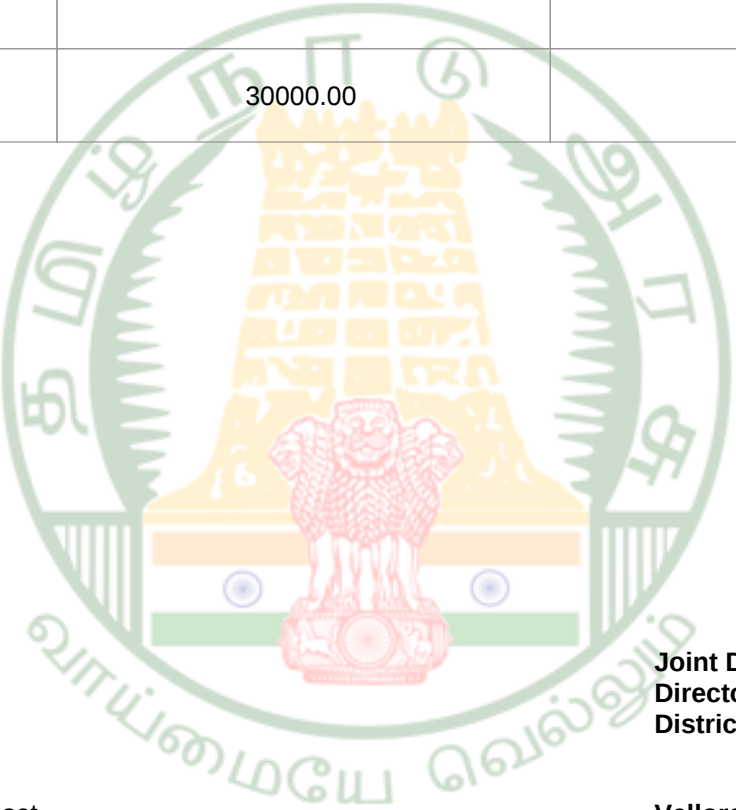
