On all streets exceeding 7.2 meters in width, shade trees shall be planted not more than 9.00 meters in succession and within 1.00 meters of the road boundary and the Land Owner

developer should plant a tree for every 600 Sq.ft of the plot area which be monitored by the concern Local Body.

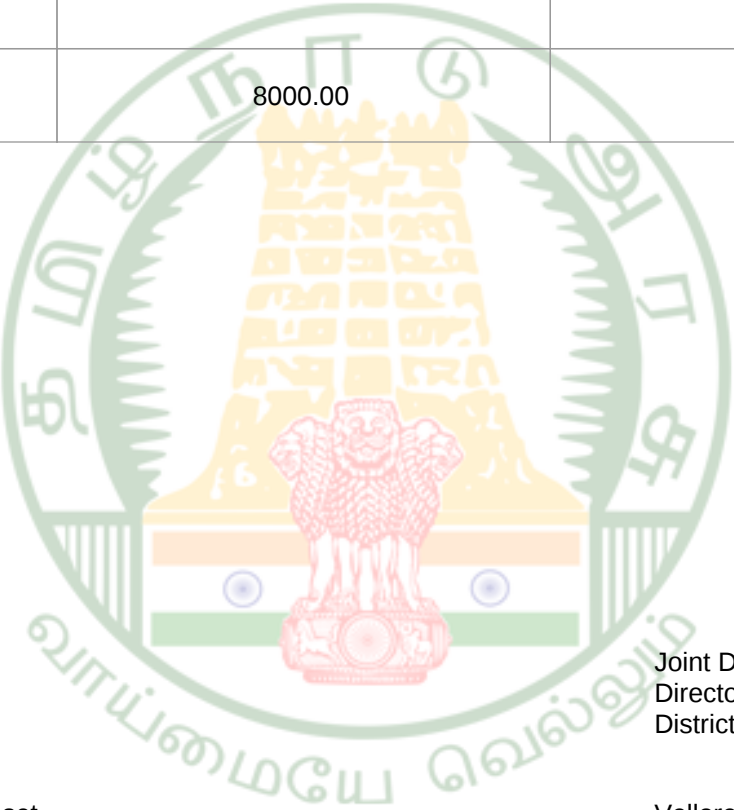
